THORSTEN SELLIN* AND J. P. SHALLOO†

Several years ago, the Bureau of Social Hygiene, Inc., of New York City, began the publication of an annual survey of current criminological studies in the United States, which it continued to issue until it disbanded in 1934, previously making provision, however, for the publication of the 1935 issue. The 1934 Bulletin was compiled and edited by Leonard V. Harrison, at that time Director of the Bureau; the 1931-1933, and the 1935 and 1936 Bulletins—Nos. I-III, V, VI—were compiled by Thorsten Sellin. The continuance of the Bulletin is made possible by the aid of the officers of the American Institute of Criminal Law and Criminology and the Editor of its Journal.

The term "research," strictly interpreted, may not be applicable to all studies listed. The selection, at least, has not been so stringent as to exclude any project with merit. The list is not complete, for some projects have undoubtedly not been brought to the compilers' attention.¹

The projects have been grouped into eight sections or sub-sections in order to facilitate the use of the list:

I. *General.*

- II. *Criminal Statistics* (Studies concerning organization and function of statistical agencies; crime statistics in local areas; statistical analysis of the operation of administrative agencies).

¹ Follow-up reports on a project are made in these Bulletins even after it has been designated as "completed" until the results have been published (in which case the place of publication, publisher, etc., are indicated), the manuscript report deposited somewhere (in which case the place of deposit is given), or mimeographed (in which case copies may presumably be secured from the author or sponsor). In a few instances projects reported as uncompleted in previous Bulletins have been dropped because no information regarding their status has been forthcoming for the last two years or because their withdrawal has for some reason been requested by the reporters.

Begun in December, 1936. Completion expected in December, 1937.
837. MACHOVER, SOLOMON (Psychiatric Clinic, Court of General Sessions, 32 Franklin St., N. Y. C.). *Factors Underlying the Associations of Felonious Accomplices*. Comparison of solitary offenders with gregarious offenders (co-arraignments) in a variety of psychological, psychiatric and sociological data. Resemblance study of associated accomplices, using same data as above. Begun in September, 1936. Completion expected in September, 1937.
838. MOLITCH, MATTHEW (New Jersey State Home for Boys, Jamesburg). *The School Adjustment of Children with Endocrine Dysfunctions*. Children with endocrine disorders are more serious school problems because of their lack of concentration and early physical exhaustion. They are also serious truants and their school work is much below their capabilities. Begun in September, 1932. Completed in December, 1936. To be published by *The Nation's Schools*.
839. ——— and ECCLES, A. K. *The Effect of Benzedrine Sulfate on Psychometric Results in Behavior Problems*. Benzedrine sulfate in varying doses is being given boys before and after psychometric tests. Control tests were made and a control group is

- being maintained on a placebo. This drug is supposed to make people more alert. Begun in March, 1937. Completion expected, September, 1937.
840. ——— and POLIAKOFF, SAMUEL. *The Effect of Benzedrine Sulfate on Behavior Problems*. A large group of boys is being given benzedrine sulfate in varying doses for various reasons. Its effect on the behavior of the boys is being noted as this drug has been reported as making individuals more alert and active. Begun in March, 1937. Completion expected, September, 1937.
841. ——— and ———. *The Treatment of Endocrine Dysfunctions (Hypopituitarisms) in Behavior Problems*. A group of hypopituitarisms is being treated by enteral and parenteral methods in order to determine their relative effects. Observations are also being made on the effect of glandular preparations on behavior and intelligence. Begun in February, 1937. Completion expected, September, 1937.
842. ——— and SULLIVAN, J. P. *The Effect of Benzedrine Sulfate on School Children Who Are Slow in Progress and in Physical Movements*. Benzedrine sulfate in varying doses is being given to a group of slow-acting children who are also doing poor school work. A control group in each class room is being maintained on a placebo. Begun in April, 1937. Completion expected, September, 1937.
843. ——— and ———. *The Effect of Benzedrine Sulfate on Stanford Achievement Results in Behavior Problems*. Benzedrine sulfate in varying doses is being given boys before taking the Stanford Achievement Test. Control tests were made and a control group is being maintained with a placebo. Begun in March 1937. Completed in May, 1937.
844. SCHAFER, MARVIN R., and others (College of Puget Sound). *Juvenile Delinquency*. Relation of juvenile delinquency to social factors, income, education, religion, mobility, divorce, etc. Begun in 1936. Completion expected in 1937. This is a WPA project.
