

The proposal recommended by the A&S Faculty last spring has been accepted by the President and The Board of Trustees. Therefore, 2005-2006 will be characterized by the implementation of the plan during the fall semester. I urge your participation, especially in the fall elections.

#### **FACULTY EVALUATIONS**

# **New A&S Faculty**



Joseph Audie: Joining the Department of Chemistry as an Instructor is Joseph Audie. Prof. Audie, a Ph.D. candidate in biophysics at SUNY Stony Brook, holds an M.S. degree in biomedical engineering

from the University of Connecticut and a B.S. in bioengineering from Hofstra University. He has published abstracts in scientific journals. His research interests are in bioinformatics and computer modeling of protein structure and function. He has been an adjunct here at Sacred Heart University for the past several years, and he will be teaching basic chemistry and biochemistry.

Mark Beekey: Joining the Department of Biology as a tenure-track Assistant Professor is Dr. Mark Beekey. Dr. Beekey earned his Ph.D. in Biological Sciences from the University of Delaware and a B.S. in Ecology from Juniata College. He has been a Post-Doctoral Associate at the Rubenstein School for the Environment and Natural Resources of the University of Vermont. His teaching experience includes the University of Pennsylvania, the University of Vermont, and the University of Delaware. He is the recipient of several grants and awards, including his being Co-P.I. for a large grant from the National Sea Grant Aquatic Nuisance Species Program. He has numerous publications and scientific abstracts to his credit, including publications in the Canadian Journal of Zoology and Freshwater Biology. His research interests include aquatic population/community ecology, life-history evolution, invertebrates, and invasive species.

Joel Block: Long-time Sacred Heart University adjunct Joel Block joins our Physics Program as a Visiting Assistant Professor. Dr. Block holds an Ed.D. degree from City University Los Angeles, a 6<sup>th</sup> year certificate from Wesleyan University, an M.S. from Southern Connecticut State University, and a B.S. from the Citadel, The Military College of South Carolina. He brings with him 41 years of teaching experience at SHU, the University of Connecticut, Wesleyan University, Southern Connecticut State University, Brien McMahon High School, and Benjamin Franklin Junior High School, both in Norwalk. Among his many recognitions is the Presidential Award for Excellence in Science Teaching from the National Academy of Science and the White House in 1984. He has twenty publications

in international, national, and state journals and served as co-editor of the <u>Connecticut Journal of Science Teaching</u>. He has led groups of students on geological field investigations in Italy, France, Switzerland, Bermuda, and the United States. Of special interest to Dr. Block is the study of religion and science. He will be teaching courses in astronomy and geology.

Charles Boyd: The Department of Biology welcomes Dr. Charles Boyd as a Visiting Assistant Professor of Cell/Molecular Biology. Dr. Boyd earned a Ph.D. in Biochemistry and Molecular Biology from the University of California, Los Angeles, and a B.A. from the University of California, Berkeley. He also completed a Postdoctoral fellowship in the Department of Cell Biology, Yale School of Medicine. He was a Teaching Assistant in Chemistry at UCLA. He has published four articles in scientific journals, including the Journal of Cell Biology and The Journal of Bacteriology, as well as several abstracts. His research interests focus on the molecular biology of flagellar biogenesis in the Gram-negative bacterium Caulobacter crescentus.

Rosemary Danaher: Prof. Rosemary Danaher joins the Department of Mathematics as an Instructor. She is currently completing her M.S. in Mathematics at Fairfield University. She holds an M.B.A from the University of New Haven and a B.S. in Mathematics from Fairfield University. Prof. Danaher left a 25-year career as a systems analyst and quality leader with General Electric to pursue her lifelong dream of a career in the teaching Mathematics. At GE, Prof. Danaher, as a certified Black Belt in Six Sigma quality, worked with senior management teams to identify opportunities for process improvements. She completed 25 Six Sigma projects yielding \$300K annual savings. Prof. Danaher served as an adjunct at SHU last fall.

Christopher DeSanctis: Prof. Christopher DeSanctis, after having served as an adjunct at Sacred Heart University, joins the Department of Government and Politics as an Instructor. Prof. DeSanctis holds an M.A. in Public Policy from Regent University in Virginia and a B.S. in Education from Grand Canyon University in Arizona. He has extensive expertise in practical politics, including his work as Policy and Communications Aid to the Mayor of Jersey City, and as campaign manager for a New Jersey gubernatorial race.

George Goss: Prof. George Goss joins the Department of Mathematics as an Instructor after having taught at SHU for many years as an adjunct. He holds an M.A. in Mathematics from Wesleyan University, an M.S. in Mathematics from Michigan State University in East Lansing, and a B.S. in Mathematics from Southern

Connecticut University. He owns and operates Audio Video Lab, Inc., servicing home theater, home and industrial laser disc players, DVD, and plasma monitors. In addition to having taught Mathematics here at SHU, he has served as instructor in computer electronics at Porter and Chester Institute in Stratford. Last year he was elected by the A&S Council of Chairs as the adjunct representative to the Council of the University Academic Assembly.

Armen Kaladjian: Dr. Armen Kaladjian becomes a member of the Department of Sociology, Social Work, and Criminal Justice as a Visiting Assistant Professor of Sociology. Dr. Kaladjian holds a Ph.D. from the Graduate School of Social Service, Fordham University, a M.S.W. from New York University, an M.A. in Sociology from New School University, and a B.A. in Sociology from Queens College, CUNY. He has taught as an adjunct at Sacred Heart University, St. Basil College, and Fordham His research areas of interest include University. professionalism and meaningful implications behind being in a profession as well as worker burnout. He participated in a project for the Bureau of Motor Equipment in NYC which led to the company's receiving a Harvard, Kennedy School of Government Innovations Award. He has served as managing editor of the Journal of Children and Poverty.

Patrick Morris, Jr.: Joining the Department of Sociology, Social Work, and Criminal Justice as an Instructor of Criminal Justice is Prof. Patrick Morris, Jr. Prof. Morris is currently a doctoral candidate at The City University of New York Graduate Center, John Jay College of Criminal He holds an M.P.A. (Master of Public Justice. Administration) from the University of New Haven and a B.S. in Criminal Justice from the University of Delaware. His area of research interest is the law enforcement response to domestic violence. After 26 years of service as a law enforcement officer in the city of Norwalk, with supervisory responsibilities in divisions such as detective, juvenile, narcotics, community services, and community policing, Prof. Morris took a position at Norwalk Community College as the coordinator of the Public Safety Academy. He is a certified police instructor and has taught both at John Jay College of Criminal Justice and at Norwalk Community College.

Nina Tarner: Dr. Nina Tarner joins the Department of Psychology as a tenure-track Assistant Professor. Dr. Tarner holds a Ph.D. in Psychology from Kansas State University and both an M.S. and a B.A. in Psychology from Shippensburg University of Pennsylvania. Most recently she was a Post-Doctoral Fellow at the University of Maryland, Baltimore County. She has served as an adjunct at the University of Maryland, Baltimore County, Towson State University, Central Penn College,

Shippensburg University of Pennsylvania, as well as others. She was Visiting Assistant Professor at Gettysburg College in Pennsylvania. She has made presentations at international and regional conferences, has published in Learning and Motivation, and is recipient of several research grants. Her areas of research interest include the ingestive behaviors in rats and conditioned flavor preferences. She has had considerable experience in supervising undergraduate and graduate research students.

Mary Treschitta: Prof. Mary Treschitta joins the Department of Art and Design as an Instructor of graphic design. She holds a dual Masters Degree in Art and Teaching from the University of New Hampshire and a B.A. in Studio Art from St. Michael's College in Vermont. Her teaching experience includes serving as adjunct at Gibbs College. She has been President of Visual Connection, a graphic design studio that creates promotional/marketing and presentation materials for such clients as Merck Pharmaceuticals and Dermal Science. She served as design director for <a href="The Minuteman Newspaper">The Minuteman Newspaper</a> and art director for <a href="American Iron Magazine">American Iron Magazine</a> and for Grafiko, a design studio in Stamford.

## Changes In Status:

**John Michniewicz:** Dr. John Michniewicz moves from the position

of Visiting Assistant Professor to tenure-track Assistant Professor of Music and Director of the Academic Music Program. As you may recall, Dr. Michniewicz holds a Doctor of Musical Arts from Manhattan School of Music, a Master of Music in Church Music from the same institution, and a Bachelor of Music from Cornerstone University in Michigan. A commissioned composer, John's contemporary styled music is published by the Chorister's Guild of Dallas, Texas. An accomplished solo organist, John has performed both in Europe and America, and has given recitals, for example, both in Vienna and on the great organ at St. Patrick's Cathedral in NYC.

Barbara Pierce: Dr. Barbara Pierce moves from the position of Visiting Assistant Professor to tenure-track Assistant Professor in the Department of Biology. She earned a Ph.D. in Ecology from the Department of Natural Resources, University of Rhode Island, an M.A. in Ecology from Central Connecticut State University, and a B.S. in Biology and Evolutionary Ecology from Eastern Connecticut State University. She completed a postdoctoral appointment at the University of Rhode Island. She is recipient of several grants and fellowships, is author of a variety of conference presentations, and has some

publication to her credit. Her areas of specialization are the behavior, physiology, and ecology of individuals and how these determine population patterns of resource use.

Matthew Semel: Prof. Matthew Semel moves from the position of Instructor of Criminal Justice to tenure-track Assistant Professor of Criminal Justice. He is currently completing his Ph.D. in Criminal Justice at the City University of New York. He holds a J.D. degree from New York Law School, an M.S. in Journalism from Northwestern University, and a B.A. in English from Colgate University. He is a member of the Bar for the Eastern and Southern Districts of New York, the United States Supreme Court, Federal District Court in New Jersey, and the New York and New Jersey Bars. He has been Of Counsel to the Civil Rights Law Clinic at Touro Law School and Senior Staff Attorney for the Legal Aid Society in the Bronx.
