An Old Concept

Early 1700s

1st known form of Distance Education: Prospective clergymen obtain training through mail correspondence (Albrektson, 1995)

1858 University of London offers Distance Learning degrees

(http://museumofdistanceeducation.com)

- 1873 Society to Encourage Studies at Home (Robey, 2010)
- 1921 Latter Day Saints' University issues the first educational radio license (Robey, 2010)
- 1958 Survey examined validity of national organizations claiming to provide *training* in psychotherapy via correspondence courses
 - Catalyst for what would eventually be known as
 diploma mills (Brophy & Durfee, 1960)

Technology Develops

1976 Journal of Computers and Education

(Baepler, 2010)

1983 Reconsidering Research on
Learning from Media (Clark, 1983)
Results yielded: No significant difference

1996 University of British Columbia: first successful virtual learning environment, "WebCT" (Clark, 1983)



Today...

69% of Academic Leaders

report that online learning is critical to their long-term plans

6.7 million students

are taking at least 1 online class (or 32% of all students)

77% of 4-year colleges offer online classes

Admissions Standards

- Generally speaking, they're lower.
 - Capella: 2.7 GPA or higher, no GREs, no interview
 - Regent: 2.7 GPA or higher, no GREs, no interview
 - Walden: Bachelor's degree

Classes

- All classes are conducted online
- Contact with other students/faculty is limited
- Courses are primarily graded online discussions and papers
- Unofficial honor system
- Residency requirements

Our Initial Findings

- Convenient, convenient, convenient
 - But feeling a bit disconnected from others
 - Yet still able to find ways to connect with classmates
- Forced creativity & mastery of new tasks
 - Heightened sense of self-efficacy
- Satisfied with the knowledge gained
 - Disappointed by the skepticism
