It has been my pleasure to again serve you as the NJIT University Librarian in AY2014, my 19th year at NJIT.

The substantial improvement completed this year was the expansion and the renovation of the Barbara & Leonard Littman Architecture and Design Library. The library was opened in 1998 for the School of Architecture and since then has added the School of Art and Design. In addition to the new academic programs, increases in enrollment, and development of new technologies called for expansion, renovation, and refurbishing of existing space. Barbara Littman, a former College of Architecture & Design (CoAD) graduate generously came to the rescue and with Maya Gervits did a fine job of leading the project. They also passed their ten year NAAB (architecture) and CIDA (interior design) accreditation. The library was mentioned as a "gem" and we agree wholeheartedly. Susan O'Connor, Architecture Library Specialist resigned and will be greatly missed. We are interviewing candidates to fill the position.

Another big improvement was the completion of EDS (EBSCO Discovery Service) implementation. EDS enables students and faculty to search across articles, books, e-books, databases, journals resources through a single search box from the library webpage. EDS searching had the immediate effect

of greatly increasing access and usage of journal articles in many of the library databases. This was implemented under the leadership of Haymwantee Singh and Ann Hoang without additional costs to the library. Technical reference librarian, Joe Mercuri promoted EDS with "Search for a Cookie" exhibit at the reference area which was well received by the students.

The Van Houten Library hours were extended during finals for the second consecutive year to 8:45pm on Saturday and 11:45pm on Sunday during finals weeks in response to student requests.

The Provost and senior administration gave the library sufficient additional funds to cover the journal and book price increases in AY2014 and we are very grateful.

Hard copy book circulation continued to decline, down 59% from AY2010, while attendance and usage of the library continued to increase. Usage of digital resources increased dramatically. For example, the usage of Elsevier, our largest single database increased over 17% in just one year.

Information literacy continues to be a strong emphasis among the reference librarians who teach in collaboration with faculty within their liaison departments. Congratulations to Davida Scharf for receiving the annual research



award given by the Research Committee of the NJLA (New Jersey Library Association) College & University Section & ACRL (Association of Colleges and Research Libraries) New Jersey chapter.

Committee was changed to
CITLAR (Committee on
Information Technology, Libraries
and Resources) in AY2014. Dave
Ullman, CIO, and I are co-chairs
of CITLAR. Effective AY2015,
the committee will report to the
new Faculty Senate, which will
select the faculty members.

This past year we mourn the passing of a former Director of Libraries, Morton Snowhite, and Library Assistant, Madalyn Paganetti, both were long time NJIT library employees.

E-book Purchases

During FY2014, the average cost per e-book was \$90.43 compared to \$87 in the previous year. The total budget spent on the patron driven acquisition program was \$21,236.

If we had to purchase all of the e-books accessed during the year we would have had to spend approximately \$137,000 of the library's materials budget.

The process and methodology of patron-driven acquisition (PDA) concept of a library patron and librarian partnership working toward collection development continues to drive selection of material accessed and purchased. PDA continues to be a valuable tool that augments the library's collection development strategy, including materials tailored to course curriculums and the anticipated demand by library patrons.





Print Book Purchases

The book expenditures chart compares the total number of books purchased from FY2010 to FY2014. In FY2014 the average cost per book was \$115 compared to \$95 in FY2013. The staff continues to find innovative techniques (e.g. PDA program with e-books) to provide resources in support of the research and teaching needs of NJIT faculty and students as the print book budget continued to decline.

Reference Services

Due to increasing enrollments and our embedded librarianship model, interactions with students and faculty are vibrant through online chat, email, and information literacy instruction face-to-face and via Moodle.

Under Bruce Slutsky's leadership, the Reference Department sponsored two opportunities for students to learn more about SciFinder Scholar through workshops conducted by Chemical Abstracts on campus. Charlie Terng engaged the Graduate Student Association and the PhD

Club in promoting a wellattended workshop on Endnote for graduate students and faculty. Joe Mercuri ran a "Search for a Cookie" day to inform students about the features of the new EBSCO Discovery Service which searches article and books databases from one search box.

Liaison librarians continued to provide detailed cited reference reports to the Promotion and Tenure committee on candidates as well as for the many applicants for vacant administrative positions. Joe Mercuri worked extensively with the Computer Science Department to establish a list of top journals in several subfields. Davida Scharf also represented the library on two of the university-wide strategic planning committees where she advocated for a unified University Learning Center that would combine the library, CAPE and the Writing Center in one location. The report she prepared also compared the library resources and staffing of NJIT to its peers. She took the opportunity to reiterate the three critical areas supported by the

library-- space -- a physical place to study alone and in groups, information resources / software and systems -- content and access systems for research and teaching faculty and students, and instruction -- teaching librarians support instruction in one of the core competencies, information literacy. Although these services are no longer as tightly integrated with one another as they once were, they are all still vital to the academic and research goals of the institution. Davida Scharf also represented the library on the Undergraduate Curriculum Committee.

Information Literacy & Research Roadmaps


The reference librarians continue to make information literacy instruction a priority. For the first time, all the Reference Librarians shouldered equally the tasks associated with the Research Roadmaps program, embedded as 10% of the course grade in about 50 sections per semester of HUM101 and HUM102. The librarians' training room, lab CAB1050, was improved by the addition of

tables and chairs to accommodate students with laptops in classes with enrollments larger than 14 (the number of installed computers' in the room). This and upgraded Wi-Fi in the library helped streamline the administration of the Research Roadmaps. In the Roadmaps exit survey, about 70% of the students continue to find the Roadmaps useful. Plans have begun for the coming year

to address the needs of the honors students who would benefit from a more advanced Roadmaps program.

Library Self Help Answer Service

The library's self-help answer service for frequently asked questions is a natural language, web-based self-service software system that automatically answers questions concerning library services, accessible from the library homepage. During

the year, the total number of questions asked was 6,147 with a response rate of 93.24%. The average number of questions asked per day was 17. The most

common question asked was "How do I find out if there is full text of a known article in a specific journal?"

ResearchGuides are course specific webpages created by the librarians in support of the information literacy program and course curriculum at NJIT. In FY2014 there were a total of 44,516 views compared to 42,648 views in FY2013 with September having the most views at 11,738 within a month.

VALE Open Library System Investigation

NJIT library continues participation in the VALE's VALID project. VALE believes that a shared open-source integrated library management system (LMS) is the ideal infrastructure to promote and support its goals of enhanced resource sharing and other transformative collaborations. VALID will allow VALE to leverage the use of a shared LMS to extend the role of NJ academic libraries by decreasing duplicative efforts, reducing information and service silos, engaging in enterprise-level collaborations, and diminishing

dependence on proprietary systems. The tasks accomplished by the VALID standing committees in FY2014 are:

The VALID Steering Committee (VOSC) continued to work on the VALID project document for the organization and operation of the VALID system. The document addresses four key service areas: (1) organizational structure, (2) operations, (3), finance, and (4) legal issues. VALE will seek consultants with appropriate expertise to address each section.

The VALID Implementation Committee (VOIT) focused primarily on the creation of the composite VALID database. This database is comprised of the alpha libraries' bibliographic records, reassembled into a VALID composite record. The new records retain each library's unique information. The end product was demonstrated at the VALE Users Conference in January 2014.


Circulation Services

Extended weekend hours continued for the fall and spring semesters during FY2014. Total attendance at the Van Houten Library was 393,680, an increase of 3,596 over attendance last year at 390,084.

Recent trends suggest that students appreciate open, bright surroundings for study - windows to let in natural light and the ability to move tables and chairs to suit study preferences. This year we adapted our existing shelving space to create more open study area. On the main level of the

Van Houten Library, we removed old book stacks, and placed small movable tables and chairs in that area. This bright and open space is a place where students can gather either for group or individual study. This trend toward collaborative space is also reflected in the usage of group study rooms.

Each year the number of requests for use of the group study rooms has increased. The chart shows the increase in group study room requests by 4% in FY2014 compared to FY2013.



Rapid Interlibrary Loan

The RapidILL (Interlibrary Loan) system continues to provide quick delivery of journal articles that are not available in the NJIT collection. The RapidILL system year end summary for NJIT Library stated: "In fiscal year 2013/2014, NJIT sent 984 article requests into the RapidILL system. Of those 984 requests, 925 were filled in Rapid resulting in a filled percentage of 96%. In addition, (the NJIT)

community received their material via RapidILL in an average of 16.4 hours."

In order to keep the ILL system functioning efficiently, the library is in the process of implementing ILLiad Resource Sharing Management software, which will "save time by managing all of our library's borrowing, lending, and document delivery through a single, window-based interface."

With upgraded equipment and a new dedicated interlibrary loan Bookeye scanner, the library staff anticipates even more improvements in interlibrary loan delivery.


Once ILLiad is fully operational, library users will be able to track the status of their requests every step of the way, with additional customer friendly services to follow.

iPad Lending Program

NJIT students continue to find the iPad lending program useful and satisfactory. During FY2014 members of the NJIT community borrowed the iPad a total of 599 times, and used the iPads to access various library resources, webpages, social media sites and apps.

Electronic Theses & Dissertations (ETD)

There are 1,989 theses and dissertations available in electronic format as ETD's (Electronic Theses & Dissertations). From July 2013 to June 2014, 124 ETDs went live on the NJIT website. Researchers, students, and business people from around the world continue to discover our ETDs through Google and Yahoo searches and then obtain immediate access to full-text content through our NJIT ETD portal. Littman Architecture and Design Library

For students in architecture and design programs it is critical to have ready access to collections of materials samples as well as special accommodations for graphic collections. They need to have at their disposal digitization stations, audio/visual equipment and comfortable spaces for collaboration.

Several users' surveys conducted in the spring of 2013 helped to re-evaluate use of the library space and to provide Professor Littman, the designer of the renovated Littman Library, with critical information.

The renovation, which has become possible thanks to the generous support of the Littman family and the college administration, took place during the summer of 2013. During this process we not only increased the number of seats and shelving capacity but created "a library that functions as an integral part of the institution's total educational experience". A seminar/quiet reading room, a large space for collaborative study, quiet reading zones, and the much needed Materials Library that currently houses 22,600 materials samples were added during the reconstruction.

The renovation was finished in time for the Council of Interior Design Accreditation (CIDA) and the National Architecture Accreditation Board (NAAB) visits and the library successfully met all the requirements. In the NAAB post-visit report it was named "a case study in excellence, combining effective special organization with accessible resources supported by a knowledgeable and attentive library staff".

Collection Development and Outreach

The library has continued to acquire materials in a variety of formats. Over 800 titles have been added to the collection in the past year, 204 of them came as donations from faculty and friends of the library. The gift of \$2,000 presented in honor of Professor Papademetriou has permitted us to establish a special fund for rare book acquisition.

"Tea in the Library" events, during which patrons can review recent acquisitions, have helped to advertise library resources and to engage patrons in informal discussions. "Tea for PhD students", has helped to support their research activities. The library also hosted several exhibitions of students' creative work: "Wondrous Space" (selected works from Prof. Prantis' class), drawing and watercolors by students in the Siena program, plus architectural models, and posters designed by students in Art+Design.

In 2013-2014 the library web site has been visited more than 90,000 times. 186,901 web page

visits were made by 48,957 visitors, 60% of whom came from the United States and 40% from Canada, China, Germany, Netherlands and India.

Reference and Instruction

In FY2014, the library staff answered approximately 10,000 questions and offered twenty seven sessions for eleven different courses, serving students in all areas of CoAD programs. The library subscribed to Digital Tutors – a training library specializing in software for designers. A complete list of

She also presented a paper at the 2014 **IEEE Integrated STEM Education Conference** (ISEC). Princeton, NJ. March 8, 2014 entitled Instruction and Assessment of Information Literacy among STEM Majors. She gave a presentation at the NJEDge.Net 15th Annual Faculty Showcase: Best Practices, held at Brookdale Community College, Lincroft, NJ. March 28, 2014 entitled College Students as Wikipedia Editors: An Engaging

Assignment. Davida collaborated with other NJ librarians in providing feedback to Middle States and to ACRL on revisions of their documents pertaining to information literacy. She is currently the primary investigator for a new Project, The Cross-Institutional Assessment of Information Literacy, sponsored by the VALE Shared Information Literacy Committee and the NJ Section of the Association of College and Research Libraries.
