Please usepaper 8  $1/2 \times 11$ " DOUBLE-SPACED, on only one side of the page, without institutional letterhead.

The following copies are required:

- (3) A copy to President Erwin Surrency, Charles Klein Law Library, Temple University, 1715 Broad Street, Philadelphia, Pennsylvania, 19122.
- (4) A copy to Secretary Patricia B. Piper, University of California, Law Library, Davis, California, 95616.
- (5) A copy to your liaison officer, listed at 66 <u>Law Library Journal</u>, 378 (omit if duplicated (3) or (4).
- (6) A copy for your files.

The report to be printed in the <u>Law Library Journal</u> will be that submitted to Miss Russo, unless that report exceeds 300 words. If your report must exceed that word limit, submit an edited report to Mr. Connie E. Bolden, Editor of the <u>Law Library Journal</u>, so that he will not have to edit it for length himself.
