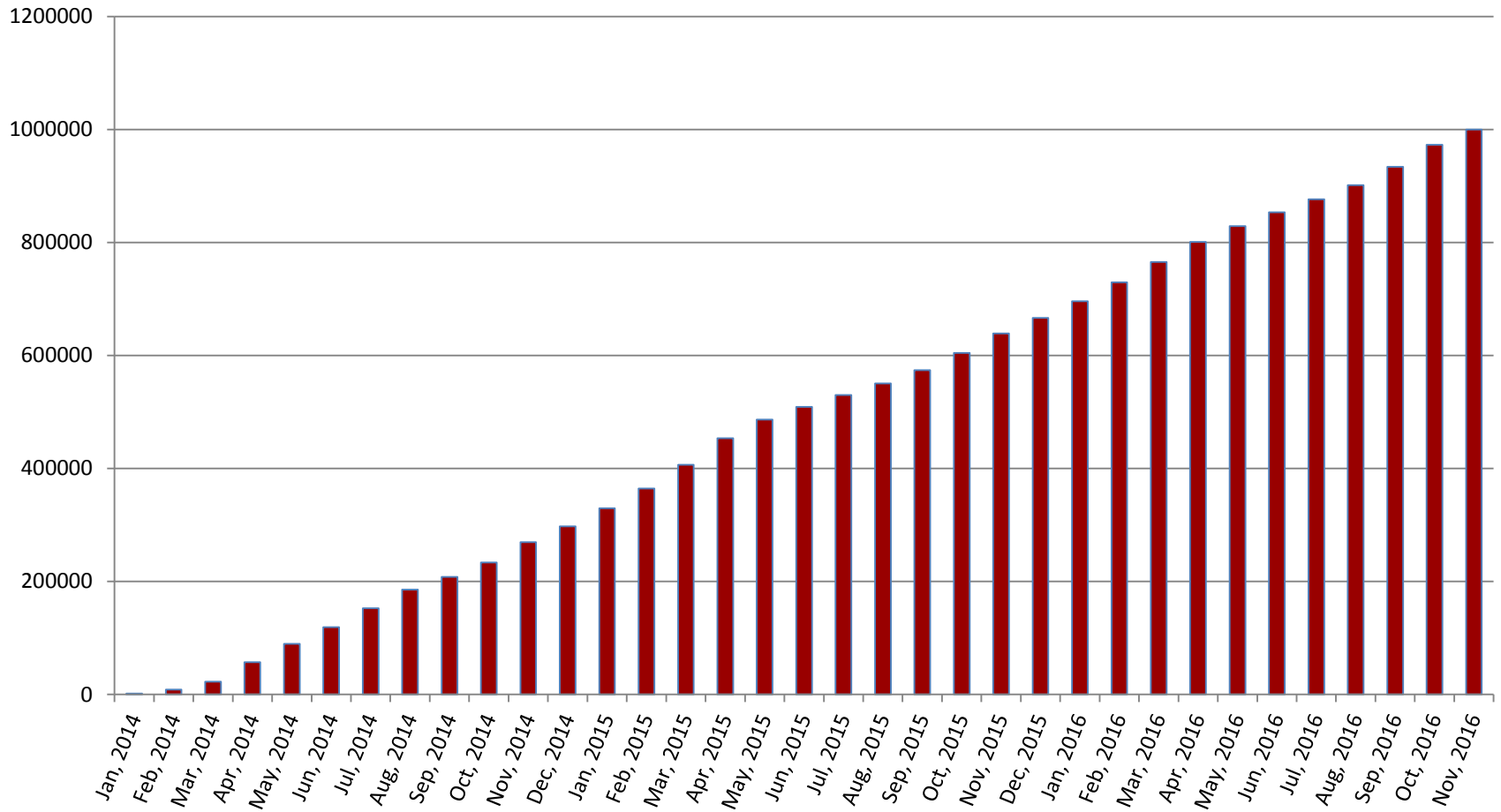

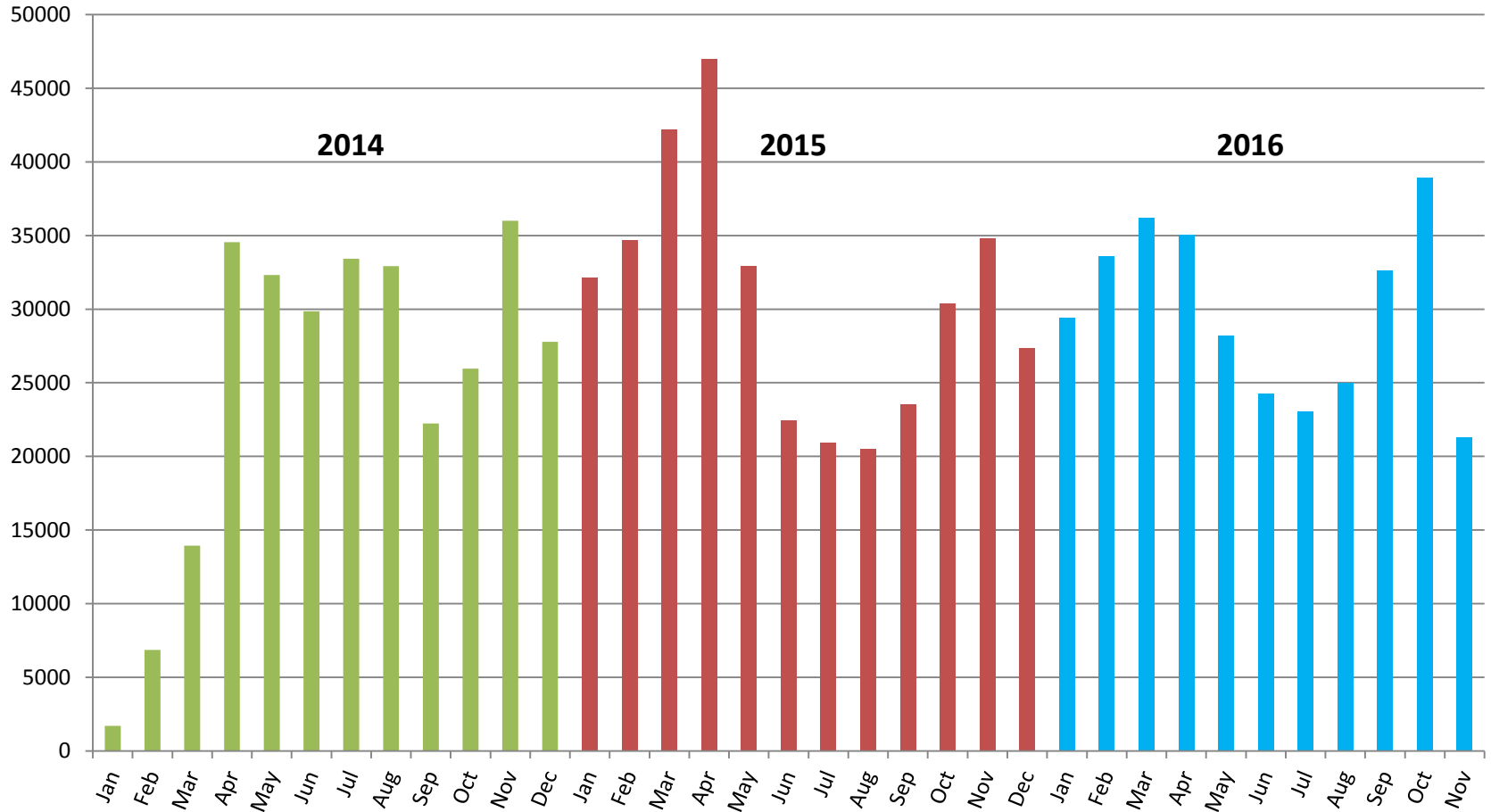

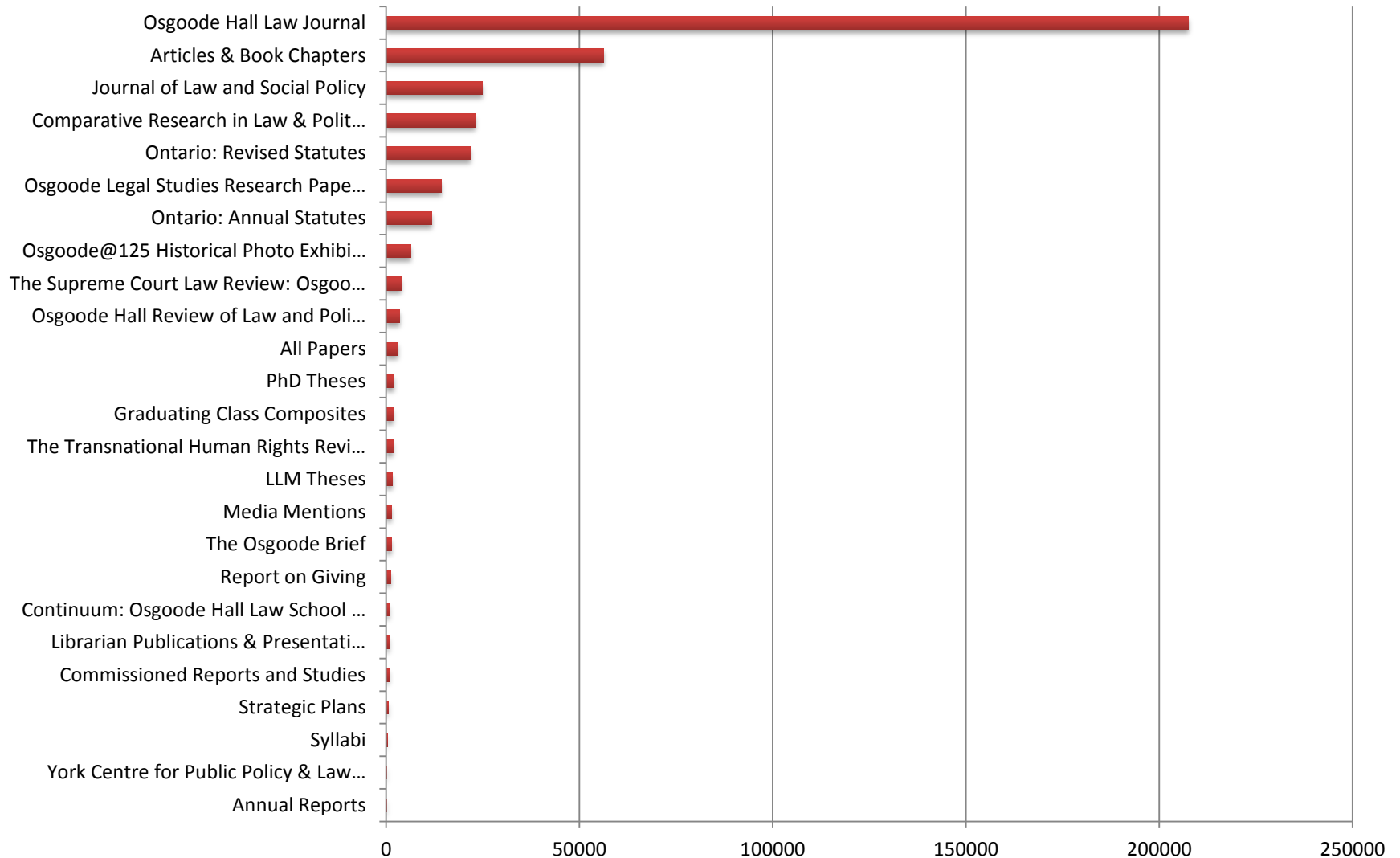
Cumulative Downloads, 2014-2016



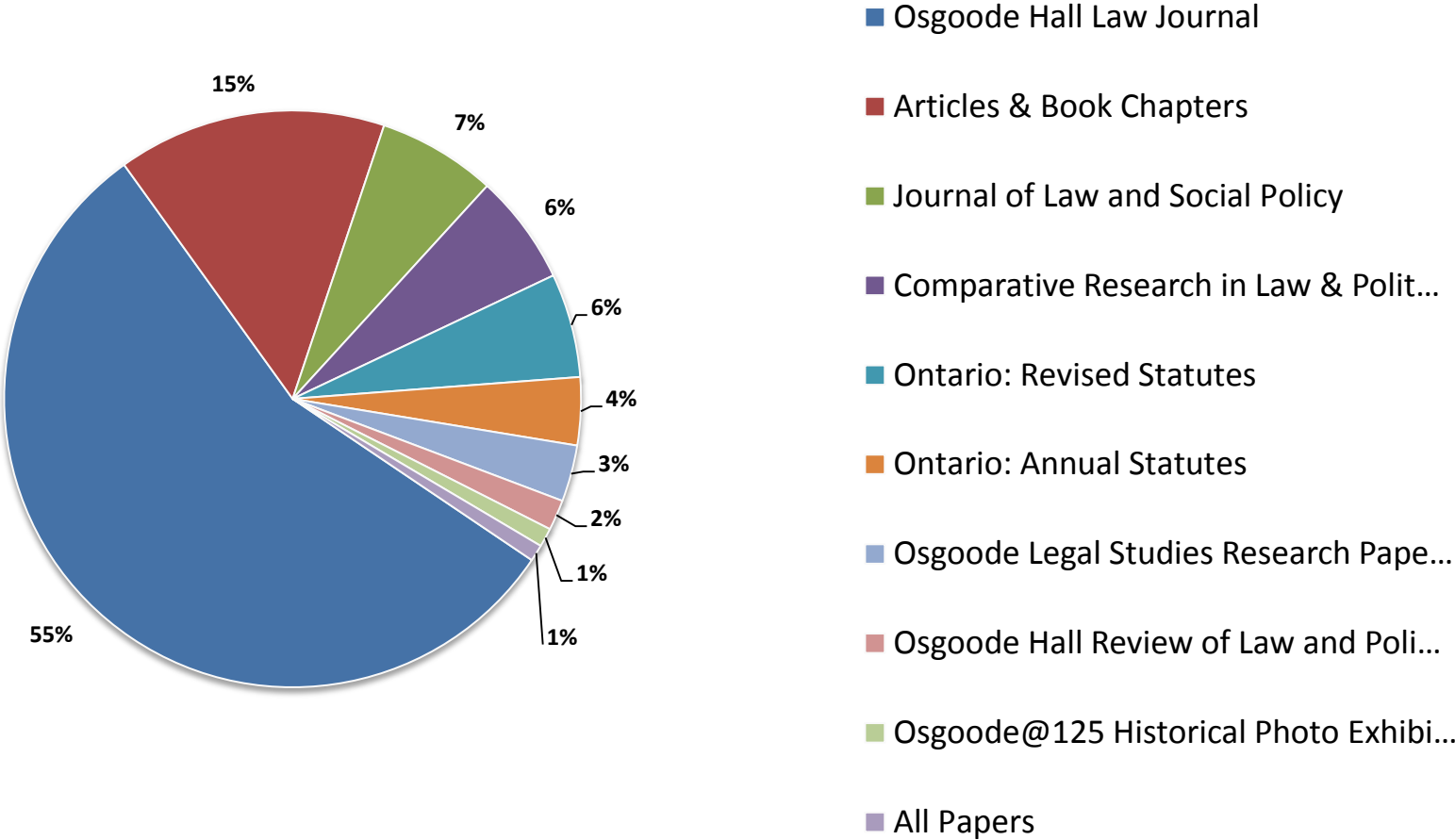
Downloads by Month, 2014-2016



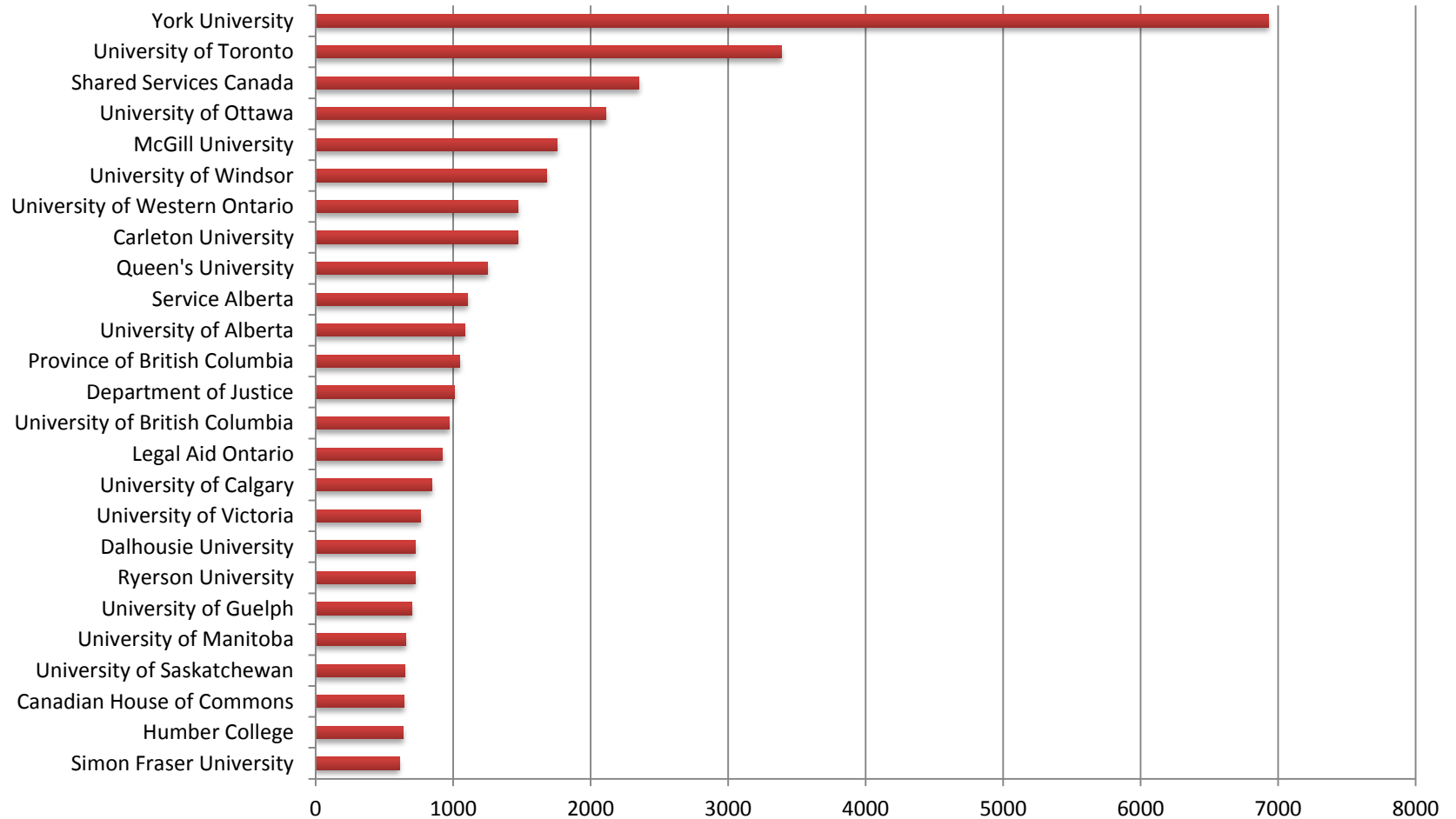
Top 25 DC Series: Past Year



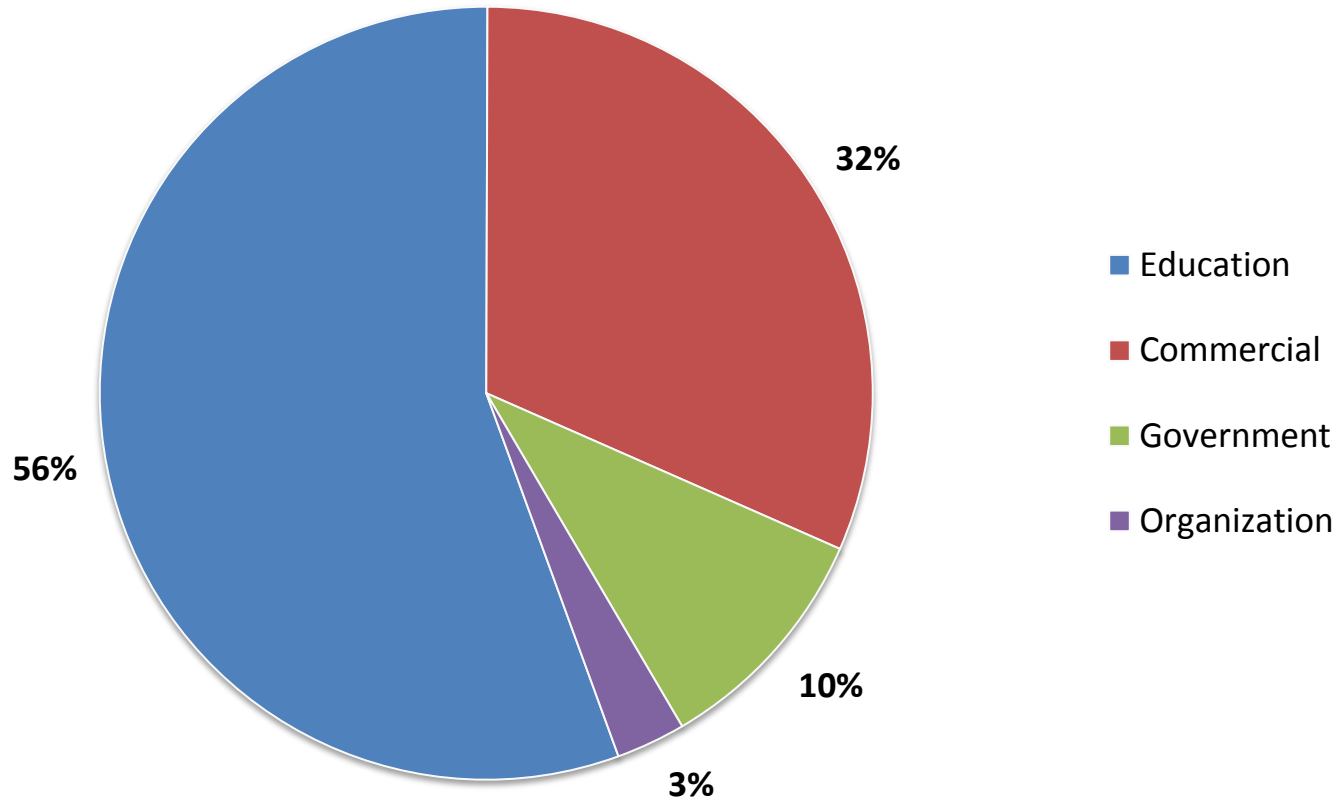
Top 10 DC Series (%): Past Year



Top 25 Institutions



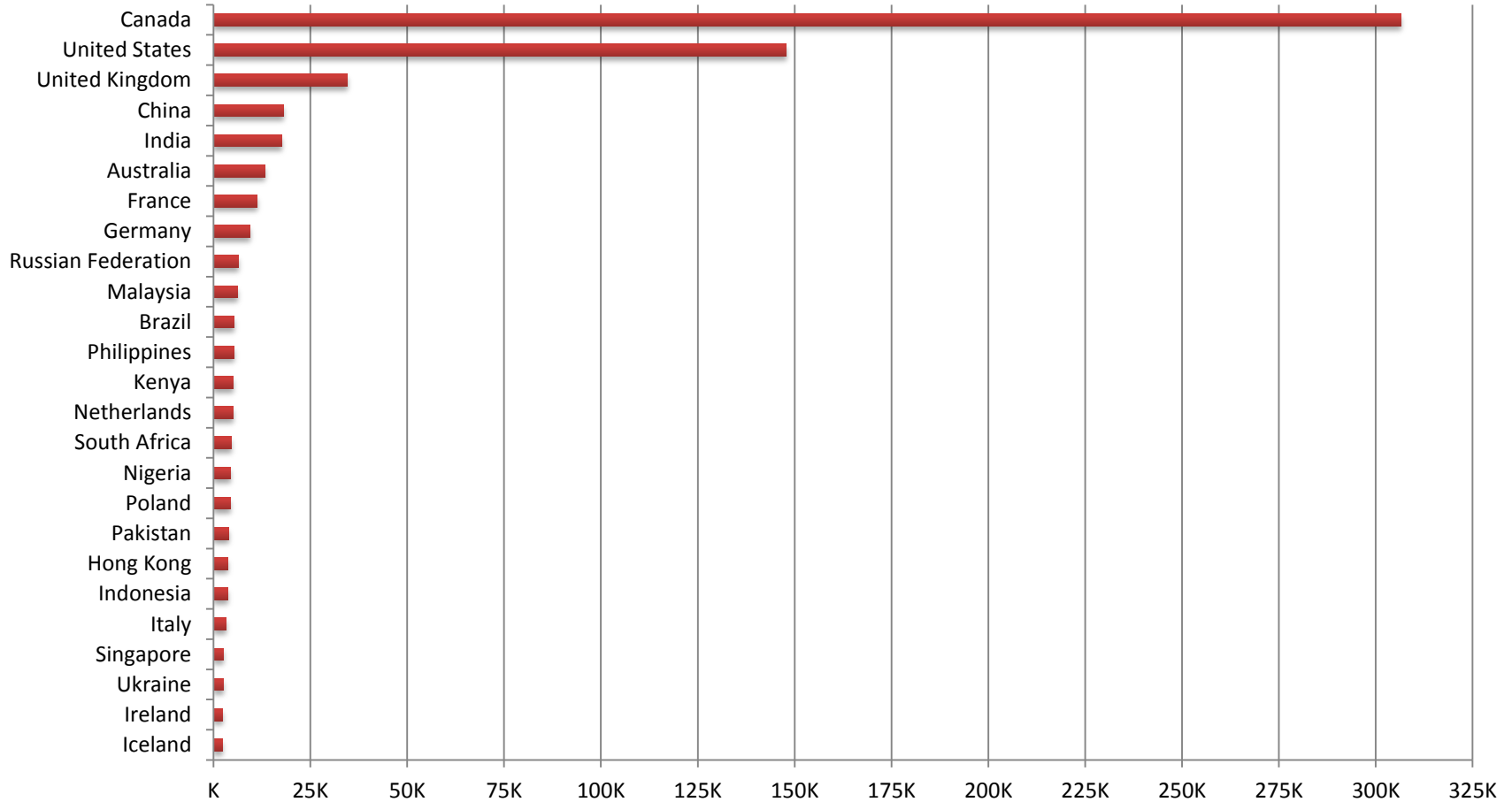
% by Type of Institution



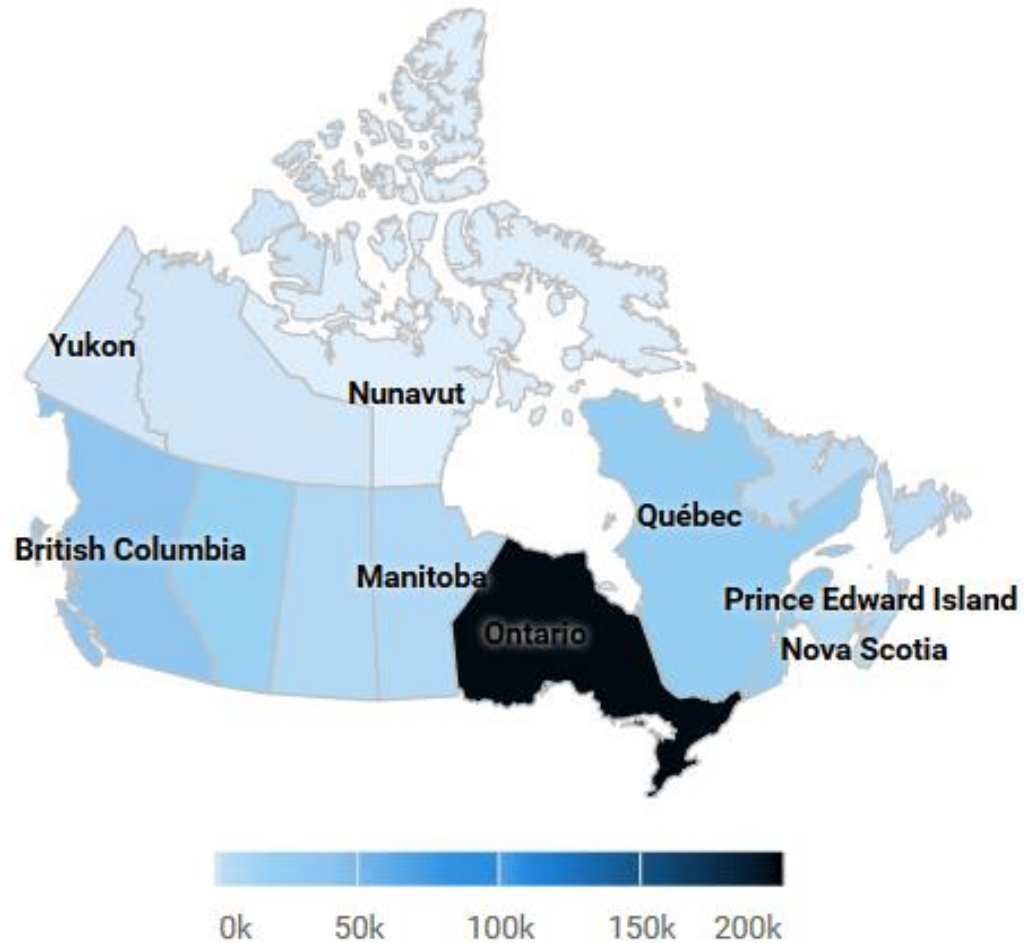
Distribution of Readership



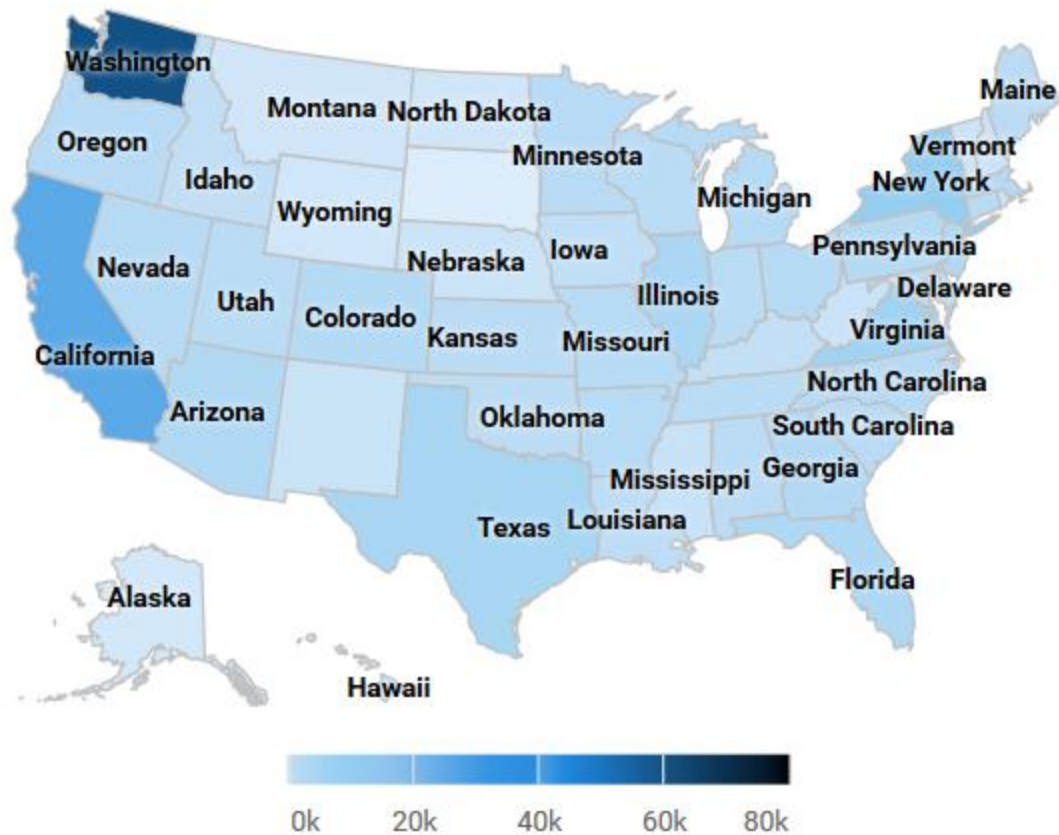
