

# Lilly gift helps fund top-notch faculty

ndiana Law is widely regarded as one of the better public law schools in the country, consistently ranking among the top 15 public law schools in the nation. But Dean Lauren Robel thinks IU can do even better.

"Our goal is to make the School not just good but great," said Robel, who became dean in 2003. "We want to be the kind of law school that gives students the best education in a public school setting. And that means looking at what the top schools are doing and seeing what steps we can take to get there."

Now, thanks to a \$25 million gift from the Lilly Endowment awarded this past December, Indiana Law is primed to take those steps. Sara Cobb, the Endowment's vice president for education, believes that "this transformative grant will significantly enhance the stature of the IU School of Law and place it in the company of our country's most elite law schools."

Robel agrees. "The Lilly grant couldn't have come at a better time," she said. "The heart of any law school is its faculty, and this grant is going to help us become more competitive in recruiting and retaining the best scholars."

Until recently, the School of Law found it difficult to attract top faculty. In the past four years, the School made 21 offers to promising scholars but had only four acceptances. Existing faculty were frequently offered higher salaries and research support by other schools. Indiana Law simply couldn't compete. But thanks to the "We want to be the kind of law school that gives students the best education in a public school setting. "It means we can really dream big and think about what the next generation of law schools should look like," Robel said. "What's really exciting is that now we can think about going after top scholars to develop new

# Baier honored as 2008 Budweiser conservationist of the year

**Lowell E. Baier**, LLB'64, attorney, architect-builder, and avid outdoorsman, was named the 2008 Budweiser Conservationist of the Year. Baier was selected in the annual program that recognizes individuals who have made exceptional contributions to the outdoors and conservation.

The Potomac, Md., resident has dedicated 37 years to wildlife conservation and is president of the Boone and Crockett Club, founded in 1887. Baier co-founded the National Capital Area Chapter of Safari Club International. He is Founding Charter Member No.14 of the Foundation for North American Wild Sheep, serving as an officer or board member for 15 years and national convention chairman from 1978 to 1981. He spearheaded the rescue and preservation of the National Collection of Head and Horns. For the last 25 years, he has played a key role in the renaissance of the B&C Club, a non-profit organization founded in 1887 by

Theodore Roosevelt to establish a coalition of dedicated conservationists and sportsmen who would provide the leadership needed to address the issues that affect hunting, wildlife, and wild habitat. Baier had a principal role in establishing a B&C post-graduate wildlife program at the University of Montana and in establishing the National Conservation Leadership Institute for mid-career government wildlife managers.

Baier was the lead in drafting former President George H. W. Bush's wildlife conservation agenda, a delegate to the White House Conference on Cooperative Conservation, and served on the U.S. Forest Service Centennial Steering Committee. In 2007, he also spearheaded preserving the birthplace of conservation in America, Theodore Roosevelt's historic 23,550-acre Elkhorn Ranch in North Dakota.

A \$50,000 grant from Budweiser and the National Fish and Wildlife Foundation will be made to Baier to support conservation efforts. In addition, the grant can be matched and the value of the award could reach as much as \$200,000.

# Gregg, JD'73, honored by Justice Department

**Larry Gregg**, JD'73, was honored Oct. 2 at the Justice Department's 55th Annual Awards Ceremony at Constitution Hall in Washington, D.C. Gregg was presented with the Mary C. Lawton Lifetime Service Award. The award is given only in exceptional circumstances to those individuals who have significantly contributed to the success of the Department by a record of outstanding actions and career accomplishments.

As a civil chief in the U.S. Attorney's Office for the Eastern District of Virginia and as an attorney in the Department's Civil and Criminal Division, Gregg played a significant role in the development of immunities and defenses that protect federal officials charged with law enforcement and national security responsibilities. # Edwards elected vice president of AABE's Indiana chapter



# Tinder confirmed to 7th circuit



In a 93-0 vote, the Senate confirmed U.S. District Court Judge **John D. Tinder**, JD'75, of Indianapolis to a seat on the U.S. Court of Appeals for the Seventh Circuit. The Court, based in Chicago, is the last stop before the U.S. Supreme Court for cases from Indiana, Illinois, and Wisconsin.

Tinder, who is the first jurist with Indiana roots appointed to the 7th Circuit in two decades, was supported in his nomination by Indiana senators Richard Lugar, a republican, and Evan Bayh, a democrat. And the American Bar Association gave Tinder the highest rating — "well qualified."

"Throughout John's career, his reputation for personal courtesy, fairness, decency, and integrity was equally well-earned and widespread among colleagues and opposing counsel alike and on both sides of the political aisle," Lugar said in an *Indianapolis Star* report.

The Senate's votes on Tinder's earlier promotions — to the district court seat and to U.S. attorney for Indiana's southern district in 1984 — also were unanimous. He has held the district court seat since 1987.

Prior to the U.S. attorney's job, the Indianapolis native was a public defender, state prosecutor, and private practice attorney in Indianapolis. He also has taught trial advocacy at Indiana Law.

He devotes significant time to global legal education programs in England and the former Yugoslavia tackling important legal and ethical issues. He has also hosted judges and lawyers from South Korea, Taiwan, China, Japan, Liberia, Russia, and other former Soviet Republics for meetings on similar topics.

programs and strengthen existing ones."

The School of Law is widely acknowledged as an innovator in several areas of scholarship, including the changing nature of the legal profession, democratic theory, and the law of cybersecurity. Robel said that the gift will enable the School to expand those areas of expertise and nurture collaborative efforts with the IU School of Public and Environmental Affairs and the Kelley School of Business.


Spurred by a Carnegie Foundation report criticizing American law schools for a lack of focus on professional identity and values, Robel and the faculty took steps to address that concern at IU.

"During the first year of law school, we ask students to pull back from their value systems and think about the intellectual side of law as objectively as they can," Robel said. "We intend to repair that and reinstate a discussion about values in the profession, but there's no systematic way of doing that. So, too often it just doesn't happen."

Last year, faculty created a new, groundbreaking first-year course focused on law as a profession. Taking a sociological approach, the course introduces students to the economic and ethical challenges of working in law and the tradeoffs involved in choosing corporate law, say, over working as a public defender.

"In a public law school, especially, you have lots of students who don't know a lot about the profession," Robel said. "So many students make career choices based on things like salary, which isn't always a good indicator of how a professional path will fit a given student. This course is designed to help students make better, more informed choices while giving them a better founding in professional values.

"We're thinking hard about how to make this place the best public law school it can possibly be. I think what attracted the Lilly investment is that we're focused on the big picture and always open to new ideas."

Prior to joining the firm, Winnett Denniston served as Administrative Law Judge for the Indiana Department of Workforce Development and worked for several years at First Indiana Bank, where she achieved the Office of Assistant Treasurer.

## Joseph B. Board Jr., JD'58

Board passed away on Oct. 12, 2007, after a lengthy battle with cancer.

Born in Princeton, Ind., Board received a bachelor's in government with highest honors from Indiana University in 1953. He went on to earn a BA and a master's degree in jurisprudence at Oxford as a Rhodes Scholar, a JD from the IU School of Law in 1958, and a PhD in government from Indiana University in 1962. In addition to being a Rhodes Scholar, Board's other honors include a Fulbright Fellowship, membership in Phi Beta Kappa, an honorary PhD from the University of Umea, and election to the Academy of Sciences at Lund.

Described as "quick, intelligent, and deeply involved in affairs of the day," Board was known both nationally and internationally as an outstanding teacher and scholar. Over the years, he held teaching positions at Union College, Indiana University, Elmira College, Cornell College, Albany Law School, the London School of Economics, the University of Umea, the University of Paris, and was a guest lecturer in numerous locations worldwide, including Oxford, London, Nottingham, Costa Rica, Copenhagen, Stockholm, Lund, and the University of California.

During his years at Indiana University, Board was actively involved in the Indiana University Student Foundation, Student Supreme Court, Student Government, Board of Aeons, Acacia fraternity, and Phi Beta Kappa. He was also a member of the Academy of Law Alumni Fellows, the highest honor the Law School bestows upon its graduates.

#### Rodney H. Grove, JD'63

Grove, of Evansville, Ind., passed away on Sept. 3, 2007.

He began his legal career working for Bamberger Forman Oswald & Hahn in 1963 and went on to become a partner at Denton Gerling & Grove from 1968 to 1971. He was a sole practitioner from 1972 until 1975. In 1989, Rodney and Dennis Brinkmeyer formed the law firm of Grove and Brinkmeyer. Since 1992, Grove was a sole practitioner of the Grove Law Office. His areas of legal expertise included personal injury litigation, labor law, workmen's compensation, family law and general litigation.

Grove's professional affiliations and

designations included president of the Evansville Bar Association in 1979; president of the National Conference of Bar Foundations (1985-1987); president of the Indiana Bar Foundation (1979-1982); chairman of the Pre Trial Section of the Indiana Lawyers Commission; and chairman of the Disaster Relief section of the American Bar Association (1972-1974).

In addition to his professional affiliations, Grove was also involved with Masonic activities throughout the past 15 years. In 1992, he was named a Master Mason in Evansville Lodge No. 64 and served as Worshipful Master of the Lodge in 1999. Grove became a Scottish Rite Mason 32nd Degree in 1993. He was the Sovereign Prince of Mordecai Council (1999-2000). Grove was crowned 33rd Degree in the Scottish Rite in 2005.

## Joseph L. Hensley, LLB'55

Hensley, retired judge of the Fifth Judicial Circuit Court for Jefferson and Switzerland Counties in Indiana, passed away on Aug. 27, 2007.

Upon graduation from law school in 1955, he moved to Madison, Ind., and began his practice. He served one term in the Indiana General Assembly in 1962, representing Jefferson & Scott Counties. He was then elected prosecuting attorney for Jefferson and Switzerland Counties, Fifth Judicial Circuit, and served from 1963 to 1966. In 1975, he was appointed judge pro tem of the Ripley Circuit Court by the Indiana Supreme Court and thereafter, while serving, was elected and served two terms as judge of the Fifth Judicial Circuit from 1977 through 1988. He also served two years as president of the Indiana Judges Association. In 1998, he was named a Sagamore of the Wabash by then Indiana Governor Frank O'Bannon. In that same year, Mayor Al Huntington named him one of "Madison's Magnificents." He was also a Kentucky Colonel and an honorary member of the Louisville Singing Fund.

He was the author of more than 20 books, most of them suspense novels, issued from St. Martin's Press, Doubleday, Walker, and other publishers. His approximately 100 short stories were published in mystery, men's, and science fiction magazines and in three collections of short stories published by Doubleday and Five Star. His books and stories were republished by anthologies, book clubs, and paperback reprints and in many languages. At one time, his agents estimated that more than two million copies of his books had been sold. The judge summed up his life by saying that for 51 years he had served as an attorney, judge, legislator, and journalist, a life he enjoyed to the fullest.

Hensley is survived by his son and attorney, Michael J. Hensley and his wife, Kathy, a certified public accountant of Madison, Ind.; his grandson, Evan Michael Hensley, a student at Indiana University Bloomington; his brother, a noted pianist, Tom Hensley and his wife, Sarah, of Sherman Oaks, Calif.; his sister, Patricia Boyd, and her husband Lon; numerous nieces, nephews, and other relatives and friends.

#### Stanley Jablonski, JD'72

Jablonski passed away on Oct. 11, 2007.

He served as a deputy Lake County prosecutor, a public defender, and a private attorney during his 35-year legal career. Throughout his career, he defended a number of police officers in disputes with administrators, including a 1992 case in which he released the testimony of topranking Merrillville police officers using racial slurs when referring to blacks, causing a shakeup in the department. Other clients of Jablonski's private law practice have included Lake Station mayoral candidate Keith Soderquist, former East Chicago Republican Chairman Robert Cantrell, and Robert Velligan, a contractor caught up in the East Chicago sidewalks-for-votes scandal.

#### Gene B. Lee, LLB'46

Lee passed away on Oct. 25, 2007, in Fort Wayne, Ind.

From 1946-1962, Lee served as a general practice lawyer and as a partner at Rockhill Vanderveer Kennedy & Lee in Warsaw, Ind. From 1963-1979, he served as Kosciusko Circuit Court Judge and was appointed to the federal branch in 1979. As a magistrate in Fort Wayne's U.S. District Court, Lee's cases included that of Daryl Oscar McCleese, who was sentenced to 24 years in prison in 1999 after being charged with conspiracy to distribute more than \$1 million in cocaine. In addition to his professional achievements.

Lee was a member of the Warsaw Evangelical Presbyterian Church, Free & Accepted Masons, Warsaw Lodge 73, and the Ancient Accepted Scottish Rite.

#### Richard D. McIntyre Sr., JD'81

McIntyre, a Lawrence County Circuit Court Judge, passed away on Oct. 30, 2007.

Born Oct. 5, 1956, in Lawrence County, he was the son of Dean and Gayle (Perkins) McIntyre. He served as a judge, attorney, U.S. Army officer, and a former state representative. McIntyre was a State Judge Advocate and member of the Indiana State Bar Association, Indiana Judges Association, Indiana National Guard, American Legion Gillen Post No. 33, F.O.P., and St. John's Episcopal Church.

#### **Richard P. Robinson, JD'50**

Robinson, former vice president and general counsel for Sears Merchandise Group, passed away on Aug. 26, 2007.

Robinson grew up in Auburn, Ind. He served in the Naval Reserves and later graduated from the University of Notre Dame and Indiana University School of Law—Bloomington.

Robinson joined Sears as a trainee in 1951 at its headquarters on Homan Avenue in Chicago, becoming manager of the trade practices division in the merchandise comparison department in 1953. In 1960, he joined the law department as an attorney. He was elected vice president and general counsel in 1981, and retired at the end of 1986.

Robinson is survived by his four children, Kathryn A. Berryhill of Houston and Sue Ellen Robinson, Thomas A. Robinson and Philip S. Robinson, all of Geneva, III.; his grandchildren Laura, Rachael, Timothy, Julia and Michael; and his sister, Virginia Robinson.

#### Vern E. Sheldon, JD'56

Sheldon passed away on July 29, 2007, following a short illness. He passed away in the company of his wife of more than 50 years, Mary "Libby" Sheldon, and members of his family.

While at the Indiana University School of Law, he served as editor-in-chief of the *Indiana Law Journal*. Following graduation from law school, he associated himself with the distinguished Lafayette firm of Stuart Devol Branigin & Ricks, continuing there until he was commissioned as 1st Lieutenant in the Judge Advocate General Corps of the United States Army in 1957. He served with distinction as Post Judge Advocate of the Pine Bluff Arsenal Troop from 1957 until 1960. Upon completion of his military duties he associated himself and soon became a partner with what is now the firm of Rothberg Logan & Warsco LLP. He continued there for 25 years, distinguishing himself as an outstanding trial lawyer, well known, popular, and much sought after legal advisor specializing both in litigation and municipal law, where he served both as an Associate City Attorney and as Attorney for the Fort Wayne–Allen County Airport Authority. In 1985, he was selected as a judge in the Allen Superior Court where he continued to serve with distinction until his retirement on Dec. 31, 1998.

Sheldon was highly regarded by all of his colleagues as an outstanding judge, totally dedicated to his judicial responsibilities, always cordial and thoughtful to the lawyers appearing before him, to witnesses, and to the many jurors over whom he exercised.

#### Judith D. Wilkenfeld, JD'67

Wilkenfeld, an attorney who became one of the world's experts on legal issues related to tobacco policy, died of pancreatic cancer on May 24, 2007, at her home in Washington, D.C. She was 64 years old.

Over the years, Wilkenfeld worked at the Federal Trade Commission, the Food and Drug Administration and the nonprofit Campaign for Tobacco-Free Kids, where she sued tobacco companies, helped enforce federal policies, and played a major role in the negotiation of the international Framework Convention on Tobacco Control. She was the lead attorney in the 1990 case brought by the federal government against the R.J. Reynolds Tobacco Co., which challenged tobacco industry advertising that disputed the health risks of smoking. She was instrumental in the FTC decision to sue RJ Reynolds over the tobacco company's use of the cartoon character Joe Camel in its advertising, and in crafting regulations governing health warnings on smokeless tobacco products.

# Val Nolan, JD'49, passes away



Remembered as a supportive colleague, a curious intellectual, and an inspirational and humorous teacher, **Val Nolan Jr.**, JD'49, made enormous contributions throughout his fascinating and varied life. The emeritus professor of law and biology passed away on March 27, 2008, at the age of 87.

"You hear about professors leading the 'life of the mind.' Val is the only one I know who actually did it," said Pat Baude, Ralph F. Fuchs Professor of Law and Public Service, who served with Nolan on the law faculty for 40 years. "Not just the usual stuff like intelligence, discipline, and scholarly ambition. No, he had the real goods: insatiable curiosity, boundless intellectual energy, a passion for perfection, elegance in language, honest self-criticism, and, above all, respect and support for the work and thoughts of others."

After graduating from Indiana University in 1941 with an AB in history, Nolan worked as a Deputy U.S. Marshall before joining the Secret Service. He began working in the Washington, D.C., Field Office, but soon joined the White House detail providing security for President Franklin D. Roosevelt. In 1942, he guarded the president on a nationwide "secret" tour of defense installations, recalling "the trip wasn't so secret after all, because thousands of people saw him."

Later that year, Nolan left the Secret Service to join the Navy, where he served in intelligence as a Japanese language expert. He also spoke Latin, Classical Greek, German, and some French. Initially, he was assigned to an amphibious group and interrogated Japanese prisoners. He was then assigned to the railroad section as an interpreter, working to determine how successful the bombing of the Japanese railroads had been.

Nolan followed in his father's legal footsteps, entering law school in 1946. On his way to graduating first in his class, Nolan served as editor of the *Indiana Law Journal* and was a member of Phi Beta Kappa, Order of the Coif, and Phi Delta Phi. He then joined the Indiana Law faculty, teaching Property, Wills, Land Titles, and Conflicts for the next 36 years until his retirement in 1985. During that time, he served as a mentor and model for countless law students.

"Professor Nolan had this masterful way of engaging and stimulating students with his probing questions or comments, even when you were really seeking answers or guidance. It was invariably his way of teaching," said **Robert Kassing**, JD'64, partner at Bose McKinney & Evans. "No other teacher in my life impacted my ability to think critically nearly as much as Professor Nolan, for which I am forever in his debt. He cared deeply about the students and the School, befriended and benefitted so many of us, and will be greatly missed."

"He was one of just a few people who had a significant impact on my life," added attorney and entrepreneur **Michael (Mickey) S. Maurer**, JD'67. "He had a sense of humor. He once asked me a question in class to which I answered 'yes.' He replied that he was looking for a shorter answer."

In 2000, Maurer and his wife, Janie, endowed the Val Nolan Chair in Law, in honor of his favorite professor. Nolan was astonished. "I have been at the Law School since 1946 and there have been, and still are, a lot of fine teachers here. I feel as if I just happened to be the one who got struck by lightning but I am glad I was," he said at the time. "The notion that you meant something like that to someone else is really overwhelming."

Dean **Lauren Robel**, JD'83, who was named the Val Nolan Professor of Law, noted, "I have been so honored and humbled to have my name associated with his. He was a giant, but a gentle one. His integrity and intellectuality set the standard for many of us at the School, both as students and faculty."

In addition to his legal expertise, Nolan also became a world-renowned ornithologist. In 1957, he was appointed a research scholar in the Biology Department and later began teaching a course for a faculty member on sabbatical. In the late 1960's, while already a tenured professor in the Law School, he was given a joint appointment with Biology.

"He set an extremely high standard for both writing and thinking, one that I have never been able to achieve, but one from which I can measure my shortcomings," said Jeff Stake, Robert A. Lucas Professor of Law. "But his greatest impact on me was at the conceptual level. Val opened my mind to the fascinating possibility that evolution has shaped human behavior in ways that are important to the law."

Nolan served as Acting Dean of the Law School in 1976 and again in 1980, when he helped persuade the Indiana Legislature to expand the Law Building.

His pervasive talents as a Secret Service agent, intelligence officer, legal scholar, and ornithologist created a sense of awe among his admirers. "He was quite dashing, a trait rarely linked to law faculty," said former Indiana Law Professor Richard Lazarus, now on faculty at Georgetown Law School. "With his strikingly handsome good looks, it was not hard to imagine him working in the White House as a Secret Service agent protecting Franklin D. Roosevelt."

A memorial service will be held on Oct. 3 in the Law School. Memorial contributions may be made to the Sycamore Land Trust or the IU School of Law.
