Job Announcement: Faculty Research Assistant Program

The Jerome Hall Law Library is now accepting applications for the position of faculty research assistant for an ongoing research program at the Law School. Successful applicants will be responsible for conducting research on a variety of topics for members of the faculty. Topics and research methods will vary by project. Past topics have included business and corporate law, bankruptcy, First Amendment law, and international criminal law, among many others. Faculty research assistants will be trained, supervised, and given assignments by the student services librarian. They will be expected to work up to 29 hours per week during the summer. The

number of hours will vary with the number of faculty research requests. Hours are flexible. FRAs must be located in Bloomington for the summer due to the occasional need for in-person consultations and research training. The positions are limited to rising 2L and 3L JD students.

Faculty and Staff News

Prof. **Leandra Lederman**, William W. Oliver Professor of Tax Law and director of the Law School's tax program, is the recipient of Indiana University's 2019 [Tracy M. Sonneborn Award](#). The award honors faculty for accomplishments in the areas of teaching and research. Named for the late eminent scientist Professor Tracy M. Sonneborn, the award is given to an exemplary researcher who is also well known as an exemplary teacher. Lederman will deliver the annual Sonneborn Lecture this fall. She is currently on a sabbatical leave as a Fulbright Scholar in Luxembourg. Prof. **Susan Williams** was the law school's most recent Sonneborn winner, in 2014.

On March 29, 2019, Prof. Lederman spoke on the US experience with tax general anti-abuse rules in the Tax Practice seminar at the University of Luxembourg organized by Prof. Werner Haslehner, her host during the Fulbright fellowship.
