KIMBALL TO PRESENT PAPER AT ROME INSURANCE LAW CONVENTION

Professor Spencer L. Kimball has accepted an invitation to present a paper to the First International Congress for Insurance Law to be held in Rome April 4-7. The Congress is sponsored by the International Association for Insurance Law.

His topic will be "Goals and Methods of Insurance Supervision". More than 600 insurance lawyers, most of them from Europe, are expected to attend.
