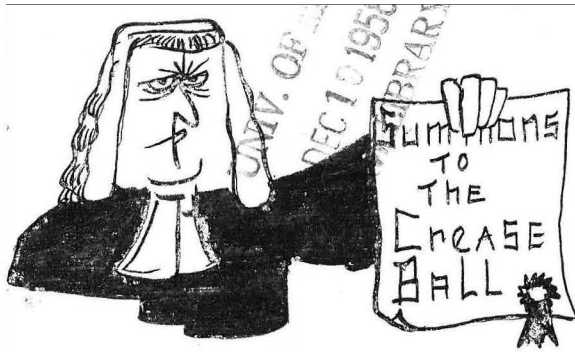

Intermission program will feature the Psurfs and Professor L. Hart Wright as master of ceremonies . . . . . Refreshments, entertainment in the lounge by a banjo duo, and distribution of the RAW REVIEW are also on the agenda.

FRATERNITY SOCIAL EVENTS . . . "NOTHIN' DOIN'" this weekend as all fraternities (including the ZOTS) plan for pre-parties and picnics for the Crease Ball weekend. . . . . TERS and PHIDS will also have dinners before the dance on Friday . . . . . Picnics are slated for Saturday.

OPEN HOUSE AND JAZZ CONCERT AT THE LAW CLUB WILL WRAP UP THE CREASE BALL WEEKEND on Sunday afternoon . . . . . Open House will be from 2:00 to 4:00 . . . . . Dixieland Jazz Concert by the Ann Arbor Alleycats will be held on the lawn beginning at 4:00; refreshments will be served.

ELECTION OF JERRY LIBIN AS EDITOR-IN-CHIEF OF THE MICHIGAN LAW REVIEW for next year by the faculty was announced at the Honors Banquet on Wednesday evening . . . . . Announced as Associate Editors were Frederic Brace, Dick Hayden, John Jackson, John Schwemm, David Shute, and Stan Walch.

FRESHMAN CLASS PICNIC I has been called off. Tickets will be refunded by Benny Kass, Law Club N-24.

REPORT OF THE SCHOLARSHIP AWARD COMMITTEE shows that a total of \$146,075 in financial aid was given to 354 law students during the period from Feb. 16, 1957 to Feb. 15, 1958 . . . . . 69 students received \$33,965 in scholarships; 116 received \$57,730 in Leckie and DeWitt Awards, carrying a moral obligation to repay; 169 received loans totaling \$54,380 . . . . . Assistant Dean Roy Proffitt, committee chairman, says the demand for financial assistance for next year is running ahead of a year ago, both in the number of applications and the size of the requests; reasons for this include (1) general economic recession, (2) continued slow rise in the cost of living, including the big jump in tuition last year, and (3) rapidly decreasing number of students receiving benefits under the GI Bill. . . . . "It appears doubtful that there will be enough money available to satisfy all the requests," according to Proffitt. "The Committee will make every effort to take care of the most

essing needs of all the students, but it can stretch a dollar no further than anyone else." Hoffitt suggests that students who will need financial aid for next year should explore the possibility of obtaining some assistance from outside sources.

Honored as the three highest in the junior class were Jerry Libin, Shute, and John Jackson; three highest seniors were Hoerner, Dewey, and Nick Yocca.

RENE DAVID, PROFESSOR OF COMPARATIVE CIVIL LAW AT THE UNIVERSITY OF PARIS, gave the first of two lectures Thursday on French problems of consideration and protections against unfair contracts . . . . . Second lecture will be given Friday in Hutchins 100 at 2:30 p.m. . . . . Prof. David was a guest at the Law Club for dinner and an informal discussion in the lounge on Thursday evening.

Some runs and big scores highlighted the opening of the PROFESSIONAL FRATERNITY SOFTBALL LEAGUE . . . . . Law Club won 15-4 over Phi Chi; Jerry Leippy was the standout as he pitched the entire game and hit a grand slam home run; Brad Glass, Dave Nelson and Joe Morgiana also homered . . . . .
