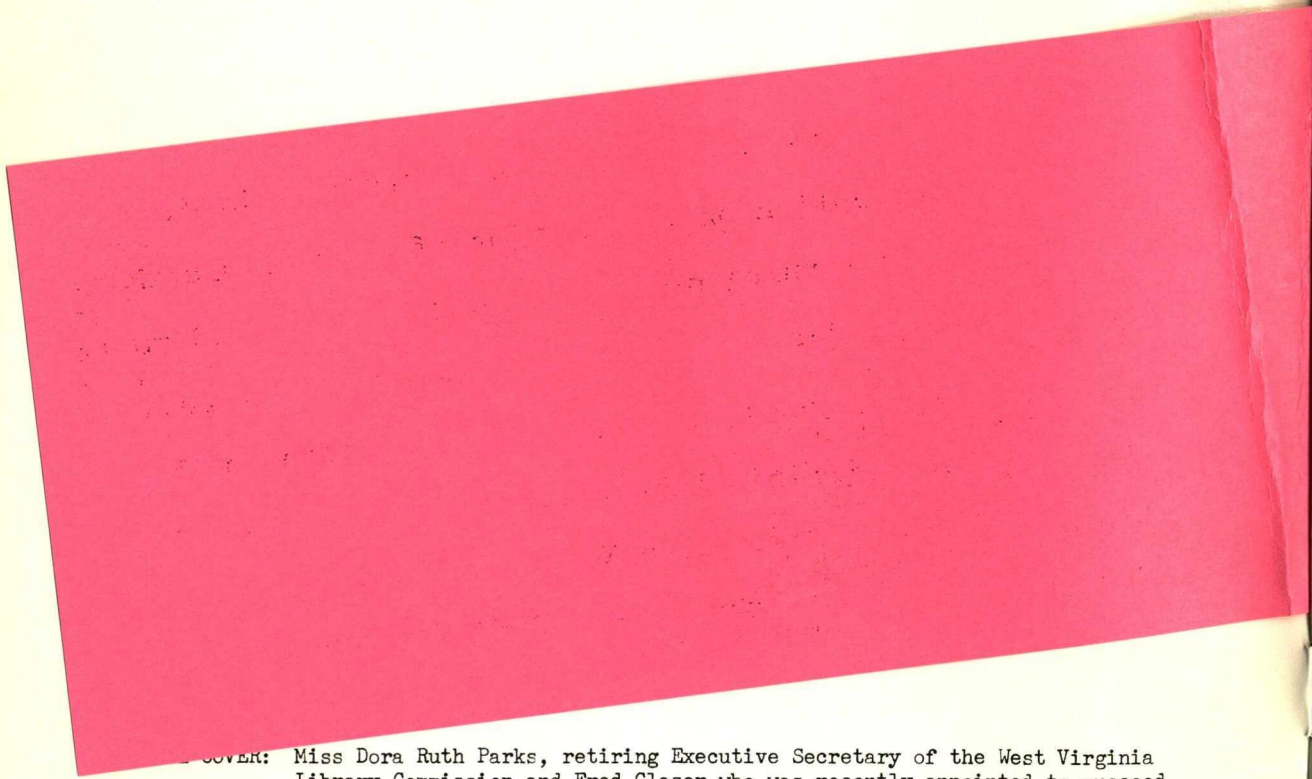

December 4, 1971

The meeting was called to order at 10:50 a.m. by Robert L. Murphy, President.

Members present were:

Robert Murphy, President; Elliott Horton, 2nd Vice-President; Judy Rule, Secretary; James Smith, Treasurer; Lois T. Murphy, Editor, West Virginia Libraries; Nancy Jo Canterbury, State Department of Education; Barbara Bonfili, School Libraries chairman; Elizabeth Fair, Public Libraries, Chairman, and Donna Hudson, Special Libraries chairman.

Doug Olsen attended as an alternate and Merle Moore as the convention chairman.

Nancy Canterbury moved and Elizabeth Fair seconded the motion to approve the minutes of the previous meeting as read. Motion was carried.

Mr. Murphy reported that Post Office Box 884, Morgantown, West Virginia is now the official mailing address of the West Virginia Library Association. The mailing address now paves the way for a third class mailing permit.

Two suggestions were offered by Mr. Murphy for projects for this year.

1. That WVLA sponsor a 30-minute show on the educational television station from Morgantown.

2. A published listing of all surplus materials in West Virginia libraries to be circulated among libraries in the state.

It was suggested that the Vice-President bill institutions and individuals for dues for 1972. Dues for 1972 are due in December of 1972. The membership committee is to actively help the Vice-President to recruit new members.

The 2nd Vice-President Elliott Horton had no report but has been asked to serve as historian for WVLA for 1972.

The treasurer reported a balance of \$1,066.00.

Elizabeth Fair moved and Elliott Horton seconded the motion that the WVLA not pay honorariums to members of WVLA for speaking at a function of the Association. Any members speaking at any function of the group will have his or her expenses paid if their library has not paid for this expenditure. Motion was carried.

The meeting adjourned for lunch at 12:30.

NEW EXECUTIVE SECRETARY OF WVLC  
SEEKS ADEQUATE FUNDING OF LIBRARIES

Fred Glazer, WVLA  
Convention Speaker  
Now WVLC Head

Fred Glazer, 34, red-headed, bearded, and dynamic, is the new Executive Secretary of the West Virginia Library Commission. Mr. Glazer had been in office only one week when he made a presentation to the House and Senate Finance Committees, pleading for adequate funding of West Virginia libraries by the state in 1972.

Among the group, which Mr. Glazer convened, to make statements in support of his stand were representatives from several regional and service center libraries; Dora Ruth Parks, former WVLC executive secretary, and two members of the State Library Board.

Both House and Senate members apparently seemed impressed since typical comments overheard were that most of the legislators felt he had done his homework in his presentation of the financial plight of West Virginia libraries.

Mr. Glazer gave each member of the committees an 8¢ roll of lifesavers, symbolic of the 8¢ per capita which the state awarded to libraries last year. This was .17 of 1 % of the state budget last year. Mr. Glazer pointed out that the

increase in the state funds for libraries was less than 14%, while the state budget increased 14.5%, so that state libraries actually lost ground financially.

West Virginia Ranks Last Nationally

Other facts brought to the legislators attention by Mr. Glazer and his representatives were that West Virginia ranks last in percentage of population served, local expenditures, state aid to public libraries-per capita state aid-per capita circulation-per capita volumes.

Mr. Glazer's grasp of the financial picture of West Virginia Libraries is undoubtedly aided by the degree of economics he earned at Columbia University.

Mr. Glazer is also known as a publicist. He has been awarded the Poster of the Decade Award . Among his other achievements is an audio-visual program, he wrote, produced, and directed. This has been shown at a governor's conference and is being considered for showing at the next ALA Convention.

Mr. Glazer's message to the West Virginia Librarians, Trustees, and friends is simple---Contact your state legislators, particularly those legislators who are members of the finance and budget committees. Let these legislators know what appropriate funds will mean to you, to your library, to your patrons, to your state. If you don't care, who does? Who should?

RARE BUT NOT UNAVAILABLE

Let your mind picture the front cover of the College and University Library Directory of 1971 and have your eye follow a line from north to south beginning with West Liberty, continuing with Salem, and terminating with Bluefield in the south. This line through the center of the state is indicative of the cooperative spirit of the college and university libraries, for each of them at these locations has purchased the Library of American Civilization, a microfiche collection of 15,000 volumes, thus making them available to the rest of the state.

This is closely in keeping with the philosophy of the federal government at the present time which distributes funds quite often to cooperative enterprises, ranging from inner city to interlibrary. As a matter of fact, the Benedum Library at Salem College obtained its Microbook Library Series of Library Resources Inc., a subsidiary of Encyclopaedia Britannica Inc., with the help of a Type C grant obtained because it was a member of the Mountain State Association of Colleges, a group devoted to the sharing of knowledge

and the obtaining of funds necessary for this purpose.

An example of how the members of this Association are willing and anxious to share their library resources was presented at a recent meeting held at Salem College in which interested students, faculty members, and visitors heard Miss Jackie Kasabach of Library Resource Inc., explain the microbook library and the microfiche reader necessary to make use of it. Knowing everything naturally, as do native West Virginians, Miss A. Merle Moore, Librarian of the Clarksburg Public Library, mentioned that in addition to the libraries mentioned, others such as the West Virginia University and Fairmont State College, would obtain the set, thus assuring even wider use; and asking whether the patrons of her library could use the microfiche of Salem College if she were able to obtain readers. The answer, of course, was that certainly this could be done and that similar requests from libraries throughout the state were welcome.

The Microbook Library itself covers all aspects of American life from the period of discovery to World War I. The nature of the collection is such that a survey revealed that at the most only a few of the largest university libraries could have more than 50 to 60% of the titles. In addition, a library with a book

collection of 100,000 volumes could be certain that duplication would not exceed 15%. The importance of the material was verified by the fact that forty-eight distinguished scholars selected it from major libraries of the country, such as the Library of Congress and the University of Illinois. After that, each title was photographed and placed upon a transparent three-by-five film card, protected by lamination on both sides.

By this method, the Library of American Civilization may be stored in Thirty-two catalog trays, close to which will be the printed volumes containing catalog cards with the usual author-subject-title information. In addition, furnished will be a Biblioguide or topical index to the set. The result for the user is that he has at hand the best material dealing with all aspects of American Life, its original form of publication, whether it may have been as a sheet, a pamphlet, a document, a periodical, a foreign publication, or a book, having been transferred to the compressed microfiche, at a cost of 1/3¢ per page as compared to .02 for a book.

As each of us is delighted, along with the children, at the knowledge which is presented in Sesame Street, he realizes that the expansion enunciated by McLuhan has indeed taken place and that young minds must be approached by means of technological innovations that are as natural to them as Dance Marathons were to many of us, and give them an opportunity to confront their peers with similar images. While doing

While doing this, our task as librarians is to present them with what is best, that is, with the rare but not unavailable.

#### NEW CLARKSBURG LIBRARY IN PLANNING STAGE

A special committee was formed during the last few months of 1971 to begin planning for a new library for Clarksburg.

Tentative plans call for using the present library as a museum and repository for its rare books, Appalachian Collection, West Virginia Collection, and other such materials. The West Virginia Collection has been utilized so thoroughly by Harrison County residents that a new staff member has been added to aid with the sought for genealogy information.

Miss Elizabeth Wade, librarian of Shinnston High School, past president of WVLA, is a member of the special committee.

Miss Merle Moore, librarian, reports that book circulation has increased in all parts of the library. Several hundreds of books for children have been bought and recently the children book shelves were almost empty.

Miss Moore, during her three years as librarian, has added many library services for the Clarksburg-Harrison County area.

With the addition of a new library hopes are that it will complement the present structure "Waldomore" which has served for more than 30 years as the center of library service for Clarksburg.

FRIENDS OF THE LIBRARY  
STAGE BANQUET

On January 25, 1972 The Friends of the Morgantown Library held their 18th Annual Banquet with Mrs. Betsy Byars, winner of the 1971 Newbery Award, as speaker.

A musical program by the newly formed Morgantown Men's Chorus was under the direction of Dr. Tom Brown, Professor in the Music Department of West Virginia University.

Mrs. Byars is the second Newbery Award winner to speak to the group; Jeanne Lee Latham another West Virginia author has also spoken to the group.

Folk-lorist Dr. Ruth Ann Musick; newspaperman Jim Comstock; Dr. Roy B. Clarkson, author of Tumult on the Mountain, and Julia Davis, whose most recent book is Mount Up, are other well known personalities who have addressed the annual banquet gatherings.

Additional past distinguished speakers, whom most West Virginia librarians will or should recognize, include geologist Betty Brayles; artist and craftsman Josephine Aull; Mrs. Bruce Crumm, Past President of the National Story League, and Dr. Armand Singer, Professor of Romance Languages, West Virginia University.

During the banquet ceremonies introduction was made of the Friends Officers for 1972. They are: Mrs. William (Frankie) Delardas, President; Mrs. Bernard Zimmerman, Vice-president; Mrs. Roland Guthrie, Treasurer, and Virginia Baer, Secretary.

The most significant contribution of the Friends to date has been the major role they played in organizing community sentiment to the passage of the levy and the building of the present library building, which opened for business in November of 1964. The time is fast approaching when an additional story for the library is needed and the Friends expect to be as busy and as effective in that campaign as they were in the first.

The Friends provide some item of equipment each year for the Morgantown Library. This item is usually not provided in the annual budget. Some of the items have been; an aquarium, a bulletin board, and the pin money to provide poster materials and fish food.

Members of the group, among their many services, act as hostesses or receptionists for a large variety of library functions.

The banquet was held in the Spruce Street Methodist Church, Morgantown.

## READY REFERENCE SERVICE

"How would you set up a telephone reference service?" was the question James B. Nelson, director of the Cabell County Library, asked me during my job interview. This led to the idea of would it work.

The first step was to investigate this type of service in other libraries. An Information Service which limits reference service to five minutes, is perfected to a high degree in the Cincinnati Public Library which serves over a 900,000 population in contrast to Cabell County with an approximate 100,000 population. The location of the Information Service desk is on the main floor of the library. The Cincinnati library have two trained librarians and one assistant at this desk. They answer inquiries from persons and from telephones. They are seated at a waist high charging desk, with more than 600 reference books shelved behind them, and behind these books is the general card catalog.

Kanawha County Public Library has a ready information type of collection at hand near the reference desk located on the first floor. Because of the extent of patron usage of the reference collection, their policy is not to give telephone reference service to students. Circulation assistants at the desk near the front entrance serve to give directions to patrons.

At the Boulder Public Library, Boulder, Colorado, college students man the telephone reference service after the library's regular closing hours, from 9 a.m. to 11 p.m. They answer questions of a ready reference nature. A federal work study program for these students enables the library to extend its reference service without overextending its budget.

The students are required to pay off their work-study grants by working for city agencies. They have been trained in the use of standard reference tools, including almanacs, dictionaries, and organizational manuals. Unsolved problems are referred to the regular staff for the next day.

Similar to the Boulder service is the after hours reference service given by the Berkeley and Oakland Public Libraries as one of the facets of BOSS, the new library cooperative formed by the two. 2

Previous to the massive publicity campaign, the first five weeks were a resounding success with 182 call recorded from regular closing time to midnight. The service is seven nights a week. With the busiest night being Saturday.

### Ready Reference at Cabell

In the Cabell County Public Library, the staff of the Adult Services and Reference agreed on a collection of approximately 170 books to be placed on the shelves behind the charging desk. Bob Lahn, reference assistant, placed a sign, "Ready Reference" placed on the desk and now is unofficially known as "Ready". The area contains the charging, catalog, and telephone.

As patrons realized that their questions could be answered here, usage of the service became heavier.

The service is limited to five minutes of telephone time.

The most used books are Books in Print, City Directory, Black's Law Dictionary, The World Almanac, The West Virginia Blue Book, The Short Story Index, The Dictionary of Abbreviations, Lovejoy's College Guide, The Cyclopaedia of World Authors, The Cyclopaedia of Literary Characters, Guinness Book of World Records, Merck's

Manual, Granger's Poetry Index, and the Marshall University Bulletin.

The AAA Tour Books are the only books placed on the shelf but have not been heavily used at this time.

Patrons are also referred to the card catalog when sources of ready reference are not sufficient. If the patron's need requires more specific work he is sent either upstairs to the Reference Room or downstairs to Junior Services.

Because of the steady usage of Masterplots by students in the Reference Room additional copies were acquired for the Ready Reference desk.

One of the problems that the Ready Reference desk was meant to solve was the necessity of the elderly patrons to climb the stairs. This problem still exists.

The staff agreed that having a reference assistant on duty did give extra help for the busy circulation assistants. Circulation is usually too busy to answer the briefest of reference questions.

An assistant trained in the use of reference tools also helped to solve the problem of showing patrons how to use the collection.

#### Increase of Interlibrary Loans

The reference assistant aided in the increasing use of the interlibrary loan service by telling the patrons of its existence. The staff of Adult Services were encouraged to suggest interlibrary loans by the use of the teletype machine.

Lack of enough space is one problem confronting the Ready Reference Service. The service is near the circulation desk, a busy place with a lot of congestion. Ideally, the service should be near the front entrance of the library, and separate from the charging desk.

The Ready Reference service has started and as its popularity grows we will look forward to another aid for our patrons.

## LIBRARY ADVISORY COUNCIL FORMED AT CHARLESTON MEETING FOR STREAMLINING LIBRARY SERVICES

The newly formed Library Advisory Council held their first meeting late last year at the WVLC offices in Charleston.

The following is the nucleus of a group of 23 librarians who met earlier to set up priorities for streamlining library service in West Virginia: Nancy Taylor, Huntington, libraries in state institutions; Victorine Loiustall, WVU, library users; Nancy Canterbury, State Department of Education, school libraries; Elliott Horton, Morgantown public librarian; Nicholas Winowich, Kanawha County librarian; Lester Smith, Concord College librarian, Perry OBrien, attorney from Ripley, public library trustees, and Ray Thomas from Charleston and representative of physically handicapped readers.

The Delphic Forecasting Method for planning was used by the group to pinpoint the needs of West Virginia Libraries for the next five years.

A total of 102 proposals were collated by the WVLC and distributed to the group for marking their value--which ranged from excellent to none.

Each member marked their value to each proposal, returned the proposals to the WVLC which tabulated the results. This enabled them to see how they individually voted in relation to the majority and they were given time to change their original marking.

Only time will show how this brainstorming will truly better the conditions of libraries in West Virginia. West Virginia libraries in national statistics is at the bottom.

RESOLUTION ON CHALLENGED MATERIALS

*An Interpretation of the LIBRARY BILL OF RIGHTS*

WHEREAS, The LIBRARY BILL OF RIGHTS states that no library materials should be proscribed or removed because of partisan or doctrinal disapproval, and

WHEREAS, Constitutionally protected expression is often separated from unprotected expression only by a dim and uncertain line, and

WHEREAS, Any attempt, be it legal or extra-legal, to regulate or suppress material must be closely scrutinized to the end that protected expression is not abridged in the process, and

WHEREAS, The Constitution requires a procedure designed to focus searchingly on the question before speech can be suppressed, and

WHEREAS, The dissemination of a particular work which is alleged to be unprotected should be completely undisturbed until an independent determination has been made by a judicial officer, including an adversary hearing,

THEREFORE, THE PREMISES CONSIDERED, BE IT RESOLVED, That the American Library Association declares as a matter of firm principle that no challenged library material should be removed from any library under any legal or extra-legal pressure, save after an independent determination by a judicial officer in a court of competent jurisdiction and only after an adversary hearing, in accordance with well-established principles of law.

Adopted June 25, 1971 by the ALA Council.

## Library Bill of Rights

The Council of the American Library Association reaffirms its belief in the following basic policies which should govern the services of all libraries.

1. As a responsibility of library service, books and other library materials selected should be chosen for values of interest, information and enlightenment of all the people of the community. In no case should library materials be excluded because of the race or nationality or the social, political, or religious views of the authors.

2. Libraries should provide books and other materials presenting all points of view concerning the problems and issues of our times no library materials should be proscribed or removed from libraries because of partisan or doctrinal disapproval.

3. Censorship should be challenged by libraries in the maintenance of their responsibility to provide public information and enlightenment.

4. Libraries should cooperate with all persons and groups concerned with resisting abridgment of free expression and free access to ideas.

5. The rights of an individual to the use of a library should not be denied or abridged because of his age, race, religion, national origins or social or political views.

6. As an institution of education for democratic living, the library should welcome the use of its meeting rooms for socially useful and cultural activities and discussion of current public questions. Such meeting places should be available on equal terms to all groups in the community regardless of the beliefs and affiliations of their members, provided that the meetings be open to the public.

Adopted June 18, 1948.
