

OPAC - NOT A TREATY, JUST A VALUABLE RESEARCH TOOL

When you search the Online Public Access Catalog (OPAC), there are many ways to locate what you want. If you do not know the exact title of your book, try a title keyword search. Just enter the most important words, leave out the generic words (like law or court), and leave out the prepositions, articles, and connectors. Dynix, UR's OPAC software, assumes the connector to be "and" unless you put two terms in parentheses, which creates an "or" connector. For example, (tax taxation) tells Dynix to look for tax or taxation.

If your title includes generic words that you anticipate will retrieve hundreds of hits, try a general keyword search. With a general keyword search you can input an author's name and a word or words from the title such as "Wigmore evidence." You can also input words that appear elsewhere in the cataloging record such as publisher or date of publication or subject or series. For example, to retrieve the torts hornbook, enter "torts hornbook," and Prosser will appear first in the list of results.

Another option if your title is full of generic words is an author search. For example, author searches can be surprisingly useful in locating state material. Try the author "Wyoming," for instance, if you do not know the exact title (or even close) for Wyoming laws. Sometimes those state materials have titles that are decidedly not intuitive. Once you retrieve hits with Wyoming as the author, you can select the line number by Wyoming and look at the hits listed there. Sometimes the state as author is more com-



plicated, such as Wyoming. Office of the Attorney General. So, you might need to go back to the list with Wyoming and look at other author names beginning with Wyoming.

Like many state materials, older books are in the non-intuitive category. Decades ago (like the 1950's) spine titles and cover titles did not appear on catalog cards, yet they were often the titles familiar to practitioners. This is a place to use title keyword searches (provided the titles have distinctive words, remember!) or general keyword searches (if you believe an author/title search would be better than title keyword). It is unlikely that most folks would remember the wordy titles of these older books in order to input an exact title search.

Finally, a search option that is underappreciated is the series search. You might be seeking a Virginia CLE title but not have a clue as to its title. Select the series search option and input Virginia CLE. Okay, this does retrieve over 200 hits. But there is an even less used option to help you

here. Type SL for Sort list and hit the enter key. You can then sort by title, author, or publication date, depending on what you are seeking. A further hint: sort list will provide you with a quick and dirty bibliography complete with call numbers! Also, consider Sort list for any long list of hits, even when you aren't doing a series search. Sorting the long lists makes them more useable and friendly.

These examples briefly illustrate the increased sophistication of an Online Public Access Catalog --although many of us still remember the old card catalogs with fondness.

BEYOND REBOOTING: COMPUTER TIP OF THE MONTH Eliminating Banner Pages

Many students have asked how to eliminate the banner pages that print before a job queued to the lab. The following steps will assist you in doing that:

Go to MY COMPUTER

Choose PRINTERS

page.

Choose the PRINTER you want to enable the banner page

Click FILE, then PROPERTIES

Choose PRINTER SETTINGS

Under BANNER SETTINGS, you will notice a checked box.

UNCHECK the box to disable the banner page; leave it checked to keep the banner

If this feature is disabled, the blank pieces of paper that sometimes follow print jobs may be eliminated as well. Please be careful not to pick up someone else's print job, if you choose to eliminate the banner pages.



A listserv which distributes up-to-the-minute information about U.S. Supreme Court announcements is administered by the Willamette University College of Law. By joining the list, you will receive e-mail announcements of all matters granted or denied *certiorari* and opinions of the court, including summaries. For example, the September 30th and October 5th e-mails listed fifteen matters granted *certiorari*, with summaries of the cases; the October 5th and October 12th releases listed the arguments and summaries scheduled for those weeks.
