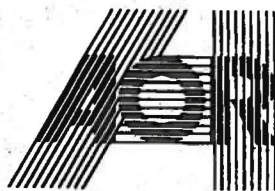

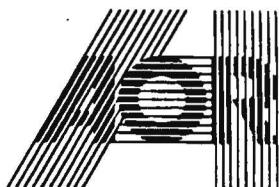

INTRODUCTION

The bipartisan Assembly Task Force on Defense Conversion was created in March 1993. The mission of the 23-member Task Force is to maximize federal defense conversion funding for California and assist communities in the defense conversion process. During the last seven months, Task Force members have worked toward accomplishing this mission through a variety of activities, which include:

- ▶ Establishing a hotline for assistance on available federal and state grants and other defense conversion-related activities;
- ▶ Conducting regional hearings in the Bay Area and Southern California to identify barriers to federal and state assistance in defense conversion;
- ▶ Providing the Congressional Task Force on Defense Reinvestment and Economic Development with suggested federal legislation to remove the barriers to defense conversion;
- ▶ Conducting special hearings on base facility reuse and defense worker retraining opportunities through Task Force working groups (worker retraining, community adjustment, and defense industry adjustment);
- ▶ Convening workshops on base reuse planning, toxic cleanup, and economic development for California communities affected by scheduled base closures; and
- ▶ Introducing legislation, which was signed into law, to assist communities in the military base reuse and defense conversion process.

S. 251 (Pell) - Job Training and Partnership Act Amendment

- ▶ Amends the Job Training Partnership Act to improve the Defense Conversion Adjustment Program, and for other purposes. (Referred to Senate Committee on Labor and Human Resources. No action scheduled as of 10/13/93.)

S. 319 (Wofford) - Recommendations on Base Closing Outside the U.S.

- ▶ Requires the Secretary of Defense and the Defense Base Closure Realignment Commission to make recommendations in 1993 and 1995 for the termination and reduction of United States military operations at military installations outside the United States. (Referred to the Senate Committee on Armed Services. No action scheduled as of 10/15/93.)

S. 365 (Feinstein) - Conveyance of Real Property at Fort Ord to University of California and California State University

- ▶ Directs the Secretary of Defense to convey to the University of California and the California State University certain surplus real property at Fort Ord, California. (Referred to Senate Committee on Armed Services. No action scheduled as of 10/13/93.)

S. 395 (Lieberman) - Federal Laboratories

- ▶ Establishes a program for the diversification of activities of certain federal laboratories. (Referred to Senate Committee on Armed Services. No action scheduled as of 10/13/93.)

S. 614 (Domenici) - Commission on the Dual-Use Application of Facilities and Resources at White Sands Missile Range Act

- ▶ Establishes a commission on the commercial application of certain defense-related facilities, equipment, processes and technologies. (Introduced on 03/18/93. No action scheduled as of 09/24/93.)

S. 660 (Riegle) - Preparation of Community Economic Adjustment Plans Before the Closure of a Military Base

- ▶ Prohibits the Secretary of Defense from closing or realigning a military installation under a base closure law until a community economic adjustment plan is prepared.
- ▶ Outlines provisions concerning plan preparation and requirements. (Referred to Senate Committee on Armed Services. No action scheduled as of 10/13/93.)

S. 850 (Boxer) - Economic Conversion Clearinghouse Act

- ▶ Establishes within the Department of Commerce the Office of Economic Conversion Information to: (1) serve as a central information clearinghouse on economic adjustment and defense conversion; and (2) aid persons in applying for grants.
- ▶ Establishes the Interagency Economic Conversion Information Coordinating Committee to advise and assist the Office. (Referred to Senate Committee on Commerce, Science, and Transportation. No action scheduled as of 10/13/93.)

S. 1056 (Feinstein) - Allocation of Defense Conversion Funds on the Basis of Job Losses

- ▶ Requires that defense reinvestment and economic growth funds be allocated among communities on the basis of the relative levels of reductions in employment experienced in such communities as a result of defense spending reductions or the closure or realignment of military installations. (Referred to Senate Committee on Governmental Affairs on 05/27/93. No action scheduled as of 09/24/93.)

S. 1298 (Nunn) - National Defense Authorization Act for Fiscal Year 1994

- ▶ Authorizes appropriations for fiscal year 1994 for military activities of the Department of Defense, for military construction, and for defense programs of the Department of Energy, to prescribe personnel strengths for the Armed Forces, and for other purposes. (Received in the House as of 09/21/93, after passage in the Senate.)

S. 1337 (Nunn) - National Defense Authorization Act for Fiscal Year 1994

- ▶ Authorizes appropriations for fiscal year 1994 for military activities of the Department of Defense to prescribe personnel strengths for the Armed Forces, and for other purposes. Its provisions were amended into S. 1298. (Received in the House as of 09/21/93, after passage in the Senate.)

S. 1338 (Nunn) - Military Construction Authorization Act for Fiscal Year 1994

- ▶ Authorizes appropriations for fiscal year 1994 for military construction, and for other purposes. (No further action is expected on S. 1338, now that the full defense bill, S. 1298, passed the Senate.)

HOUSE

H.R. 41 (Geidenson) - Invest in America Act

- ▶ Authorizes the President to seek the recoument of defense expenditures abroad and to authorize the use of expenditures recouped for domestic investment projects. (Joint referral to various House committees on 01/05/93. No action scheduled as of 09/24/93.)

H.R. 841 (Kennelly) - Defense Economic Reinvestment Act of 1993

- ▶ Establishes economic conversion programs in the Department of Defense to assist communities, businesses, and workers adversely affected by reductions in defense contracts and spending and closures of military installations, and to provide an additional credit against federal unemployment tax for states with reemployment assistance programs. (Referred to various House committees. No action scheduled as of 10/15/93.)

H.R. 1027 (Waters) - Internal Revenue Code of 1986 Amendment

- ▶ Amends the Internal Revenue Code to establish a defense contractor conversion investment tax credit. (Referred to House Committee on Ways and Means. No action scheduled as of 10/13/93.)

H.R. 1259 (Lantos) - Defense Industrial Stabilization & Community Transition Act of 1993

- ▶ Provides for economic conversion and diversification of industries in the defense industrial base of the United States that are adversely affected by significant reductions in defense spending. (Referred to various House committees. No action scheduled as of 09/24/93.)

H.R. 1260 (Lewis) - National Aeronautical Research and Competitiveness Act of 1993

- ▶ Provides for the establishment of a joint aeronautical research and development program between the National Aeronautics and Space Administration and the Department of Defense, and other purposes. (Referred to House committees on Armed Services and Science, Space and Technology on 03/09/93. No action scheduled as of 09/24/93.)

H.R. 1269 (Snowe) - Comprehensive Base Closure Reform and Recovery Act of 1993

- ▶ Establishes a comprehensive recovery program for communities, businesses, and workers adversely affected by the closure or realignment of military installations. (Parts of this measure incorporated into H.R. 2401 on 09/13/93. No action scheduled as of 09/24/93.)

H.R. 1321 (Horn) - Defense Base Closure and Realignment Act of 1990 Amendments

- ▶ Amends the Defense Base Closure and Realignment Act of 1990 to require the Secretary of Defense and the Defense Base Closure and Realignment Commission to consider military installations outside the United States for closure and realignment in addition to military installations inside the United States. (Referred to House Committee on Armed Services. No action scheduled as of 10/13/93.)

H.R. 1323 (Pelosi) - National Economic Conversion and Environmental Restoration Act of 1993

- ▶ Authorizes the Secretary of Labor to make demonstration grants to institutions of higher education to provide education and training in environmental restoration to displaced defense workers and young adults. (Incorporated in H.R. 2401)

H.R. 1432 (Brown) - Department of Energy Laboratory Technology Act of 1993

- ▶ Establishes missions for Department of Energy research and development laboratories, provides for the evaluation of laboratory effectiveness in accomplishing such missions, reorganizes and consolidates Department of Energy technology transfer activities, and other purposes. (House Science, Space and Technology Committee)

H.R. 1776 (DeLauro) - Defense Industrial Diversification and Community Assistance Act

- ▶ Facilitates and assists in the economic adjustment and industrial diversification of defense industries, defense-dependent communities, and defense workers that are adversely affected by the termination or reduction of defense spending or defense-related contracts. (Referred to various House committees on 04/21/93. No action scheduled as of 09/24/93.)

H.R. 1850 (DeLauro) - Technology Development

- ▶ Provides incentives for universities to develop effective technology-development and technology-transfer programs, and to enter into partnership with businesses, in coordination with state and local governments, to develop technologies and processes critical to meeting specific national goals and promoting long-term vitality of local communities. (Referred to various House committees. No action scheduled as of 10/13/93.)

H.R. 1880 (Bacchus) - Defense Workers Economic Reinvestment Act of 1993

- ▶ Seeks to mitigate the adverse effects on defense contractors and defense workers of reductions in defense spending.
- ▶ Establishes an Office of Training Oversight and Administration to coordinate and oversee the retraining, placement, and other transition assistance for eligible defense workers. (Referred to various House committees on 04/28/93. No action scheduled as of 09/24/93.)

H.R. 1957 (Burton) - Transfer of Property at Military Installations

- ▶ Amends the base closure laws to require the Secretary of Defense to transfer real property and facilities at military installations being closed or realigned to states and other entities that agree to convert the property and facilities into correctional facilities for youthful offenders to be operated as military-style boot camps, and to require the Secretary to develop a program to promote the expanded use of such correctional facilities. (Referred to House committees on Armed Services and Judiciary. No action scheduled as of 10/13/93.)

H.R. 1958 (Clyburn) - Tax Incentives for Areas Affected by Base Closings

- ▶ Amends the Internal Revenue Code of 1986 to provide tax incentives with respect to enterprise zones and areas affected by military base closings or reductions in military base employment. (Referred to House Committee on Ways and Means. No action scheduled as of 10/13/93.)

H.R. 2010 (Martinez) - National and Community Service Trust Act of 1993

- ▶ Amends the National and Community Service Act of 1990 to establish a Corporation for National Service, enhance opportunities for national service, and provide national service educational awards to persons participating in such service, and other purposes. [Public Law 103-82 (107 Stat. 785), approved 09/21/93]

H.R. 2040 (Skeen) - Commission on Commercial Application

- ▶ Establishes a commission on the commercial application of certain defense-related facilities, equipment, processes, and technologies. (Referred to House Committee on Armed Services. No action scheduled as of 10/13/93.)

H.R. 2064 (Harman) - Defense Reinvestment and High-Tech Job Creation

- ▶ Amends the Internal Revenue Code to allow a tax credit for defense conversion equal to the defense conversion employment credit (10% of wages paid by an employer) and the defense conversion investment credit (applicable percentage of a qualified business investment).
- ▶ Makes qualified excess defense conversion property eligible for the straight-line depreciation method and classifies it as five-year depreciable property. (Referred to House Committee on Ways and Means on 05/11/93. No action scheduled as of 09/24/93.)

H.R. 2200 (Brown) - National Aeronautics and Space Administration Authorization Act

- ▶ Authorizes appropriations to the National Aeronautics and Space Administration for research and development, space flight, control, and data communications, construction of facilities, research and program management, and inspector general, and for other purposes. (Received in the Senate, after passage in the House. Referred to Senate Committee on Commerce, Science, and Transportation. Expected to reach the full Senate in the fall.)

H.R. 2237 (Boehlert) - Defense Base Closure and Realignment Act Amendment

- ▶ Amends the Defense Base Closure and Realignment Act of 1990 to require that testimony before the Defense Base Closure and Realignment Commission be given under oath. (Referred to House Committee on Armed Services. No action scheduled as of 10/13/93.)

H.R. 2306 (Condit) - Using Military Bases as Prison Facilities

- ▶ Provides for federal incarceration of undocumented criminal aliens and the transfer of closed military bases to the Justice Department for use as prison facilities for the incarceration of criminal aliens. (Referred to House committees on Judiciary and Armed Services. No action scheduled as of 10/13/93.)

H.R. 2392 (Zeliff) - Investment Tax Credit

- ▶ Amends the Internal Revenue Code of 1986 to reinstate a 5% investment tax credit, to reduce capital gains taxes, to provide certain tax incentives for investments on closed defense bases, and to provide for the use of certain defense funds for the provision of

services to certain displaced defense workers receiving assistance under the Job Training Partnership Act. (Referred to House committees on Ways and Means, Education and Labor, and Armed Services. No action scheduled as of 10/13/93.)

H.R. 2401 (Dellums) - National Defense Authorization Act of 1994, Defense Conversion, Reinvestment, and Transition Assistance Amendments of 1993, National Shipbuilding and Shipyard Conversion Act of 1993 . . .

- ▶ Authorizes appropriations for fiscal year 1994 for military activities of the Department of Defense, for military construction, and for defense programs of the Department of Defense to prescribe personnel strengths and for other purposes. (Returned to the House from the Senate, with Senate amendments, as of 10/07/93.)

H.R. 2442 (Wise) - Economic Development Administration Reauthorization Act of 1993

- ▶ Reauthorizes appropriations under the Public Works and Economic Development Act of 1965, as amended, to revise administrative provisions of the Act to improve the authority of the Secretary of Commerce to administer grant programs, and for other purposes. (House Public Works and Transportation Committee will consider bill in early October.)

H.R. 2453 (Machtley) - Internal Revenue Code Amendment of 1986 Amendment

- ▶ Amends the Internal Revenue of 1986 to provide tax incentives to encourage the conversion of the defense industry to commercial endeavors, and for other purposes. (Referred to House Committee on Ways and Means on 06/17/93. No action scheduled as of 09/24/93.)

H.R. 2474 (Horn) - Training of Defense Personnel in Law Enforcement

- ▶ Amends Title 10, United States Code, to establish a program to assist members of the Armed Forces who are involuntarily separated from active duty to obtain training and employment as law enforcement officers. (Parts of this measure incorporated into H.R. 2401. No action scheduled as of 10/13/93.)

H.R. 2498 (Goodling) - Defense Diversification and Community Adjustment Act of 1993

- ▶ Seeks to assist community, business, and worker readjustment required as a result of the closure of military installations and reductions in defense spending, and other purposes.
- ▶ Establishes a new Assistant Secretary for Economic Adjustment within the Department of Defense. (Referred to various House Committees. No action scheduled as of 09/34/93.)

H.R. 2547 (Studds) - National Shipbuilding and Conversion Act of 1993

- ▶ Seeks to improve the economy of the United States (U.S.) and promote the national security interests of the U.S. by establishing a National Shipbuilding Initiative to provide support for the U.S. shipbuilding industry in order to assist that industry in regaining a significant share of the world commercial shipbuilding market, and other purposes. (Portions of the package are under consideration by the House Committees on Armed Services and Ways and Means.)

H.R. 2560 (Fazio) - Demonstration of Electric Vehicles and Infrastructure Development

- ▶ Establishes a program in the Department of Defense to promote and demonstrate electric vehicles and infrastructure development for military and civilian use. (Referred to House committees on Armed Services and Science, Space and Technology. No action scheduled as of 10/13/93.)

H.R. 2719 (Fazio) -Independent Site Manager at Military Bases

- ▶ Provides for the use of an independent site manager, selected by the Secretary of Defense in consultation with local governments and residents of communities adversely affected by base closures, to perform management functions in connection with the closure or realignment of military installations. (Referred to House Committee on Armed Services. No action scheduled as of 10/13/93.)

H.R. 2791 (Stupak) - Economic Recovery and Adjustment Grants

- ▶ Establishes a grant program to return a portion of the savings realized by the Department of Defense as a result of the closure or realignment of a military installation to the communities in which the installation is located to assist in the economic recovery and adjustment of these communities. (Referred to House Committee on Armed Services. No action scheduled as of 10/13/93.)

H.R. 2825 (Conyers) - Training for Future Jobs Act of 1993

- ▶ Seeks to demonstrate the economy and efficiency of centralizing federal job training programs. Establishes a Job Training Council to provide grants to nonprofit organizations for retraining displaced workers and nonprofit education telecommunications organizations to pay the federal share of the cost of telecommunications materials and services for use in local vocational and technical education schools and colleges. (Referred to House Committee on Education and Labor on 08/02/93. No action scheduled as of 09/24/93.)

H.R. 2831 (Schenk) - Economic Conversion Clearinghouse Act

- ▶ Establishes the Office of Economic Conversion Information within the Department of Commerce, and other purposes. (Joint referral to House Committees on Energy and Commerce and Armed Services 08/02/93. No action scheduled as of 09/24/93.)

H.R. 2962 (Lantos) - Early Retirement Reduction Provisions for Military

- ▶ Amends Title 5, United States Code, to modify the early retirement reduction provisions with respect to certain federal employees who are separated from service due to a base closure under Title II of the Defense Authorization Amendments and Base Closure and Realignment Act, and other purposes. (Referred to House Committee on Post Office and Civil Service. No action scheduled as of 10/13/93.)

STATE LEGISLATION

BILLS RELATED TO SELECTED DEFENSE CONVERSION 1993

AB 1X - Economic Development Centers: Military Bases (Chapter 1, Statutes of 1993)

- ▶ Allows previously approved incentives to be used to attract a federal Department of Defense Finance and Accounting Service Center at the existing site of Norton Air Force Base in San Bernardino; and
- ▶ Appropriates \$1.5 million from the Federal Trust Fund to the Trade and Commerce Agency for allocation to the Inland Valley Development Agency to rehabilitate facilities to be used by the Defense Finance and Accounting Service Center if housed at Norton Air Force Base.

AB 564 - California Trade Advanced Transportation Industry Interagency Consortium (Vetoed by Governor)

- ▶ Would have required the Trade and Commerce Agency, in collaboration with the California Energy Commission and Business, Transportation and Housing Agency, to establish and maintain until January 1, 1997, a California Advanced Transportation Industry Inter- agency Consortium with specified objectives and functions; and
- ▶ Would have required the Consortium to declare the Legislature's intent to fund the consortium through available funds.

AB 648 - New Business Incubator Enterprise Program (Chapter 442, Statutes of 1993)

- ▶ Enacts the program to be administered by the Small Business Development Board, and requires the board to determine those enterprises that would be qualified to be New Business Incubator Enterprises.

AB 693 - Local Military Base Recovery Area Act (Chapter 1216, Statutes of 1993)

- ▶ Allows for designated local agency military base recovery areas (LAMBRA) to receive regulatory, tax, and other governmental program incentives to offset losses resulting from federal military base closure;
- ▶ Allows the Trade and Commerce Agency to designate not more than one area in a region as a LAMBRA; and
- ▶ Provides specified tax credits for a variety of activities and services performed in a LAMBRA.

AB 1023 - Redevelopment: Norton Air Force Base (Chapter 968, Statutes of 1993)

- ▶ Requires the joint powers agency operating within the area of Norton Air Force Base to appoint a project area citizens' committee for the purpose of consultation and advice regarding base planning policy.

AB 1246 - Office of Strategic Technology (Chapter 446, Statutes of 1993)

- ▶ Initiates the Office of Strategic Technology as the lead agency for management, administration, and evaluation of technology development and commercialization programs; and
- ▶ Establishes within the Trade and Commerce Agency the Technology Planning Program and Challenge Grant Program, which provides grants and technical assistance to California nonprofit organizations and public agencies.

AB 1366 - Aerospace Manufacturing Technology Transfer Pilot Program (Vetoed by Governor)

- ▶ Would have established the Aerospace Manufacturing Technology Transfer Pilot Program in the Trade and Commerce Agency (TCA);
- ▶ Would have prescribed program goals and responsibilities; and
- ▶ Would have required a biennial report from TCA to the Legislature.

AB 1732 (Chapter 1153, Statutes of 1993)

- ▶ Provides for the Secretary of Trade and Commerce to serve on specified boards, committees, and commissions.

AB 2072 - Enterprise Zones: Military Bases (Chapter 1276, Statutes of 1993)

- ▶ Permits the Public Utilities Commission to allow public utilities to provide utility service at whatever discounted rate is available in enterprise zones to facilities located on federal military bases scheduled for closure.

AB 2222 - California Defense Conversion Act of 1993 (Chapter 444, Statutes of 1993)

- ▶ Creates the California Defense Conversion Council in the Trade and Commerce Agency with prescribed membership, powers, and duties.

AJR 13 - Relative to Los Angeles Air Force Base (Res. Chapter 5, Statutes of 1993)

- ▶ Urges the President and Congress to keep Los Angeles Air Force Base off the planned base closure lists for 1993 and 1995.

AJR 15 - Relative to March Air Force Base (Res. Chapter 6, Statutes of 1993)

- ▶ Urges the President and Congress to retain March Air Force Base as a fully-operational active duty military base.

AJR 22 - Relative to Long Beach Naval Base (Res. Chapter 37, Statutes of 1993)

- ▶ Urges the President and Congress to provide for the continued operation of the Long Beach Naval Base.

AJR 23 - Relative to California Military Bases (Res. Chapter 7, Statutes of 1993)

- ▶ Urges the President and Congress to review and revise the list by the Department of Defense of proposed military base closures, and to reconsider base closures in California and delay official release of the proposed closure list for 30 days beyond March 15, 1993.

AJR 29 - Relative to the National Training Center (Res. Chapter 91, Statutes of 1993)

- ▶ Asks the Base Realignment and Closure Commission, the President, and Congress to support and endorse the Silurian Valley (east of Fort Irwin, San Bernardino County) plan as the most progressive effort to meet the objective of providing for the national defense while maintaining high standards of environmental stewardship.

AJR 31 - Relative to Norton Air Force Base (Res. Chapter 62, Statutes of 1993)

- ▶ Urges the President and Congress to provide a grant of \$4.95 million as part of the 1993 funds for the facility at Norton AFB for its first aeronautics program.

AJR 53 - Relative to Norton Air Force Base (Res. Chapter 122, Statutes of 1993)

- ▶ Urges the President, Congress, and Secretary of the Department of Defense to designate the Norton Air Force Base as a location for a Defense Finance and Accounting Service Center.

SB 1X - State Representative: Base Closure (Chapter 3, Statutes of 1993)

- ▶ Requires the Governor to appoint a representative to Washington, D.C., to identify defense conversion revenue sources available to the state; and
- ▶ Requires the representative to provide an annual report to the Legislature.

SB 2X - Economic Development (Chapter 2, Statutes of 1993)

- ▶ Allows the Employment Training Panel to allocate up to \$10 million to fund special employment training agreements in response to the establishment of a federal Defense Finance and Accounting Services facility at Norton Air Force Base.

SB 268 - Economic Conversion (Chapter 441, Statutes of 1993)

- ▶ Establishes the Defense Conversion Matching Grant Program using \$4 million from the Petroleum Violation Escrow Account to the extent permitted by federal law;
- ▶ Transfers \$1.5 million of those funds to the Trade and Commerce Agency after February 1, 1994; and
- ▶ Requires the Office of Strategic Technology and regional technology alliances to evaluate and rank competitive defense conversion proposals for state financial assistance.

SB 458 - Defense Industry Conversion (Chapter 445, Statutes of 1993)

See AB 2222

SB 748 - Economic Development Policy: Allocation of Funds (Chapter 839, Statutes of 1993)

- ▶ Requires the California Export Finance Office to seek federal matching funds and make quarterly reports on project selection; and

- ▶ Requires unanimous approval of a three-person committee for financing assistance on defense conversion projects.

SB 898 - Public Utilities: Economic Development (Chapter 264, Statutes of 1993)

- ▶ Allows the Public Utilities Commission to provide incentives to industries and businesses located within the boundaries of an enterprise zone that engage in activities in connection with the conversion of Fort Ord to other uses.

SB 915 - Military Base Closure Redevelopment (Chapter 944, Statutes of 1993)

- ▶ Adds to the Community Redevelopment Law provisions governing the establishment and fiscal affairs of redevelopment agencies based in areas within a military base scheduled for closure by the Base Closure Commission, and adds to the Community Redevelopment Law provisions establishing a Mather Air Force Base Redevelopment Project Area.

SJR 2 - Relative to the United States Base Closure Commission (Res. Chapter 2, Statutes of 1993)

- ▶ Asks the President to appoint, on or before January 25, 1993, new members to the Base Closure Commission who represent California and ensure that California is adequately represented on the Base Closure Commission.

SJR 9 - Relative to California Military Bases (Res. Chapter 10, Statutes of 1993)

- ▶ Asks the President and the Secretary of Defense to postpone closure of any additional California military bases until the full impact of the economic upheaval can be assessed.

SJR 14 - Relative to the Alameda Naval Air Station (Res. Chapter 30, Statutes of 1993)

- ▶ Requests that the Senate Armed Services Committee and the House Armed Services Committee of Congress each hold a hearing on the subject of the military viability of closing Alameda Naval Air Station and constructing a new facility in Everett, Washington.

SJR 15 - Relative to Mare Island Naval Shipyard (Res. Chapter 44, Statutes of 1993)

- ▶ Asks the President to return for reconsideration or reject recommendations from the Base Closure Commission that Mare Island Naval Shipyard be closed.

SJR 24 - Relative to Proposed Veterans Administration Hospital at Travis Air Force Base (Res. Chapter 72, Statutes of 1993)

- ▶ Asks the Secretary of the Department of Veterans Affairs and Congress to approve funding for the construction of the Veterans Administration Hospital at Travis Air Force Base.

SJR 27 - Relative to Mare Island Naval Shipyard (Res. Chapter 101, Statutes of 1993)

- ▶ Asks the President, Congress, and Secretary of the Department of Defense to designate Mare Island Naval Shipyard as a location for a Defense Finance and Accounting Service Center.

Senate Resolution 11 - Relative to Mare Island Naval Shipyard (Adopted 02/25/93)

- ▶ Asks the Secretary of Defense not to include Mare Island Naval Shipyard in the March 15, 1993, list of military bases recommended to the Base Closure Commission for closure.
