

Assembly Bill 314 (Moore)

DESCRIPTION

This bill requires telephone corporations, when offering "Caller ID" services, to permit residential customers to withhold the display of their telephone number on a blanket, or per line, basis without being charged. The bill also requires telephone corporations offering caller ID to also offer, when feasible, a service which permits a called party to automatically reject calls from certain numbers. Finally, this bill requires telephone corporations to notify customers annually that use the "800" or "900" services may result in the disclosure of the customer's telephone numbers.



Assembly Bill 406 (Katz)

DESCRIPTION

This bill requires moneys deposited with gas and electric utilities by their customers that go unclaimed for more than three years to be collected by the state (in the same manner as unclaimed property is currently collected by the state) and allocated to the Low Income Energy Assistance Fund (LIEAF) which the bill rates. The moneys deposited in the LIEAF are continuously appropriated to the Controller who is directed to disburse 75% of the funds to the Low Income Home Energy Assistance Program (LIHEAP) and 25% to the Energy Crisis Intervention Program (ECIP), both of which are administered by the Department of Economic Opportunity.

FISCAL EFFECT

A continuous appropriation of approximately \$4 billion annually from the LEAF to fund low-income energy assistance program. A loss of up to \$4 million beginning in 1997 to the General Fund form reducing the amount of funds deposited in the Unclaimed Property Fund (UPF), thus available for transfer to the General Fund (if unclaimed after five years.)

The CPUC will not approve issuance or transfer of motor carrier operating authority to any person, firm or corporation with a outstanding liability to the Uninsured Employer's Fund.

Assembly Bill 486 (Polanco)

DESCRIPTION

This bill: (1) Requires the Department of Transportation (DOT) to certify socially and economically disadvantaged businesses for the purposes of contracts that are fully or partially funded by the federal government, and are administered or authorized by the United States Department of Transportation. Requires the Office of Small and Minority Business (OSMB) to certify all (2) qualified minority and women business enterprises and disabled veterans' business enterprises and authorize local agencies to accept the certification of SMB as valid when awarding contracts to a minority and women business enterprise or a disabled veterans' enterprise. (3) Provides the OSMB the sole responsibility to certify minority business enterprises and women business enterprises for the purpose fo statewide participation goals and require the OSMB to accept certification by the DOT and California Public Utilities Commission (CPUC) as specified. 4) Requires DOT to provide the certified contractor information to the OSMB. (5) Requires the Department of General Services (DGS) to establish a computerized data bank containing a list of small, minority, and women business enterprises or disabled veterans' enterprises, to be administered by OSMB and requires that the data bank be accessible to all state departments for use in contracting on or before January 1, 1993. (6) Provides that it mandate provisions become operative on the effective date of the bill.

DESCRIPTION

This bill makes legislative findings that the Department of General Services (DGS) has a conflict of interest between its role as a provider of telecommunications services through CALNET and its role in acquiring the costeffective goods and services for the state. Consequently, this bill:

- Requires DGS, in circumstances where it is providing computer or telecommunications services through CALNET in competition with private sector vendors, to adopt procedures to treat itself as it would any other vendor.
- 2) Requires the Department of Finance (DOF) to conduct a study, as specified, on the impact of the CALNET/CALDEX procedures on state operations and on private sector telecommunications providers. This study is due by July 1, 1992.
- 3) Prohibits the DGS from (a) committing any funds for further CALNET/ CALDEX modernization or expansion, and (b) provide CALNET/CALDEX network services to any non-state or public entities other than those already using the network on January 1, 1992, until the results of the study have been reviewed.

FISCAL EFFECT

One-time costs to the Department of Finance of \$100,000 for the specified study. In addition, the Legislative Analyst indicates ongoing costs of up to \$420,000 to the Service Revolving Fund (General Fund and various special funds) to ensure that the DGS is treated the same as private vendors, as specified.



Assembly Bill 549 (Moore)

DESCRIPTION

This bill abolishes the State Office of Information Practices (OIP) within the State Personnel Board and transfers its responsibilities to the State Office of Information Technology (OIT) within the Department of Finance.
