PREFACE

The United States Court of Appeals for the Ninth Circuit is the largest court of appeals in the country and issues decisions that affect the lives of fifty-four million people living in nine different states.¹ The Ninth Circuit encompasses fifteen judicial districts² and handles around 20 percent of the federal case load.³ The court establishes influential precedent for a large portion of the United States, and has consistently impacted legal trends throughout the United States.

The Ninth Circuit judges are presented with challenging caseloads, both in quantity and subject matter, which are the result of an immense number of appeals filed each year.⁴ Decisions by the Ninth Circuit often concern controversial legal issues, thrust onto the national stage as they are ripe for consideration by the United States Supreme Court. With many innovative technology companies calling the Ninth Circuit home, some of the most significant cases addressing copyright, trademark, trade secrets, privacy, and other related legal issues are heard in the Ninth Circuit. In her introduction to this issue, Ninth Circuit Judge M. Margaret McKeown discusses the Ninth Circuit's role in dealing with evolving technology and how that challenges existing law.

We are pleased to present this year's *GGU Law Review Ninth Circuit Survey*, the nation's only law review edition devoted exclusively to the decisions of the Ninth Circuit.
