TABLE OF LAW SCHOOL MISSION STATEMENTS

About this chart: To identify whether a school had a mission statement and, if so, what it encompassed, we largely followed the process described by Professor Organ in Missing Missions: Further Reflections on Institutional Pluralism (or its Absence), 60 J. LEGAL EDUC. 157, 160-161 (2010):

"The search process involved several steps. We checked the law school webpage to see if it had a link to "Mission." We checked the "About" link to see if the description of the law school referenced the school's mission. We checked the "Dean's Message" or the "Dean's Welcome" to try to identify all law schools that clearly highlighted a mission statement. We checked the "Academics" page and the "Admissions" page. We also used the search link on the school's webpage entering the words "mission" and "strategic plan." While many law schools have a "mission" that is clearly defined as a "mission" or "vision," others were less explicit, but nonetheless described the school's "aims" or "purpose" or "commitment," which we deemed sufficient to qualify as a mission statement. A mere description of the law school or what the law school does or is or what the law school provides students was deemed insufficient to constitute a mission." (footnotes omitted)

Not only is the Campbell program academically challenging, but it also provides students with comprehensive skills training in planning, counseling, negotiation, legal drafting, trial and appellate advocacy, and alternative forms of dispute resolution. No law school in North Carolina has had greater success in preparing its students for the bar examination and few schools in the United States or elsewhere can equal Campbell's effectiveness in providing students with practical skills.

A faculty committed to students and teaching

The faculty of the School of Law is a community of scholars who make teaching their priority and are readily accessible to students. They devote substantial time to serving students as mentors, coaches, and professional role models. prepare our students to practice, in the words of our motto, "Law in the Service of Human Needs." Our curriculum requires all third-year students to represent actual clients in such fields as immigration law, elder law, human rights law and more. CUNY is a national leader in progressive legal education. In the spring of 2007, the Carnegie Foundation for the Advancement of Teaching, in a national study of legal education, lauded CUNY School of Law's innovative curriculum, which has become a model for law schools across the nation.

Traditional Doctrinal Study

The basic premise of the Law School's program is that theory cannot be separated from practice, abstract knowledge of doctrine from practical skill, and understanding the professional role from professional experience. Our curriculum integrates practical experience, professional responsibility, and lawyering skills with doctrinal study at every level. Forming the core of our lawyering curriculum are the skills recognized by the profession as essential to successful law practice: problem solving, legal analysis and reasoning, legal research, factual investigation, communication (legal writing, oral argument), counseling, negotiation, litigation and alternative dispute-resolution, organization and management of legal work, and recognizing and resolving ethical dilemmas.

The Role of Clinical Education

Layered onto the traditional foundation of doctrinal education is our deep and broad clinical training program. First-year students acquire clinical experience through simulation exercises conducted in a required year-long lawyering seminar; second-year students take an advanced one-semester lawyering seminar in a public interest law area of their choice; third-year students earn 12-16 credits in either a field placement program or a live-client clinic onsite at the Law School. Our curriculum rejects the traditional separation of substantive law courses into narrowly defined subjects. Precisely because attorneys are seldom presented with legal problems neatly compartmentalized into analytically distinct subject headings, our curriculum teaches students to think critically about subject matter, rule application and procedures and to synthesize these aspects critically. Thus, our graduates are able to address the many-sided problems that confront attorneys and their clients in real life.

Student-to-Student Collaboration

Because collaboration is both an important practical skill and a valuable learning mode, the Law School encourages students to work together and provides opportunities and frameworks for them to develop collaborative skills and practices. This approach alters the conventional hierarchical structure and atmosphere of most legal education. Students collaborate in virtually all of their work, so the cutthroat competition at most law schools is absent at CUNY Law. Our small size and 12 to1 student-faculty ratio foster a supportive learning environment designed to maximize individual and professional development. Because examination should be the servant, not the master of learning, many courses rely upon writing exercises and simulation work to evaluate student performance and progress.

Strategic Mission of the School of Law

George Mason University School of Law will seek to be a national leader in legal education by applying the tools of economics and other social sciences to the study of legal doctrine, process, and institutions. The law school will foster a community of faculty and students which is both learned and worldly, with the aim of producing the leaders of bench, bar, business, government, education and scholarship in service of the public good. George Mason has already established itself as a strong and innovative voice in legal education. It has not sought to position itself across the wide spectrum of legal methodologies and subject matters to be found in law schools nationally, but has focused on doing fewer things well and building systematically on its competitive advantages. It will continue to adhere to this template in order to consolidate its position as a formidable institution of professional education.

Goals

The Law School has three outstanding competitive advantages with which to drive its goals. First, and foremost, it profits from having a culture of intellectual seriousness, which affects the work of students and faculty alike. Second, the school's location makes it a magnet for professors and students whose professional plans entwine with activities specific to the national capital. Third, the university has an internationally visible Department of Economics, which is growing both in prominence and aspiration, much of whose work is germane to the domain of law and public policy.

To accomplish the Law School's Goals, it must:

Attract High Quality Students, and Train them Rigorously: The quality of a law school depends first of all on the caliber of its students. The law school has enrolled a student body which is among the strongest nationally. The most recent entering class was drawn from over 89 undergraduate institutions, and close to 46% are from out-of-state. The law school seeks to enroll increasingly promising classes of students and to prepare them, with superior instruction strongly inflected with the Law & Economics approach to legal studies, for professional careers in the national capital region, where the great majority of them – from wherever they come – remain to practice. Mason Law students have routinely outperformed the state average on bar passage. In July 2013, the all-schools average Virginia State Bar pass rate for first-time takers was 79.54%, while the George Mason bar pass rate for first-time takers was 93.37%, highest of any law school in the Commonwealth.

Maintain High Standards for Its Faculty: The law school faculty has consistently been among the most professionally influential of any in the country as measured by Social Science Research Network downloads and by scholarly reputation (faculty ranks 21st in "scholarly")

impact" based on citations per capita between 2007 and 2011 [Leiter, 2012]; 24th in median per capita citations (ibid.); 26th in "reputation" as rated by other academics [Leiter, 2003]; ranked 18th of 350 law faculties in Social Science Research Network downloads of faculty research papers [October 2013]). It will be necessary to insist that colleagues continue if not improve the productivity that generates so much favorable notice. Similarly, the part-time (adjunct) faculty, drawn from one of the deepest talent pools in the country, must continue to reflect the high ambitions of the school's instructional program.

Retain Focus on the Study of Law & Economics: The law school's heritage as a "law & economics" law school is a competitive advantage in its own right because it is a recognizable and recognized brand. But beyond that advantage, there is a widely shared sense that the analytic rigor of the law & economics approach offers students superior preparation for legal careers. Furthermore, it furnishes the faculty with a common culture and frame of reference in which to structure appointments priorities and curriculum. It has been a decade since Brian Leiter ascertained (by polling law professors) that George Mason's faculty deserved to be ranked 9th in the entire country in Law & Economics. The school's concentration on the value of public choice theory, game theory, microeconomic theory, and statistical and quantitative methods in analyzing and understanding the law has only grown stronger since then. The Law & Economics Center (LEC), currently a \$5+ million per year operation, runs instructional programs for state and federal judges (to date, over 4000 sitting federal and state court judges from all 50 states have taken LEC judicial education programs), for state attorney generals' staffs, and for law professors; sponsors several colloquia per year for work-shopping the scholarship of young law professors from universities and law schools across the country, sponsors large-scale empirical research pro bono publico, and produces empirical policy advice and research for the bipartisan Civil Justice Reform caucus of the U.S. House of Representatives.

Develop Additional Related Areas of Concentration and Intellectual Leadership: George Mason has supplemented its core competencies in law & economics by giving increased attention to other areas of interdisciplinary study such as intellectual property, legal history and constitutional studies. The law faculty has several prominent legal historians and constitutional scholars, whose work complements the instructional program and addresses matters of student interest and particular relevance to the local market. In October of 2012, the School of Law started the Center for the Protection of Intellectual Property to explore the utility of traditional conceptions of property to the creation of res novae and their potential contributions to the innovative capacity of the national economy.

Concentrate Educational Offerings on Matters Particularly Relevant to the Local Market: The law school must exploit its natural geographic advantages in order prepare students for the highly competitive DC-area legal market. In addition to Intellectual Property and constitutional/historical studies, the school will consider increasing its offerings on Immigration Law (of increasing interest to students and highly germane to a metropolitan area with very large immigrant populations) and Homeland Security Law. The school has created a new National Security Law Journal and has expanded the services provided by the law school's Clinic for Legal Assistance to Servicemembers and Veterans. Emphasize Legal Research and Writing: The skill that members of the bar say that they most often find deficient in new law graduates is legal writing. George Mason has responded to this concern by requiring four semesters (not only two, as in most other law programs) of legal research, writing, and analysis, as well as a senior writing requirement. Law school graduates, we know, follow many different career paths, and for that matter many different careers which in some cases are quite remote from traditional law practice, but a common thread for virtually all is mastery, not mere proficiency, in producing complex written narrative. Because clear writing aids, and is in turn aided by, analysis, and because it is something close to a universal tool in a law graduate's professional toolkit, legal writing will continue to be emphasized in the instructional program. These challenges notwithstanding, I believe that pursuing a law degree has tremendous value. Critical and creative thinking, innovative problem solving, and a deep appreciation of professionalism remain fundamental skills needed by graduates to succeed—skills that are uniquely honed at GW Law through strong academics, innovative programming, and a strong commitment to diversity. A robust pedagogy that demonstrates the intersection between scholarship, doctrine, and practice is at the core of the GW Law experience. Helping to develop our students into lawyers is a faculty that reflects these ideals. In addition to publishing widely cited books and articles, our professors are often involved in litigation before the U.S. Supreme Court, international tribunals, and other courts. They also provide commentary to the news media, testify on Capitol Hill, serve as consultants to various governments, and pursue many other activities that enrich the academic life of the school. Preparing Students for the Legal Profession

Excellence in teaching is our first priority. Our goal is to provide our students with an intellectually rigorous academic experience that emphasizes critical thinking, effective problem-solving and experiential learning. To assure that our students are prepared to be effective and creative lawyers who are ready to start practice upon graduation, we integrate instruction in practical lawyering skills and encourage our students to avail themselves of our vigorous clinical, externship and lawyering programs. By offering comprehensive instruction in legal ethics, the College also helps our students understand their professional and civic responsibilities.

Pursuing Scholarship

One of the most important functions of the College is to advance academic discourse in the law and other disciplines. As a community of scholars, our faculty and students explore, discuss and disseminate new ideas about the ways in which law functions in our dynamic society. Members of the faculty are committed to engage in an active program of research and scholarly publication to broaden their academic skills and knowledge and to enhance the reputation of the College. The College also provides students with opportunities to contribute to scholarly discussion, through membership in the Law Review, participation in seminars, collaboration with professors as research assistants, and various extracurricular activities.

Providing Access for Historically Underrepresented Groups

The cornerstones that provide the foundation for Chicago's educational mission are the life of the mind, participatory learning, interdisciplinary inquiry, and an education for generalists. What sets Chicago apart from other law schools is its unabashed enthusiasm for the life of the mind — the conviction that ideas matter, that they are worth discussing, and that legal education should devote itself to learning for learning's sake. Learning the law at Chicago therefore is a passionate — even intense — venture between and among faculty and students. It begins in the classroom where students share the stage with the professor. The professor does not lecture, but instead engages the group in a dialogue. Known as the Socratic Method, this dialogue presents students with questions about thorny legal concepts and principles. Chicago remains committed to legal education as an education for generalists, although students with particular interests will find it possible to study topics in depth through advanced and more specialized courses. Emphasizing the acquisition of broad and basic knowledge of law, an understanding of the functioning of the legal system, and the development of analytic abilities of the highest order, a Chicago legal education prepares students for any professional role they might choose – legal practice or legal education, entrepreneurial ventures, international private or public law practice, corporate practice, government service, alternative dispute resolution including arbitration and mediation, or work with non-profit organizations. Graduates do many things in their careers, and they all take with them the analytic skills emphasized during their years at the Law School.

To this end, the School of Law offers a broad curriculum and complementary extracurricular activities designed to teach students both the general principles of law and the basic skills needed for a successful practice in a changing legal environment. The faculty employs both traditional and innovative methods of classroom instruction, provides skills training in a variety of clinical and simulated settings, and serves as advisors and mentors to students and student groups outside of the classroom. Throughout the educational process, the faculty strives to establish a climate of professionalism and open inquiry and to instill in its students a pride in legal craftsmanship, a sound sense of ethics and professionalism, an appreciation for the role of law and of the practice of law in society, and a commitment to public service. The School of Law also extends its teaching mission to other audiences by providing continuing legal education programs for the bench and bar, lending legal expertise to legislators and other government policy makers, contributing to academic discussions at other law schools or in other disciplines, and helping the general public to gain a better understanding of law and legal institutions.
