SOMMAIRE — *Plusieurs sujets de nationalité étrangère ou expatriés ne pouvant aller au Noviciat de Grignon (Orly) il a paru nécessaire d'ériger un autre. — On demande à la Propagande qu'il fût établi à Sintra. — Le Saint-Siège a daigné accueillir favorablement cette demande.*
