# **Major Accomplishments**

The past year has been one of significant accomplishment for the College of Law, its faculty and students. Although notable accomplishments were achieved in many areas across the law school, including supporting greater faculty research and scholarly activities, increasing community outreach and public service, enhancing international relationships, and integrating technology into all aspects of academic endeavors, the major accomplishment for the College of Law for the 1999-2000 year was the completion of a self study by the faculty during the fall semester and the site evaluation visit of an accreditation team from the American Bar Association and the Association of American Law School during the spring.

# Self-Study and Accreditation Examination

The accrediting bodies of the Georgia State University College of Law are the American Bar Association and the Association of American Law Schools. These entities use a seven year cycle of accreditation and reexamination and coordinate their reviews so that a single unified inspection team visits the campus. In preparation for the site evaluation team, the college faculty undertook an extensive self study during the fall semester. This self examination reviewed all aspects of the law school and included student surveys and similar contributions from alumni and members of the bench and bar. The faculty was pleased with the final report, which will be used as a basis for the updating of the College's strategic plan during the upcoming year. The self-study and the site evaluation visit will be used as part of the University's academic program review.

The site evaluation team visited the campus in the spring. The initial reports from the ABA team and the AALS representative have been received by the College of Law and the University. The College has replied to these reports. Both reports give praise to many aspects of the College of Law's program. As expected, there are some areas of concern, but the College's academic programs were not found to be out of compliance with any of the ABA standards.

# **Technology**

Georgia State University College of Law continues to enjoy a national reputation for its technological innovations. Recognitions in the past, like the ranking of the College of Law by National Jurist magazine as among the top 25 wired law schools, continued with the invitation to Patrick Wiseman to make a presentation at the annual Computer Assisted Legal Instruction Conference, a national meeting at which the latest and most innovative technology is showcased each year. Professor Wiseman was honored again by his selection as the first recipient of the Tom Creed Compassionate Pioneer Award by the Teaching, Learning, and Technology Affiliate of the American Association of Higher Education, a national organization that promotes the use of technology in education.

The technical upgrades for the College's courtroom, cited in last year's report, were

enhanced during the 1999-2000 year by the installation of additional and more sophisticated equipment in the courtroom itself and in the adjacent media control room. This enhancement was part of a complete renovation of the interior of the courtroom through the generosity of the Atlanta Law School Foundation.

In the spring of 2000 at the conclusion of **final** exams, contractors began the demolition of Lecture Hall 100 in preparation of a complete renovation to be completed by the beginning of the fall term. In this renovation new tables and seating will provide electricity and network data ports at each student work station. This is the second of a four part project to provide data line access to all student work stations in the four large tiered classrooms that are the core of the College's instructional facilities.

The College of Law's web pages continue to be a valuable instrument in communication with the public and for the internal benefit of the faculty, staff, and students. Once again inquiries of incoming first year students showed a vast majority reviewed the college's web pages during their deliberations as to which law school to attend. More students each year utilize the online application process. Once admitted the students access the web for the college's bulletin, curriculum planning guide, information about the faculty, course descriptions, syllabi, class assignments, on-line class discussions, and notices of upcoming law school events. Later in their program at Georgia State they will take advantage of the on-line placement bulletin. The electronic reserve system has been a big success for the Law Library. Course materials placed on reserve by faculty for students in their courses are available online for students to download electronically.

The College added to its web site an extensive section on the Georgia State University Tax Clinic. The site contains an online library of Internal Revenue Service publications, notices, and forms. The **tax** clinic's operational manual was put on line, creating a lot of attention from other **tax** clinics in the country who downloaded it from the web site. By use of security passwords, students enrolled in the clinic can use the web to track their cases and to add and extract information **from** their files. Web based materials were also developed for our summer skills program.

This past year saw a renewal of a contractual relationship among the Georgia State University College of Law, the Digital Commerce Center of the Robinson College of Business and the Georgia Courts Automation Commission for the development of a pilot project on the electronic filing of court documents. A graduate of the law school continues to serve as principal staff for this exciting project, which will ultimately alter forever the processing of documents in the legal system in Georgia.

With increasing needs for technological support, the College took steps this past year to increase the staff support available to maintain its network and web site and to help faculty, staff, and students in the use of technology. Responding to a staff resignation, the College recruited and hired a new Director of Administrative Services, a position that is responsible for computer

support services among many other duties. The new director possesses a degree in computer information systems and is the first person with such credentials to hold this position. In a similar fashion the College has undertaken the retraining of a staff member who assists with facilities and audio-visual equipment. With the latter utilizing more computer based technology, the AV assistant has trained to serve such equipment as well service computer peripherals.

# <u>International relationships</u>

Linz, Austria has been the long-time site of the College of Law's foreign summer program headed by Professor E. R. Lanier. Professor Lanier conducted another successful session during the summer with students and faculty studying international commercial arbitration. Originally an Austrian program, over the years the program has grown to one that visits the major arbitration courts in Central Europe. During the upcoming year, Professor Lanier and the College's administration will determine whether to relocate the program to another location, such as Vienna, Budapest, Prague, or Warsaw.

Relationships that have grown out of this summer program continue to provide benefit to the College of Law. The College had two visitors associated with the program visit the Georgia State University campus this past fall. Professor Hans **Dolinar** of the University of **Linz** visited for several weeks, guest teaching and visiting with students. Later in that same term the College hosted Dr. Marie-Beatrix Tupy, Secretary-General of the Vienna Arbitration Court.

A number of Austrian and German students were in residence at the College of Law this past year. The German students come for a semester to conduct legal research and complete an academic paper dealing with tax and financial institutions. This long-standing program is directed by Professor Ronald Blasi. Professor Lanier's program, which takes Americans to Austria, also has a corresponding student exchange where Austrian students come to Georgia State.

Professor Lanier was selected to participate in the 1999 University System of Georgia's international faculty development seminar in Mexico and the 2000 seminar in Panama. He also received a Global Partnership Grant from the Board of Regents to develop a summer academy for international commercial arbitration in collaboration with the Consortium on Negotiation and Conflict Resolution.

# Community outreach and public service

The Consortium on Negotiation and Conflict Resolution conducts research into the nature of conflict and the theories and principles of resolution while applying this knowledge in training and educating others in mediation and resolution. The consortium is an interdisciplinary and inter-university partnership that supports the Board of Regents' Initiative and Policy Direction on Conflict Resolution. This past year CNCR launched a conflict resolution program for the Atlanta Public Schools where students from Georgia State and other local universities are trained to teach

conflict resolution to students, administrators, teachers, and parents. CNCR is pleased with the initial year of operation and expects this program to be an immense benefit to the climate of the public schools involved. United States Attorney General Janet Reno praised the Conflict Resolution in Schools Program in a speech at the Association of American Law Schools annual meeting in January 2000. Besides support from the College of Law, the consortium has been the recipient of funding directly from the Board of Regents and from several outside funding agencies. During this last year the consortium held grants from Albany Law School and the Hewlett Foundation.

For the second year in a row, the Tax Clinic received a grant from the Internal Revenue Service to support the clinic's activities. The Georgia State University Tax Clinic serves low-income individuals who are involved with disputes with the Internal Revenue Service. Besides this public service, it is an important laboratory for the training of law students and graduate tax students from the College of Business Administration. More than 500 cases have been handled by students since the inception of the clinic, and it remains the only such entity in the southeast. Despite the adversarial role of the Georgia State Tax Clinic, the IRS respects the clinic for its success in providing equitable solutions for troubled taxpayers. In July of 1999, the Clinic was honored by a visit from U. S. Tax Commissioner Charles Rosetti.

The College of Law, together with Georgia State's Center for Digital Commerce, sponsors the Electronic Court Filing Project, a joint project to explore the automation of Georgia's courts through the electronic filing and signing of court documents. The project's research encompasses and impacts on the areas of digital signatures, electronic records and signature legislation, national legal and technical standards development, and courses at the College of Business in electronic commerce. The project received renewed funding from the Georgia Courts Automation Commission for 1999-2000 with implementation of the pilot project to commence in the fall of 2000.

The College of Law celebrated its third annual Law Week during the week of April 1-8, 2000. Law week is dedicated to increasing public understanding of and respect for the law, the legal process, and the role of the legal profession. With the theme, "Partnership Through Diversity, Celebrating our Community", this year's Law Week emphasized public service and the obligation of professionals to give back to their communities. Activities, which were sponsored by various student organizations under the coordination of the Law Student Bar Association, ranged from preparing meals for AIDS patients and a blood drive to panel discussions about hate crime legislation and pro bono work. Cathy Cox, Georgia's Secretary of State, gave the keynote speaker address, which highlighted the legal profession's community service as a vital resource.

Professor and former Dean Marjorie Girth served on the planning and implementation committees that successfully guided the transfer of the **Atlanta** Project from the Carter Center to Georgia State University. Started by President Jimmy Carter, the Atlanta Project is a neighborhood based effort to provide a single source for information and social services to economically depressed areas of the city utilizing the citizens of the community with the support

and assistance of outside resources. This year long transition involved the identification of expertise among university departments and the pairing of these resources with the organizational structure of the Atlanta Project.

Three law school faculty served as reporters to Georgia Code revision committees, charged with updating state laws. Contributing their time, effort, and scholarly expertise, Associate Dean Steve Kaminshine worked on labor law revisions, Professor Ellen Taylor assisted in rewriting sections dealing with investment advisors, and Professor Mary Radford participated in revisions of guardianship law.

Several faculty members served as amici curiae, experts invited to advise a court on a matter of law in a case to which they are not a party. Professor Ellen Podgor provided briefs in the Federal Courts for *United States* v. *Webster L. Hubbell* and *Cleveland* v. *United States*. Professor Ronald Blasi produced an amicus brief in *PNC Bancorp*, *Inc. v. Commissioner of Internal Revenue*. Professor Shubha Ghosh joined three law professors from other institutions to submit a brief of amici curiae in *Etkind* v. *Suarez* in the Supreme Court of Georgia. Professor Lynn Hogue submitted a brief in the case of *Gluzman v. United States of America* in the Supreme Court of the United States.

As part of the College's efforts in strengthening and increasing community outreach and public service, law faculty serve in leadership positions and on numerous committees for the Association of American Law Schools, the American Bar Association, the State Bar of Georgia, and for other local and regional organizations where their legal training is of value. Ronald Blasi served on the Editorial Advisory Board of the Journal of Bank Taxation. James Bross chaired the AALS Section on Agricultural Law. Mark Budnitz was a member of the Uniform Commercial Code Committee of the State Bar of Georgia and served on the Board of Directors of the Atlanta Legal Aid Society. William Edmundson was Secretary of the AALS Section on Law and Interpretation. Marjorie Girth functioned as the AALS Summarian for the joint ABA and AALS accreditation site team evaluating the law school at the University of Alabama. Dean Janice Griffith served as a member of the Executive Committee of the Section on State and Local Government Law. Dean Griffith also made several presentations at the Seminar for New Law School Deans for the American Bar Association. Bernadette Hartfield continued to serve on the Board of Trustees of the Law School Admissions Council. Nancy Johnson, Law Librarian and Professor of Law, completed her third year on the Executive Board of the American Association of Law Libraries and served as an Editorial Board Member of Legal Reference Services Quarterly. Marjorie Knowles was chair of the AALS Committee on Academic Freedom and Tenure and continued her long time service as a Trustee of TIAA/CREF. E. R. Lanier was a member of the Board of Trustees of the Institute for Continuing Legal Education in Georgia. He also served as a member of the Editorial Board of the Croatian Arbitration Yearbook. Charles Marvin became Chair-Elect of the AALS Section on Law and Africa. Paul Milich was Secretary/Treasurer of the Bleckley Inn of Court. Mary Radford continued her long service on the Executive Committee of the Georgia Appellate Practice Resource Center. Charity Scott was Vice Chair, Clinical Ethics Interest Group, Health Law Section, American Bar Association.

Ellen Taylor was member of the Board of Directors, Georgia Advocacy Office. Patrick **Wiseman** was a member of the Board of Directors of Georgia Advocacy Office.

# <u>Interdisciplinary activities</u>

The College of Law engages in interdisciplinary and inter-departmental cooperation, including teaching and research. This past year the joint research efforts of the College of Business and the College of Law concerning digital signatures and the electronic filing of court documents expanded into teaching, with Mark Budnitz and Todd Vincent team teaching a course for M.B.A. students on electronic commerce. Other law faculty teach courses in the Colleges of Arts and Sciences, Business Administration, and Education. Correspondingly, a member of the Risk Management and Insurance faculty of the College of Business teaches insurance law to College of Law students.

William Edrnundson served on the Advisory Board of the Arts and Sciences based Jean Beer Blumenfeld Center for Ethics. In November of 1999, the **Blumenfeld** Center for Ethics sponsored a conference for academics, professionals, and the public at which law professor Charity Scott spoke on medical privacy issues.

The College of Law has two joint programs with other colleges at Georgia State University. A significant accomplishment this year was the approval by the College of Law and the University of a joint JD/MA in Philosophy degree program. The College is engaged now in conversations with the City Planning Program in the College of Architecture at Georgia Institute of Technology for the team teaching of a course in Growth Management Law in which both law and Georgia Tech students will be enrolled.

# **Scholarship**

The impressive record of scholarly research and publications by the faculty of the College of Law continues, building an ever greater professional reputation for themselves and contributing to an increasing scholarly reputation for the college and university. Books published by the faculty were The Law of Lender Liability by Mark Budnitz; Cases and Materials on Corporations by William Gregory; Winning Research Skills, 4<sup>th</sup> edition, and Legal Research Exercises, 6<sup>th</sup> edition, both by Nancy Johnson; Courtroom Handbook on Georgia Evidence and Georgia Rules of Evidence. 1999 Pocket Part by Paul Milich; Tax Procedure and Tax Fraud in a Nutshell by Patricia Morgan; and 1999 Supplement to White Collar Crime: Law and Practice, by Ellen Podgor.

Ellen Podgor, <u>Boston College Law Review</u> and <u>American University Law Review</u>; Mary Radford, <u>Mercer Law Review</u>; Natsu Saito, <u>Third World Law Review</u>; Eric Segall, <u>Constitutional Commentary</u>; and Roy Sobelson, <u>Mercer Law Review</u>.

# **Development**

Efforts on behalf of the College of Law raised the law school's assets held by the Georgia State University Foundation to \$4,863,000. The largest new gift was a generous contribution from the Atlanta Law School Foundation for \$125,000 for the remodeling of the courtroom. This capital gift was in addition to the Atlanta Law School Foundation's annual scholarship support. Other gifts during this last year include an endowed fund for the Law Library to purchase materials on natural resource law, given by law school alumnus Dr. Stephen E. Draper; a scholarship fund endowed by Georgia State University's founding dean, Ben F. Johnson, Jr.; a donation for the college's Student Trial Lawyers Association; and a donation for a new trophy case, given in the name of the Student Trial Lawyers Association.

Much activity was devoted to the launching of the Board of Visitors Scholarship Fund. The initiation of this fund was important, for it signified the maturity of the college's board and the board's acceptance of its role as a financial supporter of the law school. Contributions from the members of the college's Board of Visitors now total \$25,000, with pledges in hand that will raise that amount substantially.

The college is pleased with the hiring of a new development director who came on board in late March. Dr. Alleen D. Deutsch relocated from Florida State University where she was director of development for the College of Social Sciences. The law school administration and faculty look forward to Dr. Deutsch's guidance during the last stages of the university's capital campaign.

# **Student Achievements**

The College of Law continued its success in student moot court and mock trial competitions. Numerous teams competed in intrastate, regional, and national competitions. Notable activities this past year included impressive performances in the Thomas Tang Moot Court competition and the National Criminal Justice Trial Advocacy competition. For the Thomas Tang competition, Georgia State's team won the Southeast Regional Competition, defeating Florida State in the finals. The regional victory allowed the Georgia State team to participate in the national rounds. In the National Criminal Justice Trial Advocacy Competition the Georgia State College of Law team won its first three rounds and proceeded to the semifinals with a 3-0 record.

The College of Law was pleased that Student Bar Association President, Dawn Jones, was a recipient of the Sparks Award. The award annually honors individuals within the university who have distinguished themselves by their work, attitude and contributions to the

Georgia State community. Nominated by her admirers in the College of Law, the final selection of recipients was made by a university committee that sought to bestow the awards on unsung heros who go the extra mile with good perseverance.

# Maior faculty or staff changes

Important personnel actions accomplished for the last year were the hiring of the following: Dr. Alleen D. Deutsch as development director; Ken Walsh as Director of Administrative Services; and Deborah McCullum as administrative assistant for Dean Griffith's office. The Law Library experienced a change in catalog librarians with the departure of Edna Dixon, who left to pursue a Ph.D. in Information Policy at the University of Illinois School of Library Science, and the hiring of Gail Spears, who most recently worked at Clemson University Library. Long time instructor in the college's reading, writing, and advocacy program, Linda Robinson, left Georgia State to attend graduate school at University of Southern California. Recruited to replace her was Janieen Tarrance, a graduate of Emory Law School and most recently an enforcement attorney with the Georgia Office of the Commissioner of Insurance. Jennifer Chiovaro assumed the coordination duties for the RWA program that Linda Robinson had done before her departure.

# **Progress in assessing Institutional Effectiveness**

The College of Law has long identified several instruments or measures to assess institutional effectiveness. Success of student teams in moot court and mock trial competitions reflect the rigorous intellectual preparation and practical lawyer skills that student receive in class. The College of Law has a long record of student achievement, and the past year proved no different. College of Law students fielded seventeen teams in fourteen competitions around the country this past fiscal year. The most notable successes were the performance of the Asian-American Law Students' team in the Thomas Tang Moot Court Competition, the Georgia State team's participation in the finals of the National Criminal Justice Trial Advocacy Competition, the regional championship won by the GSU team in the Association of Trial Lawyers of America National Competition, and the state championship secured at the National Invitational Mock Trial Tournament, Young Lawyers Division.

A valuable tool for measuring institutional effectiveness for the College of Law is the success rate of students sitting for the Georgia Bar examinations. Successful passage of such examinations are a requirement for entry into the legal profession. From its inception, the College of Law at Georgia State has built an impressive record of success on bar examinations. The principal date for taking the exam is in July after the spring commencement. Another testing is done in February for the few who graduate in December or who are repeating the test. For the July 1999 administration of the Georgia Bar Exam participants trained at Georgia State University had a 93.4% pass rate with those taking the test for the first time having a passage rate of 91.6%. For the February 2000 administration of the test all takers affiliated with Georgia State had a rate of 75.5% and first time takers had a rate of 84.8%.

Employment statistics six months after graduation are a standard measure used for assessing legal education and are annually collected by the College's accrediting agency, the American Bar Association, and by <u>U.S. News and World Report</u> for its edition on rating graduate and professional schools in America. The figures for the class of 1999 show an employment rate of 94.82%. Employment in large (51 to 100 lawyers) and very large (over 100) firms is prized and highly competitive. The percentage of Georgia State graduates employed in this category represents 14.76% of the 1999 class. This means that our chosen graduates were picked **from** regional and national pools of graduates representing some of the most prestigious law schools in the country.

Another measure of the effectiveness of legal instruction received as a student at Georgia State's College of Law is the success of graduates in achieving partner in prestigious law firms, appointment of election to the bench, and service as legal counsel for major corporations. Georgia State graduates are now partners in Alston & Bird; Arnall, Golden & Gregory; Holland & Knight; Jones, Day, Reavis & Pogue; Kilpatrick Stockton, L.L.P.; Powell, Goldstein, Frazier & Murphy; Long, Aldridge & Norman and others. A number of Georgia State College of Law graduates serve as assistant district attorneys and magistrate judges, and two graduates have State Court judgeships. Numerous corporate legal offices employ College of Law graduates including AT&T, BellSouth, Cox Enterprises, Equifax, Federal Reserve Bank, Georgia Power, and Georgia-Pacific.

#### **Retention & Graduation**

The summer skills program and the academic enrichment program are two valuable activities at Georgia State University College of Law to assist with student retention and graduation. Both of these entities are intended to improve the success rate of students who are deemed to be at risk of experiencing academic difficulty in law school. The summer skills program is a pre-start program that takes place prior to the beginning of the academic year for first year students. The academic enrichment program takes place during the regular school year and consists of tutorials offered by upper level students under the direction of a faculty committee.

The College of Law participated in a pilot program held at the University of Georgia in Summer 1999 that is patterned after the national Conference on Legal Education Opportunity program, more commonly known as CLEO. The national program was established in 1968 and was operated by several national bar associations. The purpose of CLEO was to diversify the legal profession by implementing recruitment, access and retention programs to increase the number of minority students who graduate from ABA-accredited law schools. The federal appropriation that supported the national program was recently cut from the federal budget. Under the leadership of Chief Justice Robert Benham and with the cooperative effort of the four (4) Georgia ABA accredited law schools, a state-funded, CLEO-like program was established in Georgia known as the Georgia Law School Consortium Fellowship Program. Four minority

students, one Asian-American and three **African-American** students, who qualified were admitted to Georgia State University College of Law in Fall 1999 under this program. They have all successfully completed their first year of law school and are currently enrolled in their second year.

Throughout the 1999-2000 academic year, the academic enrichment committee studied the effectiveness of our academic enrichment program that has involved student tutorials of first year courses and faculty led sessions on outlining and exam skills taking. Based on recommendations included in the committee's report, the program is being revamped to focus more on the learning of skills and methods for organizing materials. By decreasing the number of substantive courses covered in the academic enrichment program, student tutors will be able to work with a smaller group of students thereby enhancing their learning experience. The elimination of substantive tutorials in the spring will enable tutors to meet in small groups with students deemed to be most at risk of academic failure.

I submitted a second grant request in November 1999 to the Internal Revenue Service for a grant in the amount of \$100,000 for the fiscal year ended 9130100. This is the maximum amount that Internal Revenue Service may award pursuant to the Low-Income Taxpayer Grant Program. This grant request was to further expand and improve the operation of the clinic and ensure that the clinic remains financially viable. We are told that we will be informed in February 2000 whether we will be awarded the grant.

In addition to these two grants, I continued to develop our relationship with the Trammel1 Foundation and with the State Bar of Georgia. The TrammelFoundation contributed \$50,000 to the clinic in July 1999 and the State Bar of Georgia, Tax Section is considering a contribution. Furthermore, I cultivate existing donors by writing thank you letter, inviting certain contributors to special events (such as the visit of the Commissioner of Internal Revenue), and other wise keeping them informed of developments affecting the clinic.

# GHOSH, SHUBHA

Professor Ghosh was invited in June 1999 to write a paper for a print symposium to appear in **The Antitrust Law Journal** during the Spring of 2000. ### KADISH, MARK

Professor Kadish appeared on radio and television broadcasts as a legal commentator. He appeared on WAGA-TV, WXIA-TV, WGNX-TV, CNN Radio and WGST-AM Radio and discussed a variety of legal-interest topics. Professor Kadish was quoted in the Atlanta Journal and Constitution and the Daily Report on several legal issues of interest including gun control and the Calvin Johnson case. Professor Kadish's involvement in the Calvin Johnson case was discussed in the New Yorker Magazine January issue (interview was in December 1999). Professor Kadish spoke at length on the issue of gun control on WCBS New York Radio and WABC New York Radio news-talk programs.

Professor Kadish accepted a limited appointment as a Special Assistant District Attorney for Fulton County from District Attorney Paul Howard. Professor Kadish assisted in the prosecution of a criminal case involving seven defendants who viciously assaulted a woman. The case resulted in a conviction of four of the defendants.

Professor Kadish continues to work on a law review article, which will update the Article 36 of the Vienna Convention on Consular Relation Publication, which appeared in the <u>Michigan Journal of International Law</u> (1997). During the Summer of 1999, substantial research was accomplished. Although case law in this area is somewhat sparse, all extant cases since publication were analyzed.

Research has continued into a number of cases decided in 1999. The following cases cite to Professor Kadish's article: <u>State v. Reves</u>, 1999 WL 743, 529 (Del. Super.); <u>United States v. Lombera-Camorlinga</u>, No. 98-50347 (9th Cir. 1999) (the panel decision has been withdrawn and will be heard en banc by order of Chief Judge Hug, October 1, 1999); <u>United States v. Superville</u>, 40 F.Sup. 2nd 672 (D.C. Virgin Is. 1999). On September 30,1999 the Inter-American Court of Human Rights issued Advisory Opinion OC 16, "The Right To Information On Consular Assistance In The Framework Of The Minimum Guarantees Of Due Process". Professor Kadish is awaiting a translation of this 79-page opinion from Spanish to English in order to integrate this most significant opinion into the update. Professor Kadish is cited at page 6 for his submission of an Amicus Curiae Brief to the Court.
