## Faculty Senate Thursday, January 21, 1993 Wallenberg Hall 12:00 noon

- The meeting was called to order at 12:00 noon by Jane Borelli, Chair. Members unable to attend: R. Narske, K. Youngberg, M. Finnemann, J. Hildreth, P. Kivisto, C. Mahaffey, M. Quinn, J. Winship, B. Jacobson, M. Neil, R. Schussheim-Anderson, D. Snowball.
- 2.R. Troll moved that the minutes of December 21, 1992 be approved with the correction that Jeanne Davidson was in attendance. Seconded by M. Peterson and **passed.**
- 3. EPC Report Dean Selbyg
  - a) EPC recommended the approval of

## HI 317 [H] Austria from 1848-1919 / 3 cr.

Surveys the evolution of the Hapsburg Empire with specific concentration on the period from the 1848 revolution and the rise of Metternich and the question of Austrian relations with emerging Prussia to the dual monarchy before World War I. Concludes with an analysis of the war and its political consequences. (To be taught on the Vienna Term only.) Seconded by D. Erickson and **approved.** 

b) EPC recommended the renumbering of LS 110, 21st Century Seminar to LS 400, 21st Century Study Research Seminar / 1-1-1 cr. This course will carry the [C] suffix and have IP grading. Seconded by R. Radloff and approved.

c) EPC recommended the addition of MA 100 College Algebra / 2 cr. Mastery of basic algebra skills through a self-paced review. (Offered Pass-No Credit only.) IP grading for one extra term at most.

Seconded by C. Morrow and approved.

EPC recommended the addition of MA 450 [N] Topology / 3 cr. Metric spaces, topological spaces, homeomorphisms, convergence, completeness, compactness, function spaces.

Seconded by D. McLaughlin and **approved.** C. Morrow reported that the department will be dropping MA 442 [N] Optimization and Modeling / 3 cr.

d)EPC recommended a proposal to rearrange the internship courses as follows: (see attachment #1 in January 21 agenda)

Drop IN 382, xx 383 (Taken concurrently in summer only)

Change IN 388 (3+ cr.), xx 389 (2+ cr.) and Add IN 389 (3+ cr). These courses
 must be taken concurrently for an internship placement during the
 academic year. During the summer term, IN 388 and IN 389 must be
 taken concurrently and, if the student chooses, the departmental
 course xx 389 may also be taken but only with permission of the
 department. The total credits taken for a full-time internship will
 be 8 credits, the minimum credits necessary for full-time students.

The proposal was seconded by E. Hay and approved.

- e)EPC recommended the following proposals to allow credit-load averaging for full-time students: (see attachment #2 in January 21 agenda)
  - 1.A student who has paid full-time tuition and who did not enroll in the number of credits allowed by that payment may use those payments to reduce subsequent overload charges, subject to the following regulations:
- a)Payments may be carried forward only as long as full-time student status is maintained, interrupted by no more than a total of two terms, not counting summer sessions.

b)Payments from previous terms may be used only to reduce overload charges.

- c)Reductions in overload charges will be made on a credit-for-credit basis, not on the dollar amount charged for credits.
- d)Once an overload charge has been applied, it will not be refunded as a result of a smaller than maximum load in a subsequent year.

- e)Overload charges not covered by previous payments will be billed in accordance with current Business Office policy.
- 2.A student who pays full-time tuition for twelve terms, interrupted by no more than two terms, may enroll in one additional credit without overload charge during the academic year in which he or she graduates.

Seconded by M. Davis. D. Nelson explained that refunds would be allowed only for early withdrawal from a class in accordance with current policy. The proposal **passed.** 

With permission of the chair, Dean Selbyg introduced supplemental agenda items from EPC for Senate action.

- 1. EPC recommended renumbering of the following courses:
  - a) EN 101 College Writing to WR 101 College Writing. Seconded by D. Erickson.
- Erickson explained that EN 101 is required for all but Foundations students, and therefore should not count as part of the 40-hour limit on courses with the same course code. It is not required for any other departmental major. There was some discussion of alternative prefixes.
- D. Lee moved to amend the motion by substitution: "To maintain the current designation of EN 101 but exempt the course from the 40 credit limit." Seconded by P. Olsen.
- The chair called for a vote on the substitution and by a show of hands **the substitution passed**. A vote was then taken on the main motion as amended and the **motion passed**.
  - 2)EN/WL 232 Modern Drama to WL 232 Modern Drama. Second by P. Olsen. Of the 9-10 plays covered in the course only three are from English/American Literature. The motion passed.

3) AR 227 Photography II to AR 327 Photography II. Seconded by P. Xiao and passed.

2. EPC recommended the following course additions:

a)**RE 333 Varieties of Christian Thought / 3 cr. / HR suffi**x. Various Christian theologians, classical and modern, studied and compared from a historical and theological perspective.

Seconded by D. Lee and **passed.** D. Lee reported that the department will be dropping RE 330 Religion and American Culture.

- c)AR 229 Video Art / 3 cr. / F suffix. Drop the "Summer School Only" designation. Seconded by C. Goebel and passed.
- $d\,)\,\text{JA}$  220 Introduction to Contemporary Japanese Society / 3 cr.

The course explores various aspects of Japanese Society and the way it is portrayed in the United States. It encourages critical analysis of stereotypes and development of self understanding through comparison and contrast. Students will learn some Japanese terms, but this is not a language course. The focus is on contemporary society in Japan. Seconded by T. Banks and **passed.** 

e)JA 401-2-3 Current Japanese / 3+3+3 credits

Transition from textbooks to the language of film, video, newspapers
 and magazines. Guided research on current topics and access
 to media. Prerequisite: JA 303.
Seconded by D. Erickson and passed.

L. Belby raised the question as to why the accelerated course in Japanese language was not on the agenda for further approval. It was his thought that the course had been approved for one year only. Dean Selbyg responded that the course had been approved without such a restriction. Belby moved to adjourn at 12:55. Seconded by B. Nefzger and **passed**.

With the adjournment, the changes in the Theatre Major as listed on the supplemental agenda, will be carried over to the next Senate meeting on February 18.

- 2.With the correction on page four, next to last paragraph (Japanese .... course approved for **one** year only), G. Mann moved that the minutes be approved as corrected. Seconded by T. Felden and **passed.**
- 3.It was proposed that a Senate meeting be held next Wednesday, February 24, if necessary, to complete today's agenda. Seconded by D. Erickson and passed.

### 4. Advanced Standing and Degrees Committee - Michael Kirn

The list of winter term candidates for graduation was presented and AS&D recommended approval pending completion of all requirements. Seconded by D. Erickson and passed.

The following students will graduate with honors: summa cum laude Thomas J. Van Osdol magna cum laude Christine D. Broadston Sanjai Nagendra Mark Reade

## 5. Old Business - Dean Selbyg

- EPC recommended that TH 441, Dramatic Theory and Criticism, be deleted from required courses for the Theatre major (it will no longer be offered), and that the supporting courses for the Theatre major be changed from 6 credits (EN 232 and either EN 343 or EN 344) to 9 credits (EN 232, EN 343 and EN 344). Seconded by P. Xiao and **passed.**
- 6.The Steering Committee proposed the following dates for the Spring meetings: Senate Meeting: March 25, April 15 and May 13 (Old & New Senate) Faculty Forum: March 23 (proposed by Gender Equity Committee)

Faculty Meeting: May 6 Seconded by B. Jacobson and **approved**.

## 7. Report from Educational Policies Committee - Dean Selbyg

- a)EPC endorsed the recommendation of the General Education Committee to approve the following first year sequences for 1993-94 (in addition to Foundations). (Attachment #1) (a) American Culture in Transition (b) Environmental Studies (c) The Rise of Fascism and the Crisis of Personal Identity (d) Reading Nature, Text and Self (one year experiment) Seconded by R. Troll.
- It was noted that in sequence (c) the title of RE 130, Faith in the Christian Church, has been changed to "Introduction to Christian Thought." Also, HI 280, History Colloquium, will replace HI 115 The Rise of Fascism.
- There was also discussion about the spring courses in sequence (a)--PO 264-01 American Political Culture, to be taught by Dean Hammer or RE 120-01, Introduction to Christian Ethics, to be taught by Ann Swahnberg. No decision has been made on D. Hammer's teaching position for next year and those participating in the sequence asked for a little flexibility until the decisions have been made, since it is the preference of the sequence faculty to keep the political science course. D. Lee moved to amend by deleting the alternative course since it is not clear that it will be in the Master Schedule. Seconded by A. Levin and **approved.**
- N. Moline expressed his concern that the Asian sequence had not been approved. L. McCallum asked if a substitute sequence would be offered if any of the four chosen did not have enough students and Dean Selbyg said there would be no substitutions.

The chair called for a vote on the sequences as amended, and the **motion passed.** 

b)EPC recommended that the Degrees of Bachelor of Music and Bachelor of Music Education be replaced with the Bachelor of Arts with majors in music performance and music education. Seconded by M. Neil. Dean Selbyg explained that the College prefers, and the music department agrees, to offer the various majors within the framework of the Bachelor of Arts. Motion passed.

- c)In order to avoid problems with the 40 hour credit limits on courses with the same course code, EPC recommended that the code designation MU be changed to ME for a series of courses offered by the Department of Music. Seconded by M. Neil and **passed.** 
  - d)EPC recommended 1) a change in requirements for the major in Sociology, and 2) dropping the major in Social Work. Seconded by P. Kivisto and motion passed.
  - e)EPC recommended 1) a change in requirements for a minor in Sociology and 2) dropping the minor in Anthropology. Seconded by M. Davis and **motion passed.**
  - f)EPC recommended the addition of the following new courses in Sociology, Anthropology and Social Welfare, and dropping SO 210, 305, 341, 342, and all courses in Social Work.

b)Since no more than two faculty members from one division shall serve at any one time on the Foundations Committee, the following resignations and nominations are proposed: David Dehnel (1994) resigned from the committee and the N&R Committee nominated Heidi Storl to replace him to represent faculty who have participated in Foundations.

The N&R Committee nominated Carla Delucchi to replace Heidi Storl to represent non-participating faculty.

Nominations were closed and the nominees accepted.

9. EPC recommended a change in the Minor in Women's Studies (Attachment #3).

Seconded by G. Mann. T. Felden moved to amend by adding RE 315 [HR] Interpreting Paul (3 cr.) to the list of additional courses. The main motion as amended was **approved**.

A survey of the debate over equality in the development of American constitutional law, with particular emphasis on issues of racial equality. Issues considered include the scope and limits of legal equality and the selection by the courts and other governmental bodies of remedies for discrimination.

Seconded by L. McCallum and motion passed.

- ME 322 Piano Pedagogy, must be taken two terms / 1+1 cr. Replaces MU 421 and MU 422
- ME 326 Vocal Pedagogy, must be taken two terms / 1+1 cr. Replaces MU 464 and MU 465

ME 363 Pedagogy for Strings, Woodwinds, Brass or Guitar/1+1 Survey of principles, methods and materials of instrumental pedagogy. Must be taken two terms.

# ME 364 Literature for Strings, Woodwinds, Brass or Guitar /1+1 cr.

Survey of literature for woodwind, brass, guitar or strings. Includes score study and performance of selected works where applicable. Must be taken two terms. Replaces MU 363.

MU 307 Opera and Musical Theatre in London / 3 cr. A study of the operatic and musical theatre repertoire written since 1945 and premiered in London. Emphasis will be upon the musical and textual styles, as well as the cultural context which influenced the genres. Offered only on European term, Fall 1993.

## MU 308 African American Music / 3 cr.

A study of the history of Black Music in the Americas with emphasis on critical examination of African influence, the various musical styles, performance practices, aesthetic considerations, and the cultural and social context out of which the music derives.

Seconded by L. McCallum and passed.

Seconded by S. Knudsen. M. Davis explained that the State requirements have changed and the students need more credits in the methods courses. This would amount to an increase of only 2 credits for any one student. The changes were **approved**.

Study of and practice in the types of writing most commonly used in business, government and nonprofit organizations. Prerequisite: EN 101

and declared major in pre-business, business or accounting. Seconded by R. Reed and **approved.** 

- 4. Report from General Education Committee Dean Selbyg
- The General Education Committee recommended that the C suffix be given for SW 360, Comparative Social Welfare and Policy. Seconded by L. McCallum. There was some question about the course receiving the C suffix without a special focus on another culture. It was explained that after a fairly broad comparative study in the first two weeks, the course does have a special focus on social welfare in China and Mexico. The C suffix was approved.
- 5. Nominations and Rules Report Lori Scott
- The N&R Committee recommended that the Student Publications Board be recategorized as a committee primarily responsible to the administration, specifically the offices of the Dean of Academic Affairs and Dean of Student Services. This action concerns the Board's responsibility for the student yearbook which no longer has faculty involvement. Seconded by M. Finnemann.
- There was discussion about the role of the faculty in overseeing the publications of the <u>Rockety-I</u> and <u>Observer</u>. The faculty expressed some unwillingness to relinquish its primary responsibility for the <u>Observer</u> since students receive academic credit for their work in its publication. E. Hay moved to send the committee issue back to Nominations and Rules for clarification and the **motion passed**.
- 6.R. Troll moved, seconded by R. Schussheim-Anderson, to adjourn the meeting at 12:40 p.m. Motion carried.

- 3. Report from Nominations and Rules Taddy Kalas

#### STUDENT PUBLICATIONS BOARD

Motion 1: To list the Publications Board as a committee reporting to both the Dean of the College and the Dean of Student Services. Seconded by T. Bengtson.

- There was discussion concerning the reasons for reclassifying the committee. K. Youngberg moved to amend the motion by stating that the committee would report to both the faculty and the Dean of Students Services. N. Huse remarked that the in the current committee structure the committee is responsible **primarily** to the faculty, which should take care of any concerns about the Dean of Student's office. A vote was taken on the motion and it was **defeated**. The committee structure will remain as is.
  - Motion 2: To redefine the function of the Publications Board to read:
    - 1.To select the editors and business managers for the <u>Observer</u> and <u>Rockety-I.</u>

2. To hear complaints that cannot be handled by the Journalism adviser or which pertain to misuse of student funding for these publications.

The Journalism program is a component of the curriculum connected appropriately

to an academic department and supervised by a faculty member who has been hired for that purpose and who is responsible to the Academic Dean. The <u>Observer</u> is an independent feature of the Journalism program, serving as a lab experience for students.

The motion was seconded by P. Xiao and carried.

#### GENDER EQUITY AND AWARENESS COMMITTEE

MOTION 3: To add the following stipulation for the election of a Chair to the Gender Equity and Awareness Committee, "The elected Chair of the committee must be a tenured member of the faculty."

There were questions regarding the rationale behind this change. T. Felden pointed out that no other college committees currently carry such a stipulation. T. Kalas said that a similar motion regarding the Professional Ethics Committee was forthcoming from Nominations and Rules. Faculty serving on these committees deal with matters concerning other faculty, which distinguishes them from committees dealing primarily with student-related concerns. D. Lee pointed out that the Human Relations Committee would also fall into this category. Seconded by L. McCallum and **motion carried.** 

4.Report from the Human Relations Committee - Dean Selbyg

- The Human Relations Committee proposed adding the words "or sexual orientation" to the list of factors on which we do not discriminate in the Augustana policy on Sexual Discrimination and Harassment. It will read as follows:
- Augustana College affirms the principle that its students, faculty, and staff have a right to be free from sexual discrimination from any member of the College community. The College administers its educational programs under a policy that all admission criteria, resources, services, programs, employment, and housing shall be maintained on a nondiscriminatory basis, with regard to sex, race or color, creed, ethnic background, or **sexual orientation** at all times. Seconded by T. Bengtson.
- D. Hill stated that according to our current policy we have no discrimination at Augustana, including sexual orientation. Hill argued that our current policy does not reflect our practice: in admissions we discriminate in favor of, for example, minorities over whites and men over women, and

we offer racially-based scholarships to minorities. L. Belby argues that such scholarships are no more "discriminatory" than many other scholarships currently offered on the basis of religion, ethnic heritage, major, or geographical origin, for example.

The chair called for a vote on the motion and it **passed without** dissent.

5. Report from Educational Policies Committee - Dean Selbyg

- The meeting was called to order at 12:00 noon by Jane Borelli, Chair. Members unable to attend: M. Fogde, R. Narske, M. Peterson, R. Radloff, J. Hildreth, C. Mahaffey, J. Winship, C. Hyser, M. Neil, H. Noice.
- 2.With a correction on page 3, item 6, "It was <u>recommended</u> that the policy be studied further..., B. Hammer moved that the minutes be approved as corrected. Seconded by C. Goebel and **passed**.
- 3.Report from Advanced Standing and Degrees Committee Michael Kirn
- M. Kirn presented the list of candidates for approval for spring graduation, pending completion of all requirements. One student, Eric Bergo, will complete the requirements in the summer. Seconded by B. Jacobson and approved.
- M. Kirn then presented the list of 134 students who have earned Honors in the spring and summer terms. The percentage of students earning honors through spring term is 3.4% summa cum laude, 5.8% magna cum laude and 15.9% cum laude, for a total of 25.1%.

### 1) BA 405 Topics in Business Administration / 1 credit

A course in special topics in Business Administration. Prerequisites: Declared major in Business Administration, senior standing.

## 2) LS 301 [S] Authority and Order / 3 credits

The course will examine several modern forms of cultural authority, including the legacies of the Enlightenment, responses to that legacy and the crises of traditional authority in the nineteenth and twentieth centuries.

Seconded by L. McCallum and passed.

## 3)PL 100 [H] Introduction to Philosophy: Knowledge, Nature and Value / 3 credits

An introduction to philosophical thinking, both to the topics that have interested philosophers and to the methods they have used to arrive at an understanding of them.

Seconded by H. Storl and **passed**. It was announced that PL 244 will be dropped.

  - a)The committee assignments for 1993-94 were presented for approval with the following changes:

With these changes and additions the motion was seconded by M. Davis and **passed**.

b)Reorganization of Faculty Welfare Committee, Educational Policies Committee, and the responsibilities of Division Chairs as proposed in attachment #1 of the May Agenda.

Motion 1

1.1 The membership of the Educational Policies Committee shall be:

The Dean of the College or a representative chosen by the

Dean (Chair) The Director of Records Six Tenured Faculty (one per division, elected by each division for 3 year terms) Three Non-Tenured Faculty (from three different divisions and from three departments not already represented) Five Student Representaives (no two majoring in the same division)

1.2 The General Education sub-committee of Education Policies shall be abolished. The functions of that subcommittee will be taken up by the EPC as a whole.

No individual shall serve, simultaneously, on EPC, Faculty Welfare, Budget Committee or as Chair of Faculty Senate with the temporary exception of those individuals who are Division Chairs at the time of implementation of this proposal. They will continue to represent their divisions on Faculty Welfare and EPC until the expiration of their current terms. At that point, their divisions will hold elections to select separate representatives. A Division Chair whose term begins in the 1993-94 academic year has the option of severing his appointment with EPC.

Seconded by B. Hammer and approved.

Motion 2

- 2.1Division chairs are elected from within divisions for three-year, staggered terms. Chairs may be elected for more than one term, <u>but not for more than two consecutive terms</u>. Faculty members who will be absent from their teaching responsibilities or from the campus for two or more terms during the year automatically relinguish division chair assignments for the time they are absent and must be replaced by election within the division. Chairs who will be absent from their teaching responsibilities or from the campus for one quarter or less may be replaced at the discretion of the chair. Only tenured, full-time faculty members are eligible to stand for election.
- 2.2Division chairs may not serve on the Budget Committee, Educational Policies, or as Chair of the Faculty Senate during their term.
- The current chairs will continue to serve and the fall nominees will be given an option for their choice of committee.
  - d. 2.3The duties of the Division chair include:

- a)being the divisional representatives on the Faculty Welfare Committee
- b)participating with the President, Dean, and departmental chairs in interviewing and selecting candidates for membership on the faculty
- c)coordinating academic planning within the academic divisions of the College

Full-time faculty are eligible to vote for Division Chairs. Full-time faculty who have part-time teaching responsibilities in two departments may vote in both departments. Administrators with part-time teaching appointments may vote if they teach at least 11 credits per year.

Seconded by Lou Belby and passed.

e. N&R recommended a change in the description of the Professional Ethics Committee to state that the chair must be a tenured member of the faculty. Seconded by T. Kalas.

B. Hammer moved to amend the description by omitting the words "randomly chosen" from the membership selection. Seconded by D. Erickson.

D. Lee stated that if members are not randomly chosen, the committee could be a "stacked" committee.

The chair called for a vote on the amendment and it **failed**. The chair called for a vote on the original motion and it **passed**.

6. Report from the Steering Committee - Tom Bengtson

The Steering Committee recommended that the dates for the 1993-94 year be selected in advance so that Wallenberg Hall would be available for other events at the noon hour. Bengtson explained that should it be necessary to call extra meetings, the Senate would have priority over other things that might be planned.

President Tredway suggested that the Senate might consider meeting in another room since it is very difficult to hear in Wallenberg. He suggested using Larson Hall or John Deere Lecture Hall.

After much discussion, L. McCallum moved that the motion be tabled. Seconded by G. Mann and there was a tie vote. The chair broke the tie by voting to table the motion.
