The Board of Regents, Texas Eastern University, convened at 2:00 p.m., April 4, 1979 with eight members present: Chairman David K. McKie, C. Quentin Abernathy, Jeff Austin, Jr., Otis T. Dunagan, Gene W. Hightower, D.D.S., H. J. McKenzie, Robert M. Nall and Dean W. Turner.

Also present were James H. Stewart, Jr., President; Donald W. Whisenhunt, Vice President for Academic Affairs; John R. Sawyer, Vice President for Fiscal Affairs; L. J. Grubbs, Director of Physical Plant and Resident Engineer; J. Archie Whitfield, Director of the Office of Public Information; and Rosemarie Cross, Secretary to the President.

The meeting was called to order by Chairman David K. McKie.

ITEM I.

INVOCATION

Rev. Hoyt Huff, Associate Minister of the First Christian Church of Tyler, Texas brought the invocation for the opening of the meeting of the Board of Regents, Texas Eastern University.

ITEM II. ANNOUNCEMENT OF EXECUTIVE SESSION

The chair announced that it would be necessary to have an executive session during the meeting as authorized under Article 6252-17, Section 2, Paragraphs (f) and (g) Vernon's Texas Civil Statutes.

ITEM III. EXECUTIVE SESSION

The chair announced the meeting would convene into executive session at 2:19 p.m. The meeting reconvened into open session at 3:10 p.m.

ITEM IV. APPROVAL OF MINUTES

Regent Turner moved and Regent Dunagan seconded that the Minutes of the March 14, 1979 meeting of the Board of Regents be approved. Motion carried unanimously.

Chairman McKie announced that the Minutes of the March 28, 1979 Board of Regents meeting would be submitted for approval at the next board meeting.

ITEM V. APPROVAL OF AGENDA

Regent McKie reported that the present officers of the TEU Educational Foundation, Inc. had been reelected in accordance with Section 8, Article Two of the foundation bylaws during the annual meeting of the Board of Directors held earlier in the day and requested ratification of the officers by the Board of Regents. The Executive Committee consists of officers of the Board of Directors, Henry M. Bell, Jr., Charles Childers, B. G. Hartley, H. J. McKenzie, David K. McKie, B. H. McVicker, M.D., J. Harold Stringer and Neal E. Velvin and newly elected officers of the Board of Regents.

BOARD ACTION: Regent McKie moved and Regent Dunagan seconded that the Board of Regents ratify the following TEU Educational Foundation, Inc. officers elected during the corporation's annual meeting April 4, 1979: A. W. "Dub" Riter, Jr., president; Isadore Roosth, vice president; and C. Quentin Abernathy, secretary-treasurer. Motion carried unanimously.

ITEM VIII. CONSTRUCTION PROGRESS REPORT

For the benefit of newly appointed members of the Board of Regents, Regent McKenzie explained the functions of the Campus and Building Committee. "There have been three of us on the Campus and Building Committee, and we have -- in connection with the university--Mr. Grubbs who is in charge of all engineering and maintenance of all buildings and structures and campus on TEU's 200 acres. All our building is handled under contract in accordance with the state requirements. Competitive bids must be taken, and we have done this in every instance. The three buildings now under construction, Sciences and Mathematics, Business Administration and Library, are being constructed by Gordon Campbell who has his own supervisors of construction, and in addition to that, has an architect-engineer supervisor who works directly with Mr. Grubbs. As items come up that are extras, they are checked out with the architect and with Mr. Grubbs and the contractor and an agreed price is reached. Then the amount of that extra, if it is a justified extra, is passed to the building committee for their approval and the building committee also checks it and after that it is recommended to the board for approval as to payment. This has been a very satisfactory way to check all of the extra we have on buildings." Regent McKenzie called on Mr. Grubbs to analyze the status of the work as it had progressed in Phase II for the week ending March 30, 1979. Mr. Grubbs gave the following report.

Sciences and Mathematics Building: Brick work is essentially complete. The air conditioning including air handlers, defusers, registers, duct work, insulation, air-water

balancing, is essentially complete. Roof work is complete except for minor repairs. The elevator has been tested according to state law and is ready for operation. Dry wall texture and paint is essentially complete. Some of the more sophisticated equipment in the laboratories has been installed and put into operation initially, but has not been accepted. Motor control panels have been installed and basic checkout has been completed. Tack boards and chalkboards are all in place. Three environmental rooms for the building are complete and ready to be put into operation. In summary, the building is 97 or 98 percent complete. We are about ready for the substantial completion inspection and preparation on the punch list.

Business Administration Building: Roof work is complete and brick work is essentially complete. Mechanical/electrical equipment including air handlers are in place but not in operation. The elevator is installed and in the process of being checked out. Painting is about 85 percent complete. Acoustical tile ceiling work was begun about two weeks ago.

Greenhouse: The building is essentially complete. Heating and ventilating equipment is being checked.

<u>Site Work</u>: There is a considerable amount of work to be done because of bad weather. There is quite a bit of sod work to be done although sodding is complete on the upper dam and some sod is in place on the northeast side of the Sciences and Mathematics Building.

Library: Very little progress has been made on this building because of inclement weather. Building and site excavation is near complete and some concrete was poured last week. Parking area excavation is nearly to grade. It is expected that steel will be up in about 60 days.

In response to a question from Regent McKenzie, Mr. Grubbs stated that occupancy of Phase II buildings is expected by the latter part of August.

BOARD ACTION: Received as information.

ITEM IX. SELECTION OF DEPOSITORY BANK

Regent Abernathy reported that in accordance with Board of Regents policy of rotating the institution's depository bank among members of the Tyler Clearing House Association, the Finance and Appropriations Committee recommended Tyler Bank and Trust Company be designated by the Board of Regents as the depository bank effective September 1, 1979. The present contract with Southside State Bank expires August 31, 1979.

BOARD ACTION: Regent Abernathy moved and Regent McKenzie seconded that the Board of Regents approve the selection of Tyler Bank and Trust Company as the Texas Eastern University depository bank

effective September 1, 1979. Motion carried unanimously.

President Stewart gave the following oral report based on a previously submitted written report and recommendations:

1. Approval of Graduates for 1979 Commencement

The faculty, Deans Council and vice president for academic affairs of Texas Eastern University had certified that degree candidates named in Attachment B are completing curricula offered by the several schools and departments of TEU, and the president was honored to recommend to the Board of Regents that these students be awarded the appropriate degrees with all rights and privileges pertaining thereto in recognition of their academic accomplishments and that each student named be awarded the designated baccalaureate or master's degree during the 1979 Annual Commencement program to be conducted at Harvey Hall, Tyler, Texas on May 12, 1979 at 2:00 p.m.

The total number of graduates presently anticipated for the 1979 Annual Commencement is 501 with 131 students having completed degree requirements during the Summer Semester 1978; 144, during the Fall Semester 1978; and 226, during the Spring Semester 1979.

There is a total of 358 bachelor's degrees and 143 master's degrees including 47 master's degrees in interdisciplinary studies. The School of Applied Studies has reported 85 bachelor's degrees; the School of Business Administration, 68 bachelor's degrees and 5 master's degrees; the School of Education and Psychology, 115 bachelor's degrees and 91 master's degrees; the School of Fine and Performing Arts, 11 bachelor's degrees; the School of Humanities and Social Sciences, 59 bachelor's degrees and the School of Sciences and Mathematics, 19 bachelor's degrees.

his/her recommended degree contingent upon each degree candidate successfully completing the requirements for his/her degree; furthermore, that each approved degree candidate named in Attachment B be awarded the designated baccalaureate or master's degree during the Annual Commencement program on May 12, 1979 at 2:00 p.m. in Harvey Hall. Motion carried unanimously.

2. Fine Arts Scholarships

Based on the April 12, 1978 Board of Regents request, the Texas Eastern University Educational Foundation, Inc. funded Fine Arts Scholarships in music and drama for a two-year period as follows: \$2,000 for the first year and \$4,000 for the second year for music students based on a formula of \$200 per student per year and \$500 for the first year and \$1,000 for the second year for drama students based on a formula of \$100 per student per year.

In regard to the \$1,000 designated for second-year drama scholarships, it is recommended that this amount be utilized for speech scholarships. These two academic programs are closely related, and it has been determined by the faculty, dean, vice president and president that this modification would best serve our present situation. Chairman Turner asked how many students were presently participating in the speech program. Dr. Rada replied that there were presently six or eight students actively participating in forensic, reader's theater and speech festival activities. He stated that the interest was there on an informal basis, and he felt that with a little incentive the number of participating students could be boosted to twelve or eighteen or higher. Dr. Stewart took this opportunity to congratulate Dr. Rada and Dr. Freeman on the success the university had experienced in these programs.

BOARD ACTION: Regent McKie moved and Regent Nall seconded that the Board of Regents, upon the recommendation of the president, approve the change in the guidelines of the Fine Arts Scholarships funded by the Texas Eastern University Educational Foundation, Inc. from the designation of drama students to that of speech students. Motion carried unanimously.

3. Extension of Social Security Coverage to University Employees

As reported to the Board of Regents on April 12, 1978, an employee referendum for the purpose of determining employee preferences concerning Social Security coverage was postponed last spring in order to observe any actions which the 66th Texas Legislature might take concerning payment of the employees' portion of Social Security (5.85 percent on earnings up to \$16,500). Since no legislation has emerged

or is anticipated in the 66th legislature which would change the state's Social Security program, it is now desirable and appropriate to reinitiate an employee referendum on Social Security.

On January 18, 1978 it was reported to the Board of Regents that the process for accomplishing this objective requires a request that the Social Security Division of the Employees Retirement System of Texas conduct a referendum for the purpose of determining employee preferences concerning Social Security coverage for university employees. Further, a representative institutional committee to conduct the referendum under the direction of the Social Security Division of the Employees Retirement System of Texas is required. A committee comprised of the business manager, a faculty member and a classified employee has been recommended to the director of that office for appropriate action.

It is required that notice of the date of the referendum be posted not less than 90 days prior to the referendum. Therefore, an announcement was posted February 28, 1979 giving advance notice of the referendum which is planned for June 1, 1979 in order for implementation of the program to take place September 1, 1979.

Results of the referendum will indicate the number of employees for and against Social Security coverage and will assist in the final decision on this matter by the Board of Regents. No fixed percentage of votes is required to implement the program. In the event the board elects to provide Social Security coverage for university employees, the employees who vote for the coverage will be required to participate while employees who vote against the program will be excluded from participation. Furthermore, if the program is initiated at Texas Eastern University, all new employees joining the university after the referendum will be required to participate in the program.

Chairman Turner asked if a secret ballot would be taken or if the results would show how each employee voted. President Stewart replied that the ballots would show how each employee voted because ballots cast by individual employees would serve to establish whether or not the employee participates in the Social Security program if instituted by the Board of Regents. He stated further that employees were fully informed about this and other referendum provisions through the efforts of the representative institutional committee. Regent McKie asked if employees had an option between the Social Security program and the regular retirement program, and President Stewart explained that the referendum applied to Social Security only. He added that faculty and certain other employees are given a choice between the Teacher Retirement System and the Optional Retirement Program. Social Security would be in addition to the retirement plan

under which individual employees are covered. Separate ballots have been prepared for employees under the Teacher Retirement System and for those under the Optional Retirement Program. Regent Abernathy stated that the Social Security percentage had now risen to 6.13 on earnings up to \$22,900 and asked what portion the employees would be expected to pay. President Stewart replied that the state currently pays the employer's matching portion under Social Security and in addition pays 5.85 percent on earnings up to \$16,500 of the employees' portion according to action taken by the 65th Texas Legislature. Texas Eastern University employees would be required to pay the difference in the employees' portion if the program is adopted by the Board of Regents.

Chairman Turner asked if there was any action to be taken by the board at that time, and President Stewart explained the report was being given for information only. However, the results of the employee referendum, along with the latest facts available on the matter, would be brought to the board for consideration at the proper time.

BOARD ACTION: Received as information.

4. Texas Community and Junior College Scholarships

Texas Eastern University awarded seventeen scholarships to students from thirteen institutions under the Texas Eastern University Educational Foundation, Inc. Community and Junior College Scholarship program for the Spring Semester 1979. Participating colleges and respective awards, which vary in amount according to individual course loads, are as follows:

Our business office had estimated the amount needed for Community and Junior College Scholarships for the Spring

Semester 1979 to be \$4,312.50. Accordingly, \$4,143.00 (the estimated requirement of \$4,312.50 less a \$169.50 balance on hand) was requested from the foundation under authority previously established by the Board of Regents.

BOARD ACTION: Received as information.

5. Student Enrollment Reports

A report relative to Spring Semester 1979 twelfth class day student enrollment was prepared according to House Bill 1012, 65th Texas Legislature, and provided to members of the Board of Regents with Administrative Notes for March 26, 1979. This report indicates the identity and academic rank of instructors, the number of semester credit hours accrued to each course, the course number and title and the department in which the courses are offered. Reference was made to the report at this time for the purpose of making the material a part of the official record of the university as Attachment C to the minutes of this meeting. State law, through House Bill 1012, further specifies that governing boards shall be provided with a report relative to student enrollment in each class on the last day of the semester. This data for the Fall Semester 1978 was provided to Board of Regents members with Administrative Notes for January 29, 1979 and will become a part of the official university record as Attachment D to the minutes of this meeting.

BOARD ACTION: Received as information.

ITEM XIV.

DISTRIBUTION OF MINUTES

Regent McKie asked for information relative to the distribution of the Board of Regents approved minutes. Dr. Stewart replied that copies are sent to six state offices plus the Governor's Office, three offices on the TEU campus and the university library where they are made available to faculty, staff, students and the general public. Chairman Turner requested that notice be placed in Intercom in order to inform all individuals concerned that copies of the minutes are available in the TEU Library. President Stewart suggested that he consult with the Faculty Senate and Administrative Council to determine the most appropriate manner in which to share these materials. Chairman Turner requested that Dr. Stewart report his findings to the Board of Regents.

ITEM XV.

ANNOUNCEMENT OF NEW PUBLICATION

President Stewart displayed a new book, <u>Fundamentals of Abnormal Psychology</u>, recently published by Rand McNally and written by Dr. Frederick Mears, TEU professor of psychology and chairman of the Department of Psychology, and Dr. Robert J. Gatchel. Dr. Stewart also pointed out that Texas Eastern University was mentioned under Dr. Mears' name and that this is not the only

textbook being authored by professors at Texas Eastern.

BOARD ACTION: Chairman Turner moved and Regent McKie seconded that the Board of Regents extend congratulations to Dr. Frederick Mears upon the publication of his book, <u>Fundamentals of Abnormal Psychology</u>, and Regent Abernathy recommended that Chairman Turner be named to execute the statement of congratulations. Motion carried unanimously.

ITEM XVI.

RESOLUTION OF COMMENDATION

BOARD ACTION: Regent Austin moved and Chairman Turner seconded that the Board of Regents pass a resolution of commendation for former chairman, David K. McKie, on a job well done and Regent Austin further moved that Chairman Turner be named to frame the resolution. Motion carried unanimously.

ITEM XVII.

CIRCULATION OF STUDENT NEWSPAPER

Regent Abernathy stated that he was no longer receiving the <u>Patriot</u>, university student newspaper; and requested that all regents be placed on the newspaper's circulation list.

ITEM XVIII.

MIKE HARVEY LAKE

Regent McKenzie mentioned that Mike Harvey Lake had recently become very muddy and offered to provide a supply of dye to color the water. Chairman Turner asked Mr. Grubbs if the amount of silt in the lake was causing problems at present. Mr. Grubbs replied that excessive drainage from unpaved areas and from the reclamation area was causing discoloration of the lake. He further stated that he had received a communication from the Parks and Wildlife Commission of Texas advising the discontinuance of the use of dye in the lake because of light transmission and its effect on production of natural foods for the fish. Chairman Turner suggested that Regent McKenzie and Mr. Grubbs confer on this matter.
