Dedication

Professor Joseph Dainow was a teacher of rare ability and a prominent legal scholar who left the legacy of an interminable list of intellectual achievements.

His devotion to the law of Louisiana was so manifest that for thirty generations of law students the Louisiana Civil Code was identified with his name.

His incomparable notion of respect made him unable either to hurt others or to allow his vast knowledge to become overbearing. Yet, in a subdued manner so much his own, he was a fighter for just causes whether in law, religion, or race. If he was ever intolerant, it was of intolerance.

He had made it his duty to search for new talent. When he found it he would stop at nothing to bring that talent to fruition. Only unusual human beings know what the right words of encouragement are, and the right moment to speak them. Of that art he was a master.

Above all he was a kind man. Human solidarity ranked very high among his values. It was easy for his warmth to betray his habitual restraint. He conceived the teaching process as a cordial relationship between someone with experience and someone willing to benefit from it. He firmly believed that knowledge is but an attitude of the spirit. That attitude he knew how to convey.

The law school would have been a lesser place without him.

Because a yearbook is intended to preserve a feeling of togetherness, a feeling beyond academic achievement that gives a school its true spirit, nothing can be more appropriate than to dedicate this issue of *L'Avocat* to the memory of Professor Joseph Dainow.

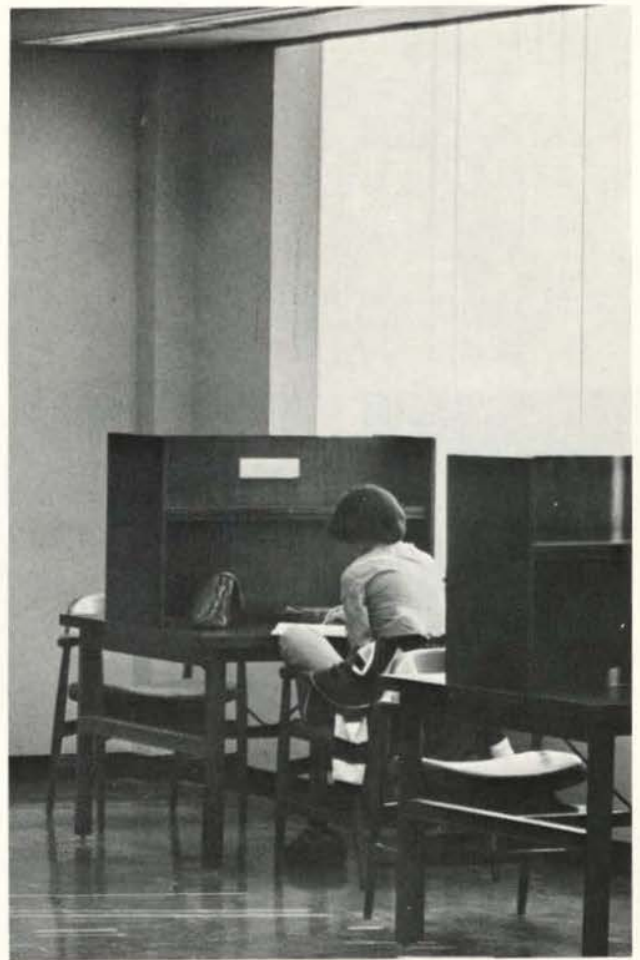




Editor's Note
