- Topic/Subject Orientation of the journal
- Format of your paper – length, currency etc
- Prominence of the journal
- Prominence of the school ([US News](#), [Leiter Rankings](#))
- Circulation of the journal
- Is the journal available on Lexis and Westlaw
- Where/How is it indexed

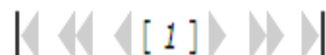

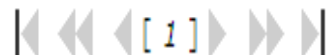

# Strategic Submissions

- Timing : Late Summer and early Fall; February to April
- Include a resume/CV
- Include a cover letter saying why they should publish YOUR paper; special circumstances
- Only submit a finished and polished draft.
- Make sure the form (length, typeface, footnotes) conforms to the requirements of the journal.
- May be able to request an expedited review if first offer is not the one you want to accept

# Submitting your paper

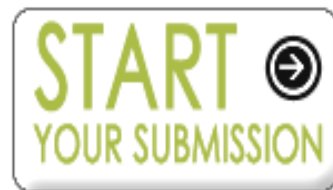
- Pence Law Library will pay for your submissions on ExpressO: use your **WCL email address to qualify**
- Up to \$150 at a time
- ExpressO has over 750 journals
- Process of uploading very simple and straightforward. Accepts Word and WordPerfect
- Address to Dear Editor: Merged addresses are not available
- You CAN (sometimes) negotiate for additional time if you prefer a different journal, Note the “exploding offer phenomenon”
