information sources – databases and software to look up facility compliance history laws, regulations and dockets – current and pending legislation and major laws governing environmental issues; the <u>Regulations Page</u> includes CFR and Federal Register contents by topic – i.e., just the environmental regulations.

The EPA designates some rulemaking as "priority rulemaking," based on a number of factors. It is also engaged in "retrospective review" of some of its regulations. A retrospective review is an opportunity to look back at an existing regulation and if any requirements are "outmoded, ineffective, insufficient, or excessively burdensome, and to modify, streamline, expand, or repeal them in accordance with what has been learned," per <u>Executive Order 13563</u>. Information about priority rulemakings and retrospective review can be found on the <u>Regulatory Development and Retrospective ReviewTracker Page</u>.

COURT AND AGENCY DECISIONS

As in all heavily regulated areas of law, many environmental law cases originate in an administrative agency, generally, but not always, the EPA. Agency decisions are appealed to federal appeals courts, and those decisions are included in the Federal Reporter series.

Agency decisions appear in various places, including the agency's website, Lexis, Westlaw, and HeinOnline's U.S. Federal Agency Documents, Decisions, and Appeals database.

LOOSE-LEAF SERVICES

These are compiled by private publishers on a subject basis. They are designed to help practitioners stay current on legal, legislative, regulatory, and policy developments, particularly in heavily regulated practice areas like environmental law, securities, benefits, and tax. They were originally published in ring binders for easy updating (hence the term "loose leaf"), but most are now available electronically.

PROPOSED LEGISLATION OR REGULATION

Thomas

Thomas is the best tool for tracking pending legislation. You can search for legislation in the current Congress by keyword, bill number, or sponsor. You can search in previous Congresses by keyword or public law number.

Lexis and **Westlaw** also have tracking functions, though Thomas is typically more up to date.

House and Senate Committee websites frequently have information about pending legislation. However, committees are not required to post or update this information, so the content and the currency of the sites vary widely. The following committees are involved with environmental matters:

- **❖** House Committee on Science and Technology;

Proposed regulations are announced in the Federal Register, available in various locations, including

Proposed regulations and comments can be found at <u>Regulations.gov</u>, a multi-agency clearinghouse for collecting public comment on proposed regulations. EPA specific to the EPA may be found at the <u>EPA Website</u>, <u>Regulations Page</u> and the <u>EPA Website</u>, <u>Priority Rulemaking Page</u>

New laws and proposed regulations may also be listed on administrative agency websites, but this varies by agency and is not always kept up to date. Websites for nonprofit and "watch dog" groups may also track new legislation or regulations.

Always update statutes and regulations by consulting the pocket parts (U.S.C.) or the List of Sections Affected (C.F.R.). The **Westlaw Key Cite** service will also flag pending changes to the U.S.C. and the C.F.R. and link to updating laws or regulations.

LEGISLATIVE HISTORY

<u>ProQuest Congressional</u>, available from the library website, is a comprehensive database of legislative history materials for all but the most recently enacted laws. It is strongly recommended that you search this database using a **Public Law** or **Bill Number**.

Legislative histories have already been compiled for many federal laws. Check a standard reference, such as the *Union List of Legislative Histories* (Reserve, KF4.U551) or the *CIS Legislative History Service* (Reserve, KF49.C63). Alternatively, do a keyword search of the library catalog, for example – "(clean air act) and (legislative history)."

Other Legislative History Sources:

In addition to the sources listed above, use **Thomas**, **USCCAN** (U.S. Code Congressional and Administrative News) (available in print, First Floor, after Statutes at Large, and on Westlaw). It is strongly recommended that you use a **Public Law** or **Bill** number to do research using these sources.

Finally, consult Congressional Committee websites, listed above, and <u>CQ Electronic Library</u>, available through the Library's website, for additional information.

STATE LAW RESEARCH

State codes and case law are available through **Lexis** and **Westlaw**. Print materials, including regional reporters, are available on the second floor of the library.

Laws and Regulations for selected states are available from <u>CCH IntelliConnect</u> and from Bloomberg BNA's <u>EHS State Regulatory Alert</u> and <u>State Environment Daily</u>.

State legislative history research can be very challenging. There is no legislative history collection analogous to ProQuest Congressional at the state level, and states vary widely in their treatment of legislative materials. Documents that do exist are often in print or microform collections in state law libraries or archives. Please contact a Reference Librarian before attempting to do state legislative history research. Most state legislatures post the text and status of current legislation on their websites. For older materials, start with **Westlaw** > **U.S. State Materials** > **Legislative Histories**.

States also vary in publishing practices for regulations and administrative materials. Administrative codes and decisions are available in state databases on **Lexis** and **Westlaw**. Useful databases include:

Current Index to Legal Periodicals

Update LegalTrac and ILP research by viewing most recent weeks' issues. Available in HTML, Word, and PDF. Organized by journal title and area of law. Accessible through Pence Law Library Website.

Index to Foreign Legal Periodicals

Journal articles covering topics in foreign and international law from 1985 to present. The index is in English, although the majority of publications covered are not. Accessible through Pence Law Library Website.

Articles before 1983 can be very useful if you are interested in development of and the policy concerns underlying a piece of environmental legislation. You will need to consult the **Index to Legal Periodicals** in print, located on the second floor, in the Periodicals section. Articles will be available through **HeinOnline**, **JSTOR**, or in print (through Pence Library or ILL). Please ask a reference librarian for assistance.

INTERNATIONAL AND FOREIGN LAW

When embarking on foreign or international law research, it is important to remember the difference between the two. International law is law between nations; foreign law is the domestic law of foreign nations. The type of legal resources differs greatly between the two. Also bear in mind that, on any particular issue, national law, regional authority or agreements, such as European Union regulations or NAFTA Agreements, and other treaties or agreements may all come into play.

Comprehensive foreign law research includes a country's legislative and administrative bodies, as well as its courts. The details vary by country, and it is always helpful if you are fluent in the official language of the country at issue.

The <u>Foreign Law Guide</u>, accessible through "Information Resources A-Z" section of the Pence Library Website, is a good starting point for foreign law research. It is organized by country and includes an overview of the country's legal system and lists the official legal sources. It also includes links to online sources where available.

The <u>International Encyclopedia of Laws: Environmental Law</u>, available electronically from the library catalog (do a title search for "international encyclopedia of laws") and in print at K3585 .E583. Contains detailed background information on national environmental laws and regulations, including summaries of and citations to major legislation.

Two additional free web resources, the World Legal Information Institute and the Environmental Law Alliance Worldwide, have substantial but eclectic collections of foreign law resources, including statutes and case law.

<u>World Legal Information Institute</u> is primarily a project of Australian university law faculties. It covers many areas of law; search environmental law <u>here</u>.

<u>Environmental Law Alliance Worldwide</u> is a coalition of public interest lawyers from around the world. Its Resources Page organizes legal and scientific information regionally and topically; includes selected national laws and cases.

Environmental Law Reporter has an international section, including an International News & Analysis page, searchable by subject, continent, and country.

TREATIES AND RELATED MATERIALS

There are treaties and agreements governing a range of environmental law issues. **ASIL** maintains a database of **International Environmental Treaties and Related Materials**.

Other treaty databases include

<u>Environmental Treaties & Resource Indicators (ENTRI)</u> a collection of treaties and other materials, from NASA and other contributors. It's unclear whether/how often this is updated, but the Treaty Locator is a very useful search tool.

<u>International Freshwater Treaties Database</u>, maintained by the Oregon State University Program in Water Conflict Management and Transformation. A comprehensive collection of water treaties; also includes the <u>Transboundary Freshwater Disputes Database</u>, a wide-ranging collection of materials on water resource management and conflict.

UNITED NATIONS MATERIALS

The United Nations plays a significant role in international environmental law. Many of the treaties and agreements listed above are U.N. sponsored. Other treaties can be found in the <u>U.N.</u> <u>Treaty Collection</u>. This service is available online; while it is rather difficult to search, it has several useful features, including the <u>Status of Treaties</u> (chapter XXVII covers environmental treaties), which lists signatories, ratification dates, and reservations.

The **U.N. Law Collection** from Hein Online is more user-friendly. It contains treaties, U.N. Yearbooks and serial publications, International Court of Justice (ICJ) and International Tribunal on the Law of the Sea materials, and other publications.

In addition, there are three U.N. databases that focus on environmental instruments, including treaties, national legislation and court decisions, and environmental policy materials:

<u>UNEP Environmental Law Instruments</u> includes environmental treaties since 1933 and is a more manageable set than the full treaty database.

ECOLEX is a joint venture of several UN agencies. It is a searchable database of treaties, national legislation, national and international judicial decisions, and other literature on environmental issues.

FAOLEX is a similar database from the UN Food and Agriculture Organization that also includes water and fishing treaties and materials, and FAO publications on international law topics relating to food policy, agriculture, rural development, biodiversity, environment and natural resource management.
