EXTRACT

Par. 90. Pursuant to authority contained in Par. 1 letter headquarters S.O.S., May 1st, 1919, the following named officers now on duty at those Headquarters, having completed their respective duties and their organizations having returned to the United States, will proceed without delay from their present stations to the Bordeaux Embarkation Camp (Girond) reporting upon arrival thereat to the Commanding Officer for transportation to the United States by the first available Government transport:-

- 1st Lt. Otto L. Amsler Hq. Co. 327th Inf.
- 2nd. Lt. Clarence W. Martin 1st. Bn. 321st F.A.
- 2nd. Lt. Frank H. Herrocks Tank Corps.

All officers returning to the United States who do not belong to organizations, will upon arrival at Port of Embarkation, report to the Debarkation Officer on the pier for instructions. If no debarkation office is present they will report to the Commanding General of the Port of Debarkation. Report will also be made by letter to the Adjutant General Statistical Division, Washington D.C. giving date of arrival, authority for the journey and their address.

Compliance with this order after arrival in the United States is subject to such delays as may be imposed by the authorities at the Port of Debarkation, disinfection, quarantine and demobilization.

The requirements of G.O. 188, GHQ.AEF. 1918, G.O. 28 GHQ, AEF, 1919 and Par. 4, Sec. 6 EMB. Instr. 13 Hq. SOS. 1919 will be complied with. The travel directed is necessary in the military service.
