It was undoubtedly Dr. Raz's international reputation as a cognitive neuroscientist and leading hypnosis researcher that inspired the confidence of distinguished authors to submit their manuscripts for publication in MBR. Dr. Raz's expertise in computer technology was also invaluable on more than one occasion, given this journal's online medium. But, on a more personal note, it was Dr. Raz's graciousness and professionalism throughout the process that made working with him a singular pleasure. He managed his editorial duties, meetings, and challenges with characteristic grace and goodwill. It is a mystery to me that he managed to travel the world, publish numerous articles, and keep his family and academic responsibilities going all at the same time. Our profound thanks go to you, Amir, to members of the Raz Lab who assisted you in this process, and to contributors – present and future – to this journal.

A number of other people also played pivotal roles in bringing us to this day. Thanks to Dr. Jim Eliuk, who assisted as a copy-editor, and to Dr. Sylvain Néron, who was a supportive colleague at McGill and the Jewish General Hospital.

Several other individuals helped in more peripheral but vitally important ways to realize this journal. Kent Cadegan, Maureen Gorman, Ian Simpson and Karen Parsonson. Thanks to all of you.

Then something serendipitous happened. At the joint ASCH–SCEH meeting in Dallas in 2007 I first heard that Dr. Amir Raz – who had just wowed conference participants with his morning plenary address – had accepted a Canada Research Chair and was moving from Columbia University in the City of New York to McGill University in Montreal. I was excited by the prospect of having so excellent a hypnosis researcher and clinician in Canada, so, as the Canadian Federation’s representative to ASCH, I approached Amir, congratulated him on his award, welcomed him to Canada and offered to introduce him to our Montreal colleagues by way of making his transition easier. This was the beginning of Amir’s relationship with the Canadian Federation, which was only cordial at first, but culminated in Amir’s acceptance (18 months later) of our offer to become the Editor-in-Chief of our online journal. As he said, “I’d like to give something back to Canada by contributing to Canadian hypnosis.”

It took over two more years of incredible effort on Amir’s part to bring this project to fruition, and it is a testimony to his talent and personal skills that the work of prominent authors now appears in our first three volumes. It is a proud moment for all of us.

A word about language: As a Canadian journal we respect that both English and French are official languages. However, for practical reasons, and as an international journal catering to a wide readership, we offer MBR in English.
