A goal of the institute is to give pre-tenured faculty the opportunity to learn from and discuss with experienced faculty how to establish and manage a research program with undergraduates. While at the institute, participants will also prepare plans for starting and/or advancing their individual research programs at their respective campuses. A range of topics will be covered during the institute, and the specific goals include ways to achieve career success in undergraduate research by learning how to:**

- select undergraduate researchers
- mentor student researchers and develop and use their research skills
- time management - balancing teaching, research and service activities
- develop and select research projects appropriate for undergraduates
- adapt to an undergraduate research environment vs. that in graduate school
- link research to the classroom and

# NSF EPSCoR

## CALL FOR PRE-PROPOSALS

### **Track-2 Pre-proposal submission:**

Oklahoma EPSCoR is requesting Research Infrastructure Improvement Program Track-2 (RII Track-2) pre-proposal submissions, for possible inclusion in the state's RII Track-2 proposal to NSF. This pre-proposal request is made in anticipation of the formal NSF competition announcement, which is expected later this fall.

To facilitate successful pre-proposal planning, the Oklahoma EPSCoR office will hold four general information and Q&A sessions throughout the state. Meetings are scheduled in Tulsa, Stillwater, Norman and Weatherford.

To be considered for inclusion in the formal Oklahoma 2012 Track-2 application, a White Paper must be submitted to the Oklahoma EPSCoR Advisory Committee for review.

The deadline for White Paper submission is 5 p.m. Monday, October 10, 2011.

The formal NSF submission deadline for states' proposals will most likely be March, 2012.

### **Track-1 Pre-proposal submission:**

Oklahoma is making plans to submit a new application in Fall 2012 for continued support through the National Science Foundation's (NSF) Research Infrastructure Improvement (RII) Track-1 Program. Pre-proposals to establish the new scientific research theme(s) are now being solicited.

The current Oklahoma RII Award, which began in September, 2008, supports research infrastructure development in the discipline of cellulosic bioenergy. One-to-two new scientific themes will be selected through the pre-proposal process for the 2012 application. To be considered for the Oklahoma 2012 Track-1 theme, White Papers must be submitted for review by the Oklahoma EPSCoR Advisory Committee.

The deadline for White Paper submission is 5 p.m. Friday, January 6, 2012.

# COMPLIANCE CORNER

## THE PROTECTION OF HUMAN SUBJECTS

The Protection of Human Subjects Committee (PHSC) is SWOSU's Institutional Review Board (IRB) for **any** research activity involving human subjects. This board is mandated by federal law and is charged with maintaining compliance with federal regulations that apply to research involving human subjects.

The **Policy and Procedures for the Protection of Human Subjects (PHS) in Research Activities document** is located on the SWOSU Sponsored Programs web site under Office of Sponsored Programs / Policies and Procedures / Protection of Human Subjects or click on: <http://www.swosu.edu/administration/osp/policies.asp>. It is important to read and understand SWOSU's policy and procedures regarding human subjects.

**Any research activity by faculty, staff, and students involving human subjects or use of data on human subjects** including survey research, questionnaires, or any form of information-seeking documentation, even if it is archived data or reused data, that will be or has been conducted on or in any SWOSU campus or facilities or supported by University resources, **must be reviewed and approved by the PHSC prior to beginning the research.** The PHSC must keep records of all activity involving human subjects for federal auditing purposes.

**Any change in the title of an approved protocol** must be reported in writing to the PHSC Chair prior to the change being made or presented in a public manner. The Chair will approve and record the title change. The PHSC must keep records of all changes for federal auditing purposes.

**Any changes that alter the original intent of a previously approved study will require a new Human Subjects Application to be submitted to PHSC for approval.** Committee approval must be provided prior to the changes taking effect. The PHSC must keep records of all changes for federal auditing purposes.

The **Application to Protection of Human Subjects Committee** (IRB # HS-1) can be located on the SWOSU forms site under Grants and Research / or click on <http://www.swosu.edu/resources/forms/category/grants-research.asp>.

Please review and refer to these important university documents for applicability, definitions, exemptions, etc.

If your research protocol involves health-related participants, health records, health information, or privacy statements, please review the section of the Health Information Portability and Accountability Act regarding health-related research. A link to the **Health Services Research and the HIPAA Privacy Rule Overview** may be located on the SWOSU Sponsored Programs web site under Office of Sponsored Programs / Policies and Procedures / Protection of Human Subjects or click on: <http://privacyruleandresearch.nih.gov/healthservicesprivacy.asp>.

Some projects may not be subject to review by the IRB. If unsure whether a completed Application to Protection of Human Subjects Committee is needed, please submit a **Protection of Human Subjects Committee Preliminary Application** (IRB #HS-4). This application can be located on the SWOSU forms web site under Grants and Research or click on <http://www.swosu.edu/resources/forms/category/grants-research.asp>.
