I. SIGNIFICANT ACHIEVEMENTS

CRIMINAL JUSTICE LEGAL STUDIES:

BRENNEN, DAVID C.- Wrote script for segment of Wills and Probate episode of television show -- THE PEOPLES LAW. Drafted in January, 1990.

BRENNEN, DAVID C.- Recipient of the "Robert Scott Memorial Award" of the Real Property and Probate Section of the Florida Bar. (Lifetime service award only given four times previously.)

BRENNEN, DAVID C.- Florida Legal Assistants, Inc., Certificate of Appreciation--for three years Service as educator member of Certification Board.

COOK, KATHY S.- Prepared one major grant for funding by the United Way and assisted in the preparation of two others.

DUFFEY, JEFFERSON S. and HOLTEN, N. GARY- Successfully recruited a minority faculty member for Criminal Justice.

HEALTH SCIENCES DEPARTMENT:

The programs of Radiologic Sciences, Medical Record Administration, Medical Laboratory Sciences, Cardiopulmonary Sciences and Health Sciences merged into the Department of Health Sciences, July 1, 1989. A chair was named in September. The major thrusts of the Department have been concourses building and organization.

Departmental structure was determined, consisting of the following committee structure:

Personnel Committee
Curriculum Committee
Student Affairs/Academic Standards
Student Recruitment

Curriculum review of undergraduate programs resulted in issuing a 6 course core requirement for the program in Health Sciences.

Curriculum review of the graduate, MSHS program resulted in a significant improvement in the courses offered, a two year published schedule, and an inclusion of Public Administration courses into the electives. (see Appendix II)

The Medical Record Administration site review for accreditation by CAHEA of the AMA was outstanding.

A monthly newsletter has been established in addition to brochures and exhibits for recruitment.

The proposal for a BSHS program was submitted to the BOR. The program included a long term care administration option and an articulation option for A.S. entry level health professions.

Met with Administration of Jewett Orthopedic and received verbal commitment for 2 senior scholarships.

One new clinical education center was added.

DEPARTMENT OF COMMUNICATIVE DISORDERS:

Again, 100% of the speech-language pathology students passed the ASHA NESPA (Boards) Exam in 1989/90. A poll taken of other programs in Florida indicated that, again, UCF has the highest NESPA pass rate in the State.

A "new" curriculum was developed at the bachelors and masters (speech pathology) level. While being consistent with ESB/ASHA guidelines the new curriculum should assure that UCF stays abreast of changes in the field and that the quality of the UCF graduate remains first-rate. Members of the community were involved with curriculum changes and endorse various modifications. Faculty endorse curriculum changes as well.

Clinic revenues moved from less than \$500 to \$12,271, on May 22,1990. Clinic revenue will be used to provide various "quality" items in the program, e.g. faculty/staff travel, clinic materials and guest lectures.

1989/90 was a good year for continuing education offerings. In conjunction with the College of Extended Studies, the Department offered the first in a sequence of Neuro-Developmental Training (NDT) courses. The course was closed at 65 attendees with 15 individuals on a waiting list. Further courses will be offered in 1990/91. These courses were developed as a response to community request. An NDT advisory board is in place and

functioning nicely. Collaborative CE workshops were also conducted with Devereux Hospital in Melbourne. The Department continued to collaborate with the four part FDOE "Weekends with the Experts" CE series. This is the #1 CE event in the State each year.

While the Daytona Beach Extension program was not continued due to insufficient enrollment, Brevard County requested establishment of an M.A. program in speech-language pathology. Working with Dr. Bob Westrick and Ms. Pam Treadwell, Brevard Schools, the program was approved.

Fall semester saw the Department complete it's academic audit for Dr. Altman. The report is on file. In short, the Department is a unidimensional teaching unit at this time. The goal for the future is more research.

NURSING

The NLN self study report, under the coordination of Dr. Frances Smith was completed in early January. An on site visit from the Board of Review of the NLN Council of Baccalaureate and Higher Degree programs was conducted to verify the report and their findings were very positive. The report is sent to the Board of Review for the meeting in October, 1990 when it makes its decision about reaccreditation.

The College of Health and Professional Studies honored Dr. Frances Smith as the Outstanding Teacher of the year.

The Nursing Departments Faculty received the following awards and or honors:

1989 FNA/AJN Award for Excellence in Writing awarded to Shelly Conroy.

Dr. Jean Kijek was presented an award for video production from the Florida Nurses Association.

Dr. B.J. Primus was appointed a Trustee of Daytona Beach Community College by Governor Martinez. She also served as a member of the board for the National Black Nurses Association. In addition, Dr. Primus developed and coordinated a major workshop on grantsmanship for minority and disadvantaged populations. It was conducted in cooperation with Florida A & M University and the Division of Nursing of the U.S. Department of Health and Human Services.

Diane Wink was the local coordinator for the National Maternal Child Nursing convention. This activity brought additional national visibility to the Department.

The RN-AA-BSN project was funded by Orlando Regional Medical Center for \$50,000.00 per year for 5 years. This project is designed to provide on site counselling and instruction for RN's to study for the BSN.
