Recheck urged for mischarged calls

There has been a recent rash of illegal, third-party long-distance phone calls which have been charged to various UCF administrative phones, it was emphasized this week by Bill D. Morris, director of University Operations

A person, or persons, are calling the Southern Bell toll operator and asking that their calls be charged to various administrative phones," Morris explained.

He said Southern Bell officials have asked for verification of suspicious calls that would have been charged to Purchasing, Computer Services and academic areas, Morris said.

Respiratory therapists recognized

Thousands of men and women, who have earned the gratitude of countless patients facing death from failing hearts or lungs, will receive overdue recognition Nov. 7-13, which has been proclaimed "Respiratory Therapy Week" by President Ronald Reagan.

'Its's been a long time coming, and I'm happy to see therapists recognized for their contribution to health care," said Bob Rogers, administrative director of respiratory therapy at Orlando Regional Medical Center. "Therapists have played an integral role in patient care for 30 years."

The significance of "their" week is not lost on students and faculty in the respiratory therapy program at UCF, which offers the only four-year degree of its kind in the state. Success of the program is due in large part to the reception it has earned in the community from health professionals.

A unique feature in the UCF respiratory therapy curriculum are internships with Orlando Regional Medical Center, Florida Hospital, Orlando General Hospital and Lucerne General Hospital. For 24 weeks, in two-week intervals, students rotate among various specialty areas-neonatology, pediatrics, adult critical care, home care, x-ray, emergency room, cardio-pulmonary

'UCF graduate interns are an indispensable part of hospital care and our routine program," said Rogers. "UCF has one of the most progressive respiratory therapy programs around."

Rogers graduated from UCF in 1971 with a degree in respiratory therapy and was program director for respiratory therapy at UCF from 1972 to 1977.

Today's respiratory therapist performs a variety of professional services within a hospital, but the most challenging role involves working with critically ill patients. Emergency resuscitation using external heart massage and artificial ventilation (better known as respiration) is one of the therapist's most important

"If you have a child who has had an asthma attack and had to be hospitalized, if you have had a heart attack or been in a car accident and hospitalized, then you know what a respiratory therapist is," said Sharon Douglass, associate director of the respiratory therapy program at UCF.

Friends' gifts welcomed for Millican Chair

The public phase is under way for contributions toward the University's obtaining \$600,000 to establish the Charles N. Millican Endowed Chair of Computer Science.

This million-dollar endeavor, well on its way, is being opened to the community at this time to permit administrators, faculty, staff at the university, as well as the community-at-large, to participate in the effort that will honor this university's founding president.

"Charles Millican is a special person to alumni, faculty, staff and friends of UCF, and we know there are many who want to be part of the establishment of this special chair," noted Dr. Louis C. Murray, chairman of the establishment committee.

Murray said the Millican Chair has two important reasons going for it: first, it will be the Southeastern region's only such chair in computer science (and third in the nation); and secondly, the state will provide the final \$400,000 of the \$1 million goal.

"If any of you care to reflect, in perpetuity, your esteem for a man who did so much for UCF, please join the many others by making your contribution today," Murray urged. "Your gift, regardless of size, is important—to us, as it is you."

Any faculty member who is interested in submitting a grant proposal to the Department of Defense University Research Instrumentation Program for the acquisition of equipment to support basic research is asked to contact the Division of Sponsored Research as soon as possible.

The program requires a reasonable cost share from university, industry, state or local sources. Prioritization of proposals for funding by DOD will largely depend on this cost-share factor. To improve your chances of funding, it is recommended that matching funds be obtained from industrial sources whenever possible.

The DSR office will assist you in locating and contacting appropriate sources of match. However, because these contacts must be made prior to submitting the proposal and tend to take several weeks to fully negotiate, it is important that I be contacted immediately if you are planning to apply to this program.

Subject: UCF Foundation Awards for Excellence

I am pleased to announce that this year the UCF Foundation will continue its program to recognize excellence among the faculty through two \$1,000 awards, one for excellence in teaching and the second for excellence in research and creative scholarship.

In addition, those faculty selected by their peers as candidates for these awards in each area but not selected to receive the \$1,000 award for excellence, will receive a plaque in recognition of their substantial achievement. These awards will be presented at the annual meeting of the Foundation in March. Previous recipients of the awards will not be eligible for consideration for the same award within five years of the time that an award was last received.

The nomination and selection procedure to be followed provides for nomination and selection procedures to be followed provides for nomination of a maximum of one candidate for each category.

Procedure for 1982/83

- 1 No more than one nomination in each category from each college (except for the College of A&S which may submit two nominations) and one from the Florida Solar Energy Center in research, may be submitted to the Office of Academic Affairs by Jan. 14, 1983. Each college (or FSEC) will select its nominee in each category through a peer review procedure and based on nominations from faculty, students, alumni and self-nomination. The peer review procedure for each college will be determined by the Dean of the College in consultation with the college faculty and administrators. Approval of the procedure by the Vice-President for Academic Affairs should be obtained no later than Jan. 3, 1983.
- 2 Each nomination must include pertinent supporting documents as evidence of Excellence in Teaching or

Publication of these memoranda and announcements about University policy and procedures constitutes official notice to faculty and staff

research and Creative Scholarship. Each documentation may include: vitae, bibliographies of publication and presentations, abstracts or research or special instructional projects. Special media material or other items too large to be included may be referenced in an appendix. The person nominating the candidate should prepare the best possible documentation in support of their nominees. The final selection will be made on the basis of that documentation, therefore, it is not realistic to anticipate that data and qualifications not in evidence will be considered on the chance that it might be known by those reviewing recommendations submitted.

- 3. The Dean of Undergraduate Studies will convene the Learning Resource Council to review the college nominees for the teaching award and the Vice President of Research will convene the Research Council to review the nominations for the Research and Creative Scholarship awards. Assuming that qualified and acceptable candidates are nominated, it is anticipated that these councils will each select one member for the respective awards.
- 4. The UCF Foundation will be provided with a list of all nominees and informed of the panel's selection in each category. Awards will be made no later than the annual meeting of the Foundation (usually in March).

Excellence in Research and Creative Scholarship Criteria

- Candidates must be classified as faculty in tenure-earning positions or their equivalent (Asst. Prof., Assoc. Prof., Prof.) and FSEC research etc., and have been on the faculty of UCF for at least two academic years.
- 2. Candidates must be productive, creative scholars. Evidence of performance, especially at UCF, of productive research or of creative scholarship may include (but need not be limited to):
 - a. Appropriate publications in recognized journals.
 - b. Publication of scholarly books.
 - c. Recent presentations of scholarly work before peers.
 - d. Recognition by peers in the discipline such as awards, membership on distinguished panels or boards or being made a "Fellow" in a national society.
 - e. Recognition of creative work (art, music, etc.) by special "shows" or concerts, etc.
 - In the sciences and engineering, grants and research contracts awarded.

Excellence in Teaching Criteria

- Candidates must be classified as faculty in tenureearning positions (Asst. Prof., Assoc. Prof., Prof.) and have been on the faculty of UCF for at least two academic years.
- Candidates must have been assigned at least 0.50 FTE to instruction for the academic year prior to the one in which the award is made.
- Candidates must be innovative, stimulating and effective teachers. Recognition of excellence in teaching has always been difficult to measure; however, the following plus other appropriate materials, may be submitted as evidence in teaching.
 - Favorable student, peer and administrative evaluations.
 - b. Previous awards, honors, etc., received in recognition of excellence in teaching.
 - c. Recent publications or presentations which relate to college teaching methodology or technology.
 - d. Evidence of extra effort to improve instruction. This may include the development of course materials, media, experiments of methodology or the development of new and stimulating courses.
 - e. Evidence of leadership in developing new and innovative instructional areas.
 - f. Evidence of a sustained period of excellence in teaching

In recognition that exceptional circumstances may arise, variations in the above mandatory criteria in either category may be accepted if adequately justified.
