How the Annual Fund Supports UB Law

B Law School is a public institution, supported by the State of New York; however, state support amounts to just 31 percent of the school's annual budget. Tuition and student fees, interest on our endowment, and grants make up another 57 percent. That leaves 12 percent of the Law School's annual budget provided by our generous alumni and friends. Without that 12 percent – clearly a monumental component – it would be impossible for the Law School to provide the student support, educational program and up-to-date infrastructure that keeps the school a leader in legal education.

A foundation for learning


UB Law's curriculum remains one of the most distinguished in the nation, allowing for smaller class sizes, innovative courses and specialized concentrations. The Annual Fund provides vital instructional resources, allowing the academic program to further evolve each year.

Constructing technique

UB Law is one of just a few law schools in the country to house a fully functioning courtroom. Our students can watch judges and lawyers at work in O'Brian Hall – a valuable opportunity to see law practiced first-hand. This state-of-the-art courtroom can accommodate appellate arguments as well as trials, and offers an incomparable practice environment for trial technique and moot court competition. Alumni giving made the completion of this project possible.

Anchoring a solid student body

Alumni gifts provide monies to fund our highest priority – helping bright, well-qualified students fulfill their dreams of obtaining a quality law degree. Last year, a significant portion of the Annual Fund was distributed to deserving students through scholarships and loans.
