


THE FIRST WORLD WAR IN THE CITY OF PORTO

INTRODUCTION

First World War began in 1914 and ended in 1918 [1, 2]. Portugal went to war through the CEP – Expeditionary Portuguese Body – in Flanders between November 1917 and April 1918 [3]. This intervention have direct impacts on population daily lives, resulting in profound changes in multiple dimensions of Portuguese society, mobilizing a male contingent in an active age. This demographic change results in a restructuring of the women role in society. Porto, as a coastal and maritime municipality, sees the war closely [4]. This research intends to share, supported in bibliographical and documentary evidences, the reality of the city in 1917 and in what way its participation in the war affected their dynamics.

OBJECTIVES

The main objectives of this work were:

- Analyze and explore the documentary heritage of the Great War period in Porto;
- Establish connections between the state of art and the quotidian's during the war presents in the documentary heritage;
- To know the quotidian's and sociability's of Porto in the year 1917.

METHODS


Document analyze – historiographic research

Four funds consulted at ADP – Porto District Archive:


- Immigrant Passport Processes and letters of call;

Description: A husband writes to his wife explaining his situation in Brazil. Tell him that he awaits her arrival on the steamboat where he will ask about her behaviour during the trip.

Description: A child is admitted as a disabled because her mother is trapped in jail and does not have milk to breastfeed.

Description: An exchange of correspondence between the Porto Chamber and the collective transport company in which it denies the decrease of the payment of the rent due to the increases provoked by the entrance of Portugal in the war.

CONCLUSIONS

The historiographic analyse show a city marked by emigration and families hoping for a better future. Even in war, the city continue to create companies and public transports continue to be assumed as main tool to circulate in the city. Although this evidence, many of those live in poor conditions, with a high poverty level. The last hope of many children to survive was their admission to the Exposed Hospice (an institution with the mission to host abandoned children), but most died shortly after admission.
