**RELATIONSHIP TO THE PROGRAM:**

This course is intended for the Licensed Practical Nurse who wishes to continue his/her education toward an Associate of Science in Nursing. This course will include complexity of clients consistent in for the Registered Nurse caring for clients in unpredictable circumstances in Psychiatric, Mental-Health.

**COURSE DESCRIPTION:** This course presents principles and practices related to the holistic nursing care of individuals and families across the lifespan. The course focuses on the continued development of the nursing process to address psychosocial needs. Concepts include the helping relationship, specific mental health illnesses, crisis intervention, and specific nursing therapies related to treatment.

QSEN (Quality and Safety Education for Nurses) is being integrated throughout the curriculum. This was initiated in Fall 2012 with safety and will continue until all competencies have been integrated. QSEN has evolved from the landmark IOM report "To Err is Human" published in 2000.\* The six QSEN competencies are: safety, patient-centered care, teamwork & collaboration, evidenced-based practice, quality improvement, and informatics. There are a total of 162 KSAs (knowledge, skills, and attitudes) associated with these six competencies that will be introduced with the competencies. There will be QSEN assignments that will be due throughout the semester. Due dates are posted.

**EXPECTED STUDENT PERFORMANCE OUTCOMES:**

Upon completion of this course, the student will be expected to:

**1. PROFESSIONAL BEHAVIORS**

- Prepare and complete clinical documentation for the Psychiatric-Mental Health client demonstrating completeness and recognition of complexity of client circumstances.
- Demonstrate professional behaviors and health care practices consistent with nursing care of clients and families across the life span with emphasis on the psychosocial needs.

**2. COMMUNICATION**

- Employ the principles of therapeutic communication in order to establish a therapeutic interpersonal relationship with patients and families.

- Demonstrate effective communication methods to ensure relevant, complete and accurate reporting methods to members of the interdisciplinary mental health team.
- Timely completion and accurate entry into medical record with awareness and compliance to facility policy regarding confidentiality, HIPPA, and faculty approval.
- Apply the nursing process to enhance therapeutic communication.

### 3. ASSESSMENT

- Demonstrate an accurate, comprehensive physical, psychosocial, and functional nursing assessment of Psychiatric-Mental Health clients with demonstrated ability to evaluate outcomes and respond within the scope of the ASN.
- Apply the nursing process as a dynamic tool to assist in meeting the psychosocial needs of patients and families.

### 4. CLINICAL DECISION MAKING

- Demonstrate safe nursing care within the guidelines of the Student Nurse Handbook and clinical facility policy and procedures.
- Demonstrate and provide evidence-based or best practice to support clinical decision-making in the role of the ASN.

### 5. CARING INTERVENTIONS

- Demonstrate and provide caring, protective and dignified care to psychiatric clients across the lifespan with respect to values, customs and habits.
- Integrate nursing care within the framework of legal, ethical and regulatory requirements.
- Demonstrate support to client and significant support person(s) during specific mental illnesses and life altering events such as drug dependency and end of life issues.
- Function as advocate for client and family members as related to mental health issues.

### 6. TEACHING AND LEARNING

- Demonstrate knowledge of specific mental illnesses, medications and nursing treatments.
- Apply knowledge of mental illnesses and recommended treatments in the provision of a physically and psychologically safe environment for patients and families.
- Demonstrate knowledge of the variety of mental health settings and practice areas available to assist clients in meeting their needs for psychosocial health.
- Demonstrate teaching methods appropriate to the diverse needs and culture of the client, family and community.

- Create, implement, and evaluate a teaching plan.

#### 7. COLLABORATION

- Demonstrate knowledge of the registered nurse as a member of the interdisciplinary mental health team.
- Utilize and demonstrate effective use of reporting tools to ensure continuity of care. This includes the use of the DSM IV/V classification tool and complete report of client status to the interdisciplinary team.
- Function as a member of the interdisciplinary team.

#### 8. MANAGING CARE

- Provide culturally congruent client care, with regard to ethnicity, race and diversity, in the meeting of client's psychosocial needs.

### **COURSE POLICIES AND COURSE/CLINICAL EVALUATION**

1. Policies related to attendance, tardiness, class participation, missed examinations or assignments, academic dishonesty, grading, Grade Appeal Procedure, and support services are included in the Nursing Student Handbook.
2. Students are expected to make a proactive, consistent, active, and responsible effort to attend all clinical experiences as part of their professional behavior development.

#### **Attendance Policy**

Regular attendance is expected, and will be taken every class meeting. Lack of attendance will adversely affect final grades. If a student misses a class session then the student has the option of submitting a written synopsis covering the content and theme of that particular class. A student may miss up to two class periods, submitting written review of the class content, without penalty but the third and each absence thereafter will result in the loss of one full letter grade to the final course grade. Tests are to be taken on the day scheduled, or submitted by the announced due date. Late assignments will only be accepted if the student notifies the instructor before the due date. An assignment that is more than 24 hours late, regardless of prior notification, will have a 10% reduction to the final grade for that assignment. Less than 32 hours of clinical will result in failure of the clinical portion of the class.

#### **Academic Conduct**

All students must practice academic honesty. Academic misconduct, including plagiarism and classroom misconduct is subject to an academic penalty by the course instructor(s) and/or a disciplinary sanction by the University.
