COURSE DESCRIPTION

The Chamber Chorale is a select mixed ensemble specializing in advanced literature from a wide variety of styles, periods, and cultures. Students will learn to perform choral music in a stylistically appropriate manner, with an emphasis on the technique of singing and musicianship. The highest levels of artistic singing will be sought through daily rehearsals and individual preparation outside of class. The Chamber Chorale also undertakes recruiting tours and other on and off-campus events.

As a part of the Chamber Chorale you may be the only representative of the UM choral program that many community members ever meet. Therefore, it is imperative that each singer maintains the highest standards of academic, personal and musical excellence.

LEARNING OUTCOMES

The student will...

- ...increase his/her fluency of reading at sight through weekly rehearsals.
- ...display growth in technical skills of singing and musicianship while gaining greater collaborative competence and knowledge of the choral repertory through regular ensemble experiences.
- ...gain a greater understanding of the common elements and organizational patterns of music through ensemble rehearsals and self-directed practice.
- ... be able to form and defend musical decisions made during the individual preparation of music.
- ...acquire an acquaintance with choral repertoire from several historical and stylistic periods through preparation and performance.

REGISTRATION

All ensembles in the School of Music satisfy one credit from Group IV: Expressive Arts, of the General Education Requirements. Freshmen and sophomores need to register for MUSI 112A, Section 02. Juniors and seniors should register for MUSI 312, Section 02.

ATTENDANCE AND GRADING

You are a member of one of the most elite choral ensembles in the state. As such, a high expectation of attendance and individual accountability must be maintained. Each student is allowed two absences. These absences should be used for emergencies only. Any absence over two for the semester may result in removal from the group. Excused absences will only be granted for university-sanctioned required events (tours, etc.). In all cases, I expect you to contact your section leader and/or me in advance of any anticipated absence. Failure to do so will result in an unexcused absence, regardless of the reason for the absence. Attendance for all items in **bold** under the "Class Schedule" section are mandatory. Missing these events may be grounds for failure and/or removal from the group.

Each member of the ensemble is responsible for his or her own part. Singers who do not know their music, who come unprepared, late, or not at all will be graded accordingly.
