**HOMEWORK:**

All but the assignments for the day preceding an exam will be collected. Assignments will be reviewed for format, neatness, completeness and evidence of effort, but not "correctness". Late homework will not be accepted. You are encouraged to make corrections on the assignments (using a different color pen or pencil) as it is discussed in class. Assignments may change with advance notice. You are responsible for these changes.

Completion of the assignments prior to each class period is an absolute necessity for the successful completion of this course and the fulfillment of criteria (b) for grading above. Students will be asked to provide answers to the homework problems during the class discussions. The answer key to the homework problems will be posted on the GBB computer system on the day after completion of a chapter. You can access it only in the GBB Labs at Sentinel/Classes/JWeber/ACCT 311. If you lose this syllabus, there is also a copy posted there.

**NOTES:**

I will ONLY sign drop slips after October 14, the last day to drop/add courses per the class schedule calendar, and before December 6, the last day to petition for a drop, if it is accompanied by a signed statement from your advisor indicating that you have decided to change your finance track (for finance majors only), or a petition to change your major or School of Business option area (for all others).

To be enrolled in ACCT 311, you must have completed 60 semester credits and have completed all business school freshman-sophomore requirements. You will be required to verify that you have satisfied these requirements by September 19th. In order to fulfill this requirement, you must provide the instructor with a copy of your U of M transcript with the appropriate courses highlighted. If you are a transfer student, you need also submit a copy of your transfer evaluation form. If you are unable to satisfy this requirement, you must obtain the permission of the instructor, or you will not be allowed to take the first exam and continue your enrollment in ACCT 311. To obtain the permission of the instructor, you must state your case IN WRITING in advance of the September 19th date. The freshman/sophomore requirements are: Enex 100, Comm 111, Math 117 & 241, Econ 111 & 112, Badm 201 & 202, Badm 257, Badm 270.
