### COURSE DESCRIPTION

This course provides an overview of the structure, processes and policy outputs of the U.S. legislature. My goal is for you to become familiar with the theoretical foundations and historical evolution of the legislative branch, to understand the dynamics of Congressional elections, and to develop a working knowledge of Congress as an institution, including procedures, rules, party dynamics, and leadership.

During the second half of the term, we will focus on the politics of policymaking in Congress. This will require an examination of the other actors and institutions that help shape national policy output. Interest groups are key players in the policy process, as are the Executive and the Bureaucracy. We want to understand the dynamics of the interaction between Congress and these other actors and institutions. The goal of this section is for you to clearly grasp the 'why' behind the scope and substance of national policy in America today.

### COURSE REQUIREMENTS

Students are responsible for all course readings and lectures. Exam questions will be drawn from both these sources. Your grade will be based on two take-home essay exams, a series of short, weekly notebook assignments, and a group project, to be discussed in-depth the first day of class.

Take-home exams will be 5-7 typed, double-spaced pages. Notebook assignments will consist of a weekly take-home question that requires you to integrate the course readings that cover the following week's topic. Notebooks will be collected periodically, without notice.

Attendance can affect your final grade. You will be allowed 3 unexcused absences. After that, each unexcused absence will result in the lowering of your final letter grade by 10 points. On the other hand, if your final grade is on the borderline between two grades, regular attendance will be weighted in your favor.

The class will be organized around lectures, discussions, and group activities. This is a participatory course. You are required to keep up with the assigned readings and attend class each day.

Grades will be assigned according to the standard +/- grading system.
