8 Whereas, the 2012-2013 The Associated Students of The University of Montana (ASUM) Senate
9 devoted significant amounts of time and resources in order to secure funding for a new building
10 for the Missoula College;

12 Whereas, these efforts resulted in an appropriation of \$29 million from the 2013 Montana State
13 Legislature;

15 Whereas, the President's Office recently expanded the list of locations under consideration for the
16 Missoula College to two, those being:

- 17 • South Campus
- 18 • East Broadway

20 Whereas, ASUM represents the interests of students from the Mountain Campus as well as the
21 Missoula College;

23 Whereas, the proposed Missoula College building and its location directly impact the welfare of
24 ASUM's constituency;

26 Therefore, Let It Be Resolved, that ASUM endorses construction of the Missoula College at the
27 East Broadway location;

29 Therefore, Let It Be Further Resolved, that ASUM designates President Asa Hohman as the
30 spokesperson for its position regarding Missoula College;

32 Therefore, Let It Be Further Resolved, that President Asa Hohman communicates the position of
33 ASUM regarding the location for the new Missoula College to The Montana Kaimin and The
34 Missoulian.
