9           Whereas, the Associated Students of the University of Montana (ASUM) is bound by its Fiscal  
10          Policy;

11  
12          Whereas, ASUM Fiscal Policy Section 17, Subsection 1 states:

13  
14          “17.1 Generated funds **MUST** be deposited with the ASUM. The organization may use its  
15          discretion as to how they would like this money budgeted, and these funds shall be allowed as  
16          carryover at the end of the fiscal year.”

17  
18          Whereas, there is ambiguity in this section;

19  
20          Therefore, Let It Be Resolved, that Section 17, Subsection 1 of ASUM Fiscal Policy be amended  
21          to read:

23          “17.1 Generated funds **from recognized ASUM agencies and student groups must MUST** be  
24          deposited with the ASUM. ~~The~~ That organization may use its discretion as to how they would  
25          like this money budgeted, and these funds shall be allowed as carryover at the end of the fiscal  
26          year.”
