The Associated Students of The University of Montana Resolution Regarding the Blackfoot Clearwater Stewardship Act November 30, 2017 SB26 17/18

Whereas, The University of Montana is a national leader in research and education related to management of wildlife and federal public lands;

Whereas, In 2005 a diverse group of stakeholders came together to create the Blackfoot Clearwater Stewardship Project, a collaborative group focused on restoration, recreation, and responsible timber harvest on federal public lands near Seeley Lake and Ovando, MT;

Whereas, The Associated Students of the University of Montana (ASUM) endorsed the Blackfoot Clearwater Stewardship Project, now called the Blackfoot Clearwater Stewardship Act of 2017, on two previous occasions;

Whereas, To date, the Blackfoot Clearwater Stewardship Project, via the Southwest Crown Collaborative, has invested \$33 million dollars and created or maintained 138 jobs annually in the Seeley and Ovando areas;

Whereas, The Blackfoot Clearwater Stewardship Act of 2017 encourages forest restoration by conducting a comprehensive landscape assessment, scheduling restoration projects, and increase funds available for restoration projects;

Whereas, The Blackfoot Clearwater Stewardship Act of 2017 would make additions to the National Wilderness Preservation System by designating 80,000 acres of National Forest land as part of the Bob Marshall, Mission Mountain, and Scapegoat Wilderness Areas;

Whereas, the Blackfoot Clearwater Stewardship Act of 2017 would increase recreation opportunities by designating special management areas for mountain biking and snowmobiling and instructing the Forest Service to complete a trail development;

Whereas, More than 80 businesses and organizations, as well as Missoula County, Powell County, and Lewis and Clark County, have voiced their proud support for the Blackfoot Clearwater Stewardship Act of 2017;

Whereas, The Blackfoot Clearwater Stewardship Act of 2017's accomplishments and positive impact should receive the support of Montana's Congressional delegation;

Therefore, Let It Be Resolved, That ASUM endorses the Blackfoot Clearwater Stewardship Act of 2017;

Therefore, Let It Be Further Resolved, That ASUM urges the United States Senate Committee on Energy and Natural Resources, which includes Senator Steve Daines, to vote in favor of the Blackfoot Clearwater Stewardship Act of 2017;

Therefore, Let It be Further Resolved, That if the Blackfoot Clearwater Stewardship Act of 2017 passes the United States Senate Committee on Energy and Natural Resources, ASUM urges Senator Steve Daines to vote in favor of the Act;
