8 Whereas, The Associated Students of the University of Montana (ASUM) hire a director to run
9 the ASUM Sustainability Center and oversee sustainability focused efforts;

10
11 Whereas, The aforementioned position is under the discretion of the Senate body and its
12 committees;

13
14 Whereas, ASUM has multiple committees with one, called the Sustainability Board, specifically
15 designed to oversee, and set out to accomplish sustainability focused goals;

16
17 Whereas, The Sustainability Center Director serves as an ex-officio on the Sustainability Board;

18
19 Whereas, The Student Political Action Committee is charged with working on legislative goals
20 of the Students of the University of Montana (UM) and ASUM;

21
22 Whereas, Section 20. D, of the ASUM Bylaws reads:

24 *The SPA Committee shall serve as an advisory board to the ASUM Sustainability*
25 *Coordinator, providing guidance and supervision.*

27 Whereas, This section of the Bylaws gives the Student Political Action Committee the role of
28 advising the Sustainability Center Director;

30 Therefore, Let it Be Resolved, That Section 20. D, of the ASUM Bylaws be changed to read:

32 *The Sustainability Board Committee shall serve as an advisory board to the ASUM*
33 *Sustainability Coordinator, providing guidance and supervision.*

35 Therefore, Let it Be Further Resolved, That this Resolution be forwarded to Braden Fitzgerald,
36 President of the Associated Students of the University of Montana; Meredith Repke, Director of
37 the Associated Students of the University of Montana Sustainability Center.
