Writing Assignments

Students will prepare one-page outlines of their assigned volume for each seminar to be distributed to fellow students and the instructor. The outline should summarize the author's key points. Weekly seminars will consist of student summaries of their respective assignments and discussion.

Students will then submit a five-page critical essay identifying major themes (limited to one or two) addressed in their assigned volume and critically evaluating the book's strengths and weaknesses. Critical essays are due one week after each seminar.
