Materials

Music will be provided by the instructor. Each student must bring a writing utensil to rehearsal. Recording devices are strongly encouraged.

Course Description

UM Cabaret is a performing ensemble showcasing students' talents in musical theatre performance. Each semester culminates in a public performance. The Spring 2016 Cabaret is entitled "Deadly" and will include musical theatre songs that somehow relate to the seven deadly sins. Students will have the opportunity to perform solos and group numbers, as well as learn audition techniques and personal marketing skills.

Expectations

It is expected that you show up to class on time, with music, prepared for what is on the schedule. Outside work is crucial to the success of our final show. After you are given your music, it is expected that you learn notes, rhythms and lyrics on your own to the best of your ability. After you rehearse your song in class, it is expected that you begin working on memorization. All songs must be memorized by Thursday, March 31. Instructor will be available for outside solo work, and may ask students to sing more music than what is listed on the course schedule, provided they can work out rehearsal time. Registration for this class is required, unless written consent of the instructor is

given. Finally, support of your fellow classmates is essential to creating a positive group dynamic. Please be kind and welcoming to one another.

Grading and Attendance

Grades are based on participation and attendance. If participation is lacking, not only will the grade suffer, but the student may be asked to forfeit solos in the final performance.

Attendance at all called rehearsals is mandatory. For every unexcused absence, the grade will drop a full letter grade. Two tardies is equivalent to one unexcused absence.

Excused absences will be accepted at the discretion of the instructor. Absences because of departmental conflicts must be accompanied by a note from a faculty member. Illness is considered excused, but please give as much notice as possible, to facilitate rescheduling of rehearsal.
