8   Whereas, The University of Montana (UM) Food Pantry has been absorbed by the Associated Students of  
9   the University of Montana (ASUM) Renter Center;

11   Whereas, The Food Pantry Student Coordinator needs to be added to the ASUM Personnel policy because  
12   they are now a Renter Center employee;

13  
14   Therefore, Let It Be Resolved, That the following be added to Section 3.0 Base Rates under Off-Campus  
15   Renter Center at a base rate of minimum wage plus one dollar with 60-72 monthly hours;



17   Therefore, Let It Be Further Resolved, That the following be added to Section 4.74;

18           The University of Montana Food Pantry Coordinator will: manage operational logistics of the  
19           pantry, recruit and manage volunteers, including University of Montana students, oversee food  
20           donations, work with the Food Pantry Program Board to raise funds and manage the pantry's  
21           finances, promote the resource to students at UM and Missoula College's campuses, maintain  
22           confidentiality, and coordinate with on and off-campus partners including Missoula Food Bank  
23           and the Montana Food Bank Network.;

25   Therefore, Let It Be Further Resolved, That the current Section 4.74 be amended to read "Section 4.75";

27   Therefore, Let It Be Further Resolved, That this resolution be sent to: Jordan Lyons, Director of ASUM  
28   Renter Center; Adrienne Smith, Director of the UC.
