Focus:

Law is common and yet distinct of everyday life in modern societies. This course examines the central features of the law as a social institution and as a feature of popular culture. We will explore the nature of law as a set of social systems, central actors in the systems, legal reasoning, and the relationship of the law on society and vice versa. The course will be taught from the perspective of the instructor, who is a local government attorney and prosecutor in western Montana.

Grading/Weight:
