# Preparing for the Clerkship Interview

With clerkship application season in full swing, it's time to think about the potential next step: The Interview. This brief overview is meant to give you some perspective on what to expect in the clerkship interview process. It also reinforces the golden rule that you should only apply to a judge for whom you would want to clerk.

### **Scheduling the Interview:**

Judges typically contact between six to a dozen applicants out of the hundreds of applications they receive. You may hear from judges at any time after you submit your application. Be prepared to travel at a moment's notice to meet with judges in person. Generally, the administrative assistant will call to schedule an interview. If you receive a message, call back promptly. Avoid trying to strategically schedule interviews (i.e., scheduling a judge later hoping your "top choice" calls). When scheduling your interview, do not miss the opportunity to gather information from the clerk or secretary. Remember to ask:

- Expected length of the interview
- General format
- Other people with whom you will be meeting

Without overstepping, use your lawyering skills here and ask open-ended questions such that the answers may provide insight into the interview style (see more on style under interview preparation). And remember: Everyone you deal with in the judge's chambers can be an important ally!

### **Interview Preparation and Research:**

Gather more information on the format, style and substance of the interview. This can vary greatly. Some judges take a rigorous tack, grilling you on the substantive law, while others take a more casual approach. Talk to former clerks, people who have interviewed with the judge, a research librarian, and see data collected by the Law Review and the Career Services Office (CSO).

As with any interview, you should be intimately familiar with, and prepared to discuss at length, every detail contained in your written application materials.

Undergo a second round of research. You should also know plenty of information about the judge with whom you are interviewing, including having read many of the judge's opinions prior to your interview. Read the Almanac of the Federal Judiciary for that judge. Do a LEXIS or WESTLAW search of the most recent

cases decided by this judge. (See a research librarian if you need assistance.) Consult news media resources for any recent news on the judge or his/her initial appointment or election to office. Read the clerkship handbooks available in the CSO to get a flavor of the atmosphere, ethics and protocol in a judge's chambers, as well as some general tasks of a law clerk. Read up on blogs like lawclerkaddict.com for demographic information. (See "Top Clerkship Research Resources").

Bring with you a packet of all the information you have gathered on the judge. Also include your own materials, any new grades, activities or honors received, an additional writing sample along with a list of references and their contact information. Contact your references to tell them of your upcoming interview and your desire to clerk for the judge.

### **Interview Content:**

There is no standard format. The length may range from 15 minutes to several hours. The judge will almost certainly be looking for personality and fit. Unlike a law firm interview, practically anything could come up in an interview. The dialogue could include anything from your law school courses to your political leanings to news events or important legal precedents. Demonstrate that you have read the judge's opinions, even if the judge doesn't bring them up. Be prepared for the questions a judge may ask and have plenty of questions for the judge ready.

Offers may occur on the spot or soon after the interview. Usually the judge will call you personally to make the offer. Do not keep judges waiting for your acceptance or denial. Go into the interview prepared to accept if you are made an offer.

### Withdrawing Applications

If you do receive and accept an offer, you must send a letter to all of the other judges to whom you've applied withdrawing your applications. If, for some reason, you decide you do not want to clerk for a particular judge, you should withdraw your application.

# Library Profile: Dan Manier

Dan Manier, Director of Law School Technology, is a true son of Notre Dame, being part of the Notre Dame family all his life. He is not only a "Double Domer" with a BA in Sociology and Business in '87 and an MNA in '93, but he carries the University's French origins in his veins and the fighting Irish spirit in his soul. His father, a Notre Dame Professor of Philosophy from 1959-2008, is of French descent and his mother was born in New York City to Irish immigrants from County Cork, the "most" Irish Catholic County in Ireland.

When Dan graduated from Notre Dame in '87, personal computing was in its infancy and schools were

just beginning to adopt them in large numbers. At that time, too, Dan's mother was terminally ill so after graduation he chose to stay in South Bend and work for a local computing consulting firm providing technological support and consultation to K-12 schools, universities, and colleges. "It was a nice opportunity in a growing field. It paid well, kept me in the area, and ultimately turned into a career." Computer technology was not Dan's formal field of study; Notre Dame did not offer many computing classes at the time. So he instead trained directly with IBM, Apple, COMPAQ, and other companies.

Planning on being a teacher or principal, Dan returned to Notre Dame in 1989 for an MNA, a not-for-profit program specifically geared to healthcare and education professionals. In conjunction with his studies, Dan worked full time with the central IT Office on campus. While there, Dan ran a program and consulted with faculty across campus. It was during this time that he met Roger Jacobs, then Associate Dean for Library and Technology. In those early years, Roger and Dan had meetings focusing primarily on computers for faculty desks. There were few PCs for staff and the library only had terminals at the time. In 1998, eager to address the ongoing technological needs and challenges in the Law School and Law Library, and make a difference, Dan applied and was hired for the position of Manager of Law School Computing.

Reflecting over the years and on his hire in '98, Dan recalled that Roger asked him to think in terms of a new law school building and how to address the technological capabilities and services and bring them up to the next level in preparation for the new facilities. "The old building was not well suited to support all



the technological needs of our faculty and students. So, here we are 12 years later and we are doing just that." A few months after beginning to work for the law school, Dan hired Susan Good as Webmaster and Desktop Consultant, the first of several positions to be added to the IT department. In 2000, the small department continued to expand, adding a position for Audio/Visual services. Over the years, as students brought in more and more laptops, and needed more computing support, in addition to an increased number of students using the computer lab, another position was added for student computing.

Like the library as a whole, the IT department focuses on service. Dan says, "I want people to know they can always come to our IT staff with any technology questions, no matter how easy or complex the issue may be. We will always do our best to help resolve their questions." Dan's philosophy is reflected in the driving force behind each member of his IT staff; that is to serve and to be of service. Dan is quick to point out that he could not begin to provide quality service to the law school without the assistance of his exceptionally talented staff, which includes Jeff Morgan (the network manager), Susan Good (the webmaster), Scott Hengert (the classroom support/ AV professional), and Eric McCartney (the student computing manager).

In addition to managing all the aspects of IT in the law school, Dan consults directly with law school departments on their IT initiatives, liaisons with other groups on campus, and consults with IT vendors to develop solutions for use in the law school. He serves on the Chief Technology Officer Council (CTO Council) in the area of strategic University Initiatives where technological information is discussed with people in similar positions throughout the university with the intent that shared information will enhance technology campus-

wide. He also collaborates with the University's Office of Information Technology on various initiatives in the law school and library.

In the Fall of 2010, Biolchini Hall will be operational for faculty and student use. The transition period has now ended and the IT Department moved into their new office spaces in the summer of 2010. The computer area located in the new facility is more "purpose built" for technology and will have a different configuration and composition that is more flexible for spatial use. This is one of the goals Dan has been working towards ever since he came here. There will be twenty seats in the instruction lab and adjacent to it will be an area for student seating designed to make it easier for students to spread out and collaborate with each other on projects. Here also, students can connect their laptops to a larger monitor, and research librarians or WestLaw and Lexis consultants can give one-on-one instruction. There will be two new, fifty seat classrooms in Biolchini Hall with advanced professional grade video conferencing capabilities "so students might be able to take a seminar class from someone teaching in London or vice a versa." If faculty, law departments or students want to collaborate and bring in a guest lecturer from another law school they, too, can be brought in through video conferencing. Dan predicts these classrooms will be very popular. Now that the transition period is over, Dan is looking forward to better serving the faculty who have need of video conferencing and distance learning, providing these services at a higher level and in a more consistent way.

The transitional period marked by the move from the old law school building into temporary quarters in the new Law School and then back again into to the newly renovated Biolchini Hall had its trials and adjustments. The faculty and students were the ones mostly affected, but technology services were greatly challenged with how the faculty and students were able to use their services. One of these challenges included reducing the computer lab from a capacity of 40 work stations down to 8 during the transition. Reflecting on this adjustment, Dan commiserates with the students. "I have to thank the students for being as patient as they were. They were as confined as we were in terms of space and options. Now it is going to feel like such a luxury for them to have all these beautiful spaces in Biolchini Hall with the amazing technology, accessible and available to them. We will be much better situated to support

them with access to power and to the internet."

On a personal note, Dan and his wife Karen have

been married for 17 years. Karen is the administrative assistant and program manager for the Higgins Labor Studies Program here at Notre Dame concentrating on fair wage and labor issues. When asked what he is most proud of, Dan quickly responded, "my children!" His daughter Maddie is 13 years old and is in the 8th grade and his son Aidan, 11, is in 6th grade. Both attend St. Joseph's Grade School in South Bend. Dan is active and involved in his children's lives. He coaches the "St. Joe" teams that his children have played on, coaching Maddie in soccer and Aidan in basketball and baseball. He says, "I look forward to spending time with my children and doing things like team activities with them where I have the opportunity to see how they interact with their peers, how they progress as young people, and develop their skills. I have really enjoyed the coaching aspect, getting to know all their friends, trying to help them do better with their own skills or as a teammate. I have been coaching for lots of years now and I really enjoy that."

Dan has always felt a strong admiration for JFK. "I always felt my lifespan overlapped with John F. Kennedy's, but it didn't. It probably felt this way because so many of his initiatives came to fruition when I was young." Dan most admired IFK's sense of exploration with the space program, feeling that it was bold and captured the imagination, ingenuity, and technology of that time. Dan is also drawn to IFK's sense of justice and equality with the civil rights movement. Introducing his children to the values of justice, equality, and civil rights from our country's historical past, Dan's family recently accompanied him to a conference in Philadelphia, before which they also stopped to visit Washington, D.C. Dan was excited to share with his children "what it feels like to stand on the steps of the Supreme Court, to go into the White House, to see the Library of Congress and to experience the town that decides so much of what goes on in the country, and to dream about making a difference in whatever they choose to

# **Tech Tips**

# Recommended Applications for iPhones, iPads, and iPod Touches

Mobile devices are becoming increasingly popular in the workplace and in everyday life. The ability to access Internet from a Smartphone or other mobile device is becoming commonplace, and there is a wide variety of applications (or "apps") that these devices use to make life more productive, interesting, and just plain fun. In this issue we focus on applications available from the iTunes Store for use on Apple devices such as the iPhone, iPad, and iPod touch, since so many Notre Dame Law School students, faculty, and staff own one or more of these Apple devices.

I asked for a list of favorite applications from some law librarians and professors at NDLS and came up with the list at left. (Many thanks to all who shared their recommendations!) I also received a few suggestions from colleagues this past week at the Annual Meeting of the American Association of Law Libraries. Meg Kribble (Research Librarian and Outreach Coordinator at Harvard Law School) and Jason Eiseman (Librarian for Emerging Technologies at Yale Law School) demonstrated some of their favorite work and play related applications, which included the Nolo legal dictionary, a free alternative to the Black's Law Dictionary application, which sells for \$49.99. One of their favorite legal news apps was JD Supra's Lane Powell app, and a favorite note-taking application was Evernote, which lets users you create notes, snap photos, and record voice memos. Another nifty application for the iPhone they mentioned was Red-Laser, which uses the camera function to take a photo of any item with a barcode, allowing users to scan through multiple websites to see if a better price is available elsewhere.

If you would like to find some helpful legal research applications, check out Jacob Sayward's recent AALL Spectrum article iCite: Legal Research? There's an app for that for a list. Another helpful article by a law firm librarian with law-related app recommendations is Bev Butula's Go mobile: Apps for lawyers. Here at NDLS, the work-related app receiving the most mention was iThoughts, which is available for \$7.99. Tricia Bellia noted that this is a "brainstorming application somewhat like Mind Manager, which many of us have used to organize research and class notes in graphical rather than linear form." Julian Velasco highly recommended both iThoughts and iAnnotate PDF, which is useful for reading, highlighting, and annotating PDF documents. Rick Garnett wrote that he uses the Magnificat app a lot, which is "a Catholic site with the day's readings, some reflections, etc." Professor Garnett also said Penultimate, which uses your finger like a pen, "is great for jotting down notes."

But what about other entertaining, informative, and (im)practical apps that our law librarians and professors regularly use? Chris O'Byrne said his favorite would have to be <u>Bookworm</u>, "even if I were not a librarian! It's an addictive/engaging word-forming puzzle game in the tradition of Boggle, Scrabble, Take Two, and Bananagrams." Julian Velasco raved about <u>NY Times Editor's Choice</u> as the way a "newspaper app should be done." One of my own personal favorite distractions is the app version of the spatial reasoning card game <u>SET</u> which is possibly my favorite game of all time and made even more fun with timed tests and other options available in the application version.

Joe Reimers recommended the website <u>freeappaday.com</u>, which as the name suggests is a site which allows you to download each day for free a new application which otherwise costs something. He said of the site, "I got a few nifty time-wasters there. It's mostly games, but some are decent. For your inner astronomer, there's an app called <u>Planets</u>, which knows your position and the time of day and can help you plot stars and note what's visible and all sorts of similar cool stuff." Joe also recommended the <u>Seafood Guide</u> put out by the Monterrey Bay Aquarium, which "is handy for making sure the seafood you're considering is farmed sustainably," and he noted that he likes to use the app <u>eBuddy</u> for Instant Messaging.

# Recipe Box

The following recipe is courtesy of Chris O'Byrne's mother. Makes 48 servings.

# Apple Pie for a Crowd

# **Ingredients:**

2 1/2 cups butter or margarine
6 cups baking mix (biscuit mix)
1/2 to 3/4 cup very hot water
7-8 lbs. tart apples
2 1/2 cups sugar
2 tsp. each ground cinnamon and nutmeg
2 tsp. grated lemon peel
1 pkg. (about 19 oz.) white or yellow cake mix
1 cup chopped almonds or walnuts

### **Directions:**

Cut I 1/2 cups of the butter into small cubes. With a pastry blender or two knives, cut butter cubes into baking mix until particles are about the size of



peas. Sprinkle about 2 Tb. of the water at a time over the mix while you stir lightly with a fork just until all is moistened; dough should be moist but not sticky. Gather dough up into a ball and divide in half. Using half the dough for each pan, press and pat it evenly over the bottom and up the sides of two 10 by 15" rimmed baking pans.

Peel, core, and thinly slice apples; scatter half over each dough-lined pan. Stir to-

gether 2 cups of the sugar, the cinnamon, nutmeg, and lemon peel and sprinkle over apples. Also stir together the cake mix and nuts and scatter half the mixture over each pie; then sprinkle each with 1/4 cup of the remaining sugar. Melt the remaining I cup butter and drizzle 1/2 cup over each pie.

Bake in a 375 degree oven for about one hour or until apples are tender and crust is well browned. If using one oven, switch the pans halfway through the baking. Cool pies on wire racks, then cut each into 24 squares.
