He teaches and writes in a wide range of subject-matter areas, including international trade, international arbitration, and comparative law. Roger earned his B.A. with Honors from Baylor in 1985, and his J.D. with Honors from New York University. He also has degrees from Edinburgh University and Southern Seminary. Before entering the legal academy, he served as a law clerk to Judge James Buckley of the United States Court of Appeals for the D.C. Circuit, and Judge Richard Allison of the Iran-United States Claims Tribunal in The Hague, Netherlands. He practiced law with Hogan & Hartson in Washington, D.C., and was also a senior legal advisor to the Claims Resolution Tribunal for Dormant Activities in Switzerland. In addition to publishing widely in leading law reviews and journals, Roger contributes regularly to the international-law blog, [Opinio Juris](#) and is the managing editor and contributor to the international arbitration blog, [Kluwer Arbitration Blog](#).
