## **Center for Civil & Human Rights News and Notes**

### **Center Receives \$750K Grant from Ford Foundation**

In early February, CCHR director and Professor Juan Méndez announced that the center had received a three-year, \$750,000 grant to conduct academic, research and advocacy activities on accountability for gross human rights abuses, a subject for which the center is well known. Professor Méndez has indicated that the general theme encompasses a number of specific issues including truth and justice in transitions to democracy, universal jurisdiction, internal criminal justice and the International Criminal Court, and the ethical and political dimensions of achieving truth, justice and reconciliation under complex circumstances.

During the course of the three-year grant, the center will work to strengthen Kresge Law Library holdings on the topic, to help turn NDLS into an important resource center on accountability for serious human rights violations. The center will also invite practitioners with rich experiences in these matters to join the center as visiting fellows for a short time, which will enable them to reflect on lessons they can share with others. Professor Méndez also hopes to organize a conference and to publish the results of scientific research. In addition, the grant will help the center attract to its LL.M. and J.S.D. programs young lawyers from around the world who demonstrate a strong commitment to study seriously all aspects of accountability.

In explaining the significance of the grant, Professor Méndez commented: "The Ford Foundation has decided to initiate a very strong investment over the next few years on what they call 'transitional justice,' and I am proud to say that we are among the first institutions chosen by Ford to launch this new strategic area. That fact will allow us to cooperate extensively with a new International Center for Transitional Justice (ICTJ) that will form the centerpiece of Ford's initiative." In early February, Professor Méndez participated in the ICTJ's first experience in providing advisory services to governments and civil society when he and three other international experts traveled to Lima, Peru, to advise the post-Fujimori government in its plans to establish a truth commission. Professor Méndez believes that the grant will allow the center to complement the work of the ICTJ with strong academic, research and documentation support.

Professor Méndez further notes, "It is particularly significant that the Ford Foundation, whose generous contribution got this center started in 1973 at Father Hesburgh's request, continues to show a high degree of confidence in us and in our ability to work at the new horizons of human rights protection."

### **CCHR Faculty News**

Center Director **Juan Méndez** attended the November 9, 2000, board meeting of the John Merck Fund, a foundation to which he provides advisory services on strategies to promote human rights and democracy in Latin America. He participated in a conference on "The Legacy of Abuse - Justice and Reconciliation in a New Landscape" organized by the Aspen Institute at its conference center in Wye, Maryland, November 10-12. Participants from several countries and institutions discussed prosecutions, truth commissions and efforts at reconciliation in countries overcoming a recent past of massive human-rights violations. Juan and several other participants had attended a similar Aspen Institute meeting in 1989, which launched many advocacy ideas about these.

Also in November, on the 13<sup>th</sup>, he participated in a panel discussion on "Human Rights and Human Wrongs: How Far Have We Really Come?" organized by the Carr Center for Human Rights Policy at the Kennedy School of Government, Harvard University. Co-panelists included Canadian historian and analyst Michael Ignatieff. The event served as the occasion to launch the book, *Realizing Human Rights* (St. Martin's Press 2000), edited by Samantha Power and Graham Allison, which includes an article Juan wrote on Latin American contributions to the human rights movement.

In Washington, D.C., on December 6, he presented the amendments to the regulations of the Inter-American Commission on Human Rights at a conference at the Organization of American States on the reform of the system of human rights protection. Both the Inter-American Court and the Commission have recently amended their court rules and regulations as part of a larger package of reforms. As one of the commissioners, Juan was asked to present the highlights of the

Inter-American Commission changes to the audience of diplomats and practitioners.

Juan then traveled to Spain later in December to participate in a tribunal to hear the defense of a dissertation at the Universidad de Navarra, a Catholic university in Pamplona, on "The Rights of Migrant Workers to Family Life Under European Community Law." The tribunal was presided over by Prof. Jose A. Pastor Ridruejo, the Spanish judge in the European Tribunal on Human Rights. During that same trip, Juan lectured at the Universidad de La Coruña on "The Inter-American System of Human Rights Protection."

On January 8-13, 2001, Juan visited Quito and Guayaquil, Ecuador, under the auspices of the U.S. Department of State and the office of the U.S. Cultural Attache in that country in response to an invitation by the Program on Human Rights at the Pontifical Catholic University of Ecuador, in Quito. He delivered two lectures on "Human Rights and Democracy in Latin America: Balance and Perspectives," and one on "The Future of the Inter-American System of Protection," as well as three four-hour-long workshops. In addition to lecturing at the Pontifical Catholic University of Ecuador, he lectured at the Universidad Central (the state-run university) in Quito, and at the Universidad Espíritu Santo in Guayaquil.

On January 23, he addressed the Human Rights Program of Columbia Law School on the ongoing reforms to the Inter-American System of Protection from the perspective of the Inter-American Commission on Human Rights.

Juan visited Lima, Peru, on February 1-3, to attend a conference on "Truth, Justice and Reconciliation" organized by several local non-governmental organizations to assist the efforts of a task force recently formed by the new government to set up a Truth Commission to deal with the legacy of human-rights abuses by the Fujimori and previous governments. The Ministry of Justice of the caretaker Paniagua administration has asked him to serve as one of five international consultants to this Task Force.

He contributed *Comments on "From Minors to Citizens"* to a book edited by Fr. Ernest Bartell and Dr. Alejandro O'Donnell, *The Child in Latin America: Health, Development and Rights* (Notre Dame Press). The article commented on a paper by Emilio García Méndez, a prominent Latin American expert on children's rights, concerning the U.N. Convention on the Rights of the Child. He also contributed *International Human Rights Law, International Humanitarian Law and International Criminal Law and Procedure: New Relationships* to *International Crimes, Peace and Human Rights: The Role of the International Criminal Court* (Transnational Publishers), edited by NDLS Professor Dinah Shelton. The book is the result of a conference organized by the CCHR and the University's Joan B. Kroc Institute for International Peace Studies in March 1999. And, with Helena M. Olea '00LL.M., Juan contributed *Derechos y Deberes Civiles y Políticos* to the second edition of the *Diccionario Electoral*, published by the Inter-American Institute on Human Rights in San Jose, Costa Rica.

**Dinah Shelton** delivered a paper titled "Compliance with Environmental Soft Law" at a symposium on November 17, 2000, sponsored by the International Center for Environmental Compliance Assessment, Kagawa University, Japan. She spoke on the Inter-American human rights system at the Lisbon Forum 2000 on "Regional and Universal Systems of Human Rights Protection: Their Contribution to the Universality and Indivisibility of Human Rights," held November 23-24, 2000. She organized and chaired the "Workshop on Consent and Compliance: The Role of Non-Binding Norms in the International Legal System," sponsored by the American Society of International Law, November 3-4, 2000. She also served as a workshop professor at the "Workshop on Implementation of International Environmental Law," a training program for government officials and professors from Laos, Cambodia and Vietnam sponsored by the United Nations Training and Research Institute, Bangkok, on January 9-13, 2001.

Professor Shelton edited and contributed to *International Crimes, Peace and Human Rights: The Role of the International Criminal Court* (Transnational Press 2000), and contributed *Droits et justice pour chaque citoyen de la planete? to Mondialisation et Societes Multiculturelles: L'Incertain du Futur* (M. Ricciardelli, S. Urban and K. Nanopoulos, eds., PUF 2000).

### Faculty News and Notes

**Joe Bauer** has published the 2001 annual supplements to the 11-volume series, Kintner & Bauer, *Federal Antitrust Law* (Anderson Publishing Co.).

**Rick Garnett** published *Taking Pierce Seriously: The Family, Religious Education, and Harm to Children*, in volume 76 of the *Notre Dame Law Review*.

In early February, Rick participated in a symposium sponsored by the Minnesota Law Review on "The Freedom of Expressive Association," serving on a panel discussing "Religious Freedom and Institutional Autonomy: Free Exercise, Establishment and Expressive Association." The essays from the symposium will be published in volume 85, issue 6, of the law review.

He is also a faculty resource for the University on the topic of school vouchers. He believes that choice-based reforms are needed to meet the social justice goals of the Supreme Court's landmark decision in *Brown v. Board of Education*. In that ruling, the Court "promised equal education opportunity to all children, regardless of race," Rick commented. "As a nation, we have failed to make good on that promise. Many people of good will now believe, and the evidence tends to suggest, that school choice and educational pluralism - not special-interest politics and bureaucracy - are our best hope for achieving *Brown's* goals."

Rick gave a presentation on "A Few Thoughts on the Meaning of the Universe and the Mystery of Human Life" to a meeting of the student pro-life group *Jus Vitae* on January 31.

**William P. Hoye**, associate vice president and counsel, with Dr. Gary M. Rhodes of the University of Southern California, published *An Ounce of Prevention Is Worth . . . The Life of a Student: Reducing Risk in International Programs*, in volume 27, issue 1 of *The Journal of College and University Law*. The article evaluates the risks involved in university foreign-study programs, and focuses on ways both to eliminate unnecessary risk and to manage inherent risk while still maintaining the academic integrity of such programs. He also wrote *What a Difference a Millennium Makes: Tort Litigation in Higher Education, Circa Y2K* for *West's Education Law Reporter*, Vol. 147, No. 3 (December 7, 2000).

As chair of the University's Task Force on Anti-Sweatshop Initiatives, Bill helped to organize the formational meeting of the Living Wage Association, held February 2-4, 2001, on campus. The association is a consortium of universities formed to address living-wage issues including: developing a working definition and formulae for the living wage; sharing costs associated with living-wage studies; providing opportunities for collaboration in implementing the living wage in specific instances; and researching the effects of the various modes of implementing a living wage.

Bill presented "Professional Responsibility and Contemporary Law Practice" to the American Council of Life Insurance in Chicago, Illinois, on February 5, 2001.

George Bariscillo '44, '49J.D., of Ocean Township, New Jersey, died Thursday, January 4, 2001, in his home. Mr. Bariscillo had been a partner at Carten, Witt, Arvantis and Bariscillo in Asbury Park, New Jersey, until about five years ago. He has served as president of the Monmouth Bar Association and as a member of the New Jersey Supreme Court's Committee on the Unauthorized Practice of Law. He also served as a commissioner in Bradley Beach, New Jersey, from 1955 to 1960.

After earning his undergraduate degree from Notre Dame, Mr. Bariscillo joined the U.S. Army Signal Corps and served during World War II in Luzon, New Guinea, and in the Southern Philippines. He then returned to Notre Dame to study law, and clerked for Hon. Haydyn Proctor before entering private practice.

Mr. Bariscillo is survived by his wife of 41 years, Susan Perella Bariscillo, his daughters Cindy (Brian) Buck and Melissa (Luke) Falk, his son George III, two grandchildren and his brother, Jack Bariscillo.

Charles J. Griffin Jr. '63J.D., of Hinsdale, Illinois, died Thursday, January 25, 2001. Born in Chicago, Mr. Griffin had studied to become a priest, but had changed routes when offered a full scholarship to NDLS, where he graduated first in his class in 1963. He spent two decades with Seyfarth, Shaw, Fairweather and Geraldson before co-founding the firm Matkov, Griffin, Parsons, Salzman and Madoff. Mr. Griffin left in 1987 to become a partner in Wildman, Harrold, Allen and Dixon, where he remained until his retirement in 1999. Mr. Griffin was known for his encyclopedic knowledge of labor law, and he specialized in employment law, focusing on discrimination, labor contracts and arbitration, union-representation elections and collective bargaining. Despite the often contentious venue, Mr. Griffin was a respected adversary.

He was a member of the board of directors at Illinois Forge, Inc., of Rock Falls, Illinois, and was a member of the NDLS Order of St. Thomas More, as well as the Brotherhood of St. Andrew, an Episcopal men's fellowship and philanthropic organization. A parishioner at All Saints Church in Western Springs, Mr. Griffin was active in vestry, the bridge club and book group. A golfer, Mr. Griffin also took up piano at age 49.

Survivors include his wife, Nancy; three sons, Matthew, John and Charles; two daughters, Catherine Ilyavi and Mary Kantor; his mother, Sarah; a sister, Therese Guzaitis; three brothers, Robert, John and Joseph; and five grandchildren.
