Abstract

Bethel Reformed Church of Grand Rapids was chartered by Classis Michigan in 1906. In August 2000, the congregation was officially disbanded and the church closed. The collection contains minutes of Consistory, Elders', Congregational, Deacons' and Building Committee meetings. Also included are financial reports, membership lists, transfer credentials and church directories.

History

Bethel Reformed Church of Grand Rapids was chartered by Classis Michigan in 1906. The church went through two modest buildings on its site at Coit and Travis streets before building its grander, longtime home, dedicated 1928. The burning of the mortgage in 1948 was an occasion for great rejoicing. In August 2000, the congregation was officially disbanded and the church closed.

Scope and Content

The collection contains minutes of Consistory, Elders', Congregational, Deacons' and Building Committee meetings. The minutes also contain pertinent administrative documents. (Please note that, due to varying binding methods by Bethel administrators, some years may overlap from file to file.) Also included are financial reports, often bound in folders with the minutes. Membership lists and transfer credentials are also represented. Some church directories listed are photo-illustrated.
