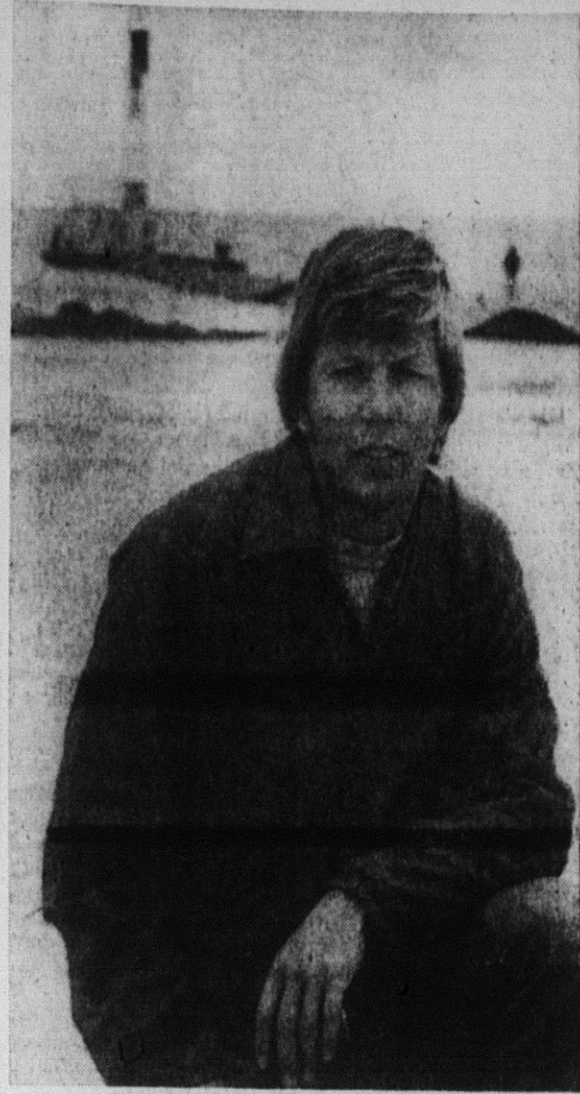

Young Diver Drowns In Dumont Lake

ALLEGAN — Richard A. Van Farowe, 16, of 6645 Barry St., Borculo, a novice scuba diver, drowned Saturday at 2:55 p.m. in Dumont Lake when his diving equipment apparently malfunctioned, Allegan County deputies said.

The youth had been diving with two companions, David John Bouwkamp, 16, of Hudsonville, and David Lafers, 25, of Jenison, an instructor in scuba diving, deputies said.

Van Farowe had been diving for about eight to 15 minutes and failed to surface near the public access site. His body was recovered from about 20 to 30 feet and was given cardio-pulmonary resuscitation at the scene. He was pronounced dead on arrival at Allegan General Hospital.

Deputies said the diving equipment had been checked in shallow water before the dive in deeper water by Van Farowe.

Surviving are his parents, Mr. and Mrs. Ivan Farowe; five brothers, Gary and Robert of Holland, John, Michael and David, at home; one sister, Mrs. Kenneth (Kathleen) Van Rhee of Jamestown; two stepbrothers, John Wyma of Jenison and Mark of Beaverdam; two stepsisters, Mrs. Debra Wiersma, in Korea and Kim Wyma of Beaverdam; his grandparents, Mr. and Mrs. Edward Van Farowe of Jenison.

Injured Passenger Files Damage Suit

GRAND HAVEN — Margaret Boersen of Holland township filed a \$200,000 damage suit in Ottawa County Circuit Court Tuesday against three defendants in connection with a Jan. 1, 1974 traffic accident at West Olive.

She claims she was seriously injured when the car in which she was riding, driven by Glen Dale Boersen of Holland, was involved in an accident with a car driven by Jack Newhouse of West Olive.

The accident occurred at Port Sheldon St. near 128th Ave. while Boersen was leaving a driveway.

Named defendants were Newhouse, Boersen and Bill Nunley Lincoln-Mercury Inc., owners of the car driven by Newhouse.

Cyclist Stopped After Police Chase

A motorcyclist faced arraignment in District Court Monday after he allegedly attempted to run Holland police late Sunday and lost control of his cycle along railroad tracks in Holland township.

Taken into custody was Daniel J. Gutknecht, 24, of 13100 Greenly St.

Police said they spotted a cyclist northbound on River Ave. running a red flashing signal light at Seventh St. at 11:47 p.m. Sunday and gave chase. The cyclist turned east off River onto Vander Veen Ave. and then north along trails at the chessie system railroad tracks.

Officers said they followed the cyclist three-tenths of a mile along the trails before he lost control and stopped.

Gate Installed At Breakwater

Holland State Park officials said a gate at the north breakwater was being installed Wednesday by the Corps of Engineers as a deterrent to persons walking onto the breakwater during rough weather conditions.

The gate is taken down during the winter season to prevent damage from ice. A request for the gate installation was made by state park officials after a 15-year-old boy was rescued from the channel waters Monday. He had been washed off the breakwater by high waves while walking with three companions.

Passing Trucker Helps Avert More Serious Blaze

Quick action by a passing tanker truck driver helped avert a more serious fire at a service station Saturday at 2:06 p.m. when a camper pickup truck caught fire, Holland firemen said.

Firemen said the truck driver spotted the flames and used his fire extinguisher to douse the blaze before firemen arrived.

The camper truck stopped at the Tulsa service station at Eighth St. and Columbia Ave. when the owner, Max Weeks, of Creston, Iowa, dropped a lighter to the pavement. It was not lit.

Firemen said Weeks asked his young son to pick up the lighter but not to light it but the youngster flicked the lighter which created a spark and touched off gasoline fumes.

Weeks suffered minor burns of the hands. The youngster was not reported injured. The camper and truck sustained an estimated \$500 damage.

The passing trucker noticed the fire, stopped his truck and extinguished the flames. The name of the driver was not immediately learned.

March of Dimes Gives Hospital Aid

ZEELAND — The Zeeland Community Hospital has received \$1,000 from the Ottawa County Chapter of the March of Dimes for two new pieces of pediatric medical equipment.

The items include a pediatric aerosol oxygen tent and an oxygen analyzer for use in the respiratory treatment of newborn and pediatric patients.

The gifts were presented to Mrs. Maxine Hiemstra of the hospital's obstetrical department by Cal Prince, chairman of the county March of Dimes.

Cabin Cruiser Comes Close to Sinking

Five persons escaped injuries when their 23-foot cabin cruiser began taking on water from a crack in the hull as she entered Holland Harbor and came close to sinking before Coast Guard pumps were put into use Friday at 8:20 p.m.

The Holland Coast Guard said the boat, owned by Richard McHahan of Elkhart, Ind., reached the Point West area of Lake Macatawa where the Coast Guard connected three pumps to remove water taken aboard. The boat later was taken to a marina for repairs.

Dog License Fees Raised In County

GRAND HAVEN — County Commissioners Tuesday raised the dog license fee to \$4.50 a year for male and female dogs and kept the fee at \$3 for neutered dogs, effective with the 1977 licenses.

Coupled with the license fee increase was a doubling of the fees paid for a dog census from 30 cents a dog to 60 cents a dog. The low census fees were blamed for the poor response in 1976 to the census when only five of the 17 township took the census.

The trailer formerly occupied by the sheriff's department at the Holland Branch Building on North River Ave. was sold to the highest bidder for \$1,510, it was reported.

Commissioners referred to the finance committee a proposal to hire Grand Valley State College students as interns for two ten-week periods at a total cost of \$1,000.

Payment of \$3,451 to cover repairs to the roof of the Civil Defense building in Holland and a CD truck damaged in a hail storm in 1975 were approved by commissioners.

Resignations were received from Mrs. Robert Stobbeaar from the Mental Health Board and Harry Jaarsma of Holland from the bikeway advisory committee.

Commissioners approved a \$3,300 allocation for the West Michigan Health Systems agency and agreed to study the remaining \$9,700 request from the agency.

Commissioners were asked to set priorities on a list of recreational projects proposed for the county to meet qualifications for application for federal grants for recreational development.

Two Injured As Car Overtakes

GRAND HAVEN — Two persons were injured when their car went out of control along Port Sheldon St. at Main Saturday at 9:13 p.m., struck a guard rail and rolled into a ditch.

Admitted to Butterworth Hospital in Grand Rapids in "good" condition were Paula Dekkinga, 29, and David Linscott, 22, both passengers in the car and both from Wyoming.

Ottawa County deputies said the car was driven by Craig Brower, 23, of Wyoming, northbound on Port Sheldon. He was not reported injured.

Boat Damaged By Waves, Seawall

GRAND HAVEN — Marine authorities today attempted to remove a 23-foot power boat from the Lake Michigan shoreline area at Johnson St. south of Grand Haven where it was washed into a seawall after losing power at midnight Sunday.

The Coast Guard and Ottawa County deputies said the \$10,000 boat sank in three feet of water after it was hammered against the seawall by waves.

The high waves prevented the Coast Guard from attaching a line from its 40-foot rescue craft to the disabled boat. Damage estimates to the disabled boat were not immediately known.

The boat was owned by Roger Merkins, 33, of Wyoming. Two passengers on the boat were identified as Mike Mooney and Ed McHenry, both 15 and from Wyoming.

County To Build At Hudsonville

GRAND HAVEN — After nearly two years of study and debate, Ottawa County Commissioners Tuesday got a handle on their building program and approved taking of bids for a county building in Hudsonville.

But the action was not without a series of motions, parliamentary maneuvering and some confusion.

Commissioners, on a ten to one vote with Donald Stoltz of Holland dissenting, authorized Buildertop Associates Inc. to prepare final plans and specifications and to advertise for bids for construction of a 16,000 square foot facility at Port Sheldon St. and 28th Ave. to house offices for the departments of Social Services, Community Mental Health, Public Health and District Court, not to exceed \$485,000.

The figure did not include furnishing the building.

Stoltz said after the meeting he still felt an addition to the Holland Branch Building was needed more than the Hudsonville facility.

To reach the decision at 6 p.m. Tuesday, commissioners had to suspend parliamentary rules, rescind action taken several months ago on the use of federal revenue funds for building purposes and re-allocate the funds.

A question of priorities in building was raised when commissioners said they had earmarked \$750,000 for a proposed law enforcement building, \$450,000 for a new branch building in Holland and only \$300,000 for the Hudsonville building.

Under those guidelines there would not be enough money to build the Hudsonville facility, commissioners were told.

Urgency for an addition in Holland was underscored by Claude Ver Duin, chairman of the Social Services board, who said the owner of a building now rented by Social Services on Lakewood Blvd. had said he would not renew the lease at the end of the year.

Ver Duin had sought direction from commissioners on whether he could seek additional rental space or go to private enterprise for a new building.

Stoltz said he could not agree with a motion by Marilyn Sherwood allowing Social Services to lease facilities for two years because it would give commissioners "an opportunity to sit on our hands two more years and we could give ourselves enough rope to hang ourselves."

The motion was defeated on a six to five vote.

A motion to delay action on the Hudsonville building lacked support.

Commissioner John Langeland suggested the county go ahead with the Hudsonville building "because the money is there." But other commissioners said the \$1.5 million in revenue sharing had to be split according to the formula adopted two years ago for the three buildings proposed.

Stoltz said if priorities were still being used to determine use of the building funds then the Holland addition should come first. Raymond Vander Laan of Hudsonville disagreed. Commissioner Kenneth Northhouse of Jenison said the improvement committee had unanimously recommended that the architect be directed to prepare final plans and specifications and advertise for bids for the Hudsonville facility.

After the rules were suspended and the revenue sharing funds unlocked and restrictions on its use removed, commissioners approved the Hudsonville project with the \$485,000 limit.

Still to be decided are plans and location for the proposed addition to the Holland Branch office on North River Ave., facilities for the Social Services department to replace the Lakewood Blvd. building and the future of the proposed law enforcement building.

To add to their building problems, commissioners were told by Circuit Court Judge James E. Townsend that the jail was overcrowded and the population averages 70 to 80 inmates daily where two years ago it was 32 persons.

He said short term solutions were available such as use of work camps or work release centers by persons sentenced in the courts.

The matter was referred to the county administration committee.

Youth Washed Off of Pier

Daring Rescue By Guard Saves Life

Holland State Park Beach Guard Phil Boeve rescued a 15-year-old boy after he was washed off of the north pier by six foot waves Monday at 3:30 p.m.

Arnold Lacombe, of 13 Elm Lane and three companions were walking out on the pier, Boeve said, when Lacombe was washed off of the pier by six-foot waves. Boeve, who had just put up the red no-swimming flag, was standing near the concession stand. He saw the youth washed off the pier through his binoculars and raced out to rescue Lacombe.

Boeve, 22, said he dived into the channel and swam out about fifty yards to Lacombe and

pulled him in using a rescue tube.

A woman working in the concession stand at the state park notified the Coast Guard who arrived with a rescue boat by the time Boeve had pulled the youth out of the water.

The Coast Guard took Lacombe to the Coast Guard station and transferred him to an ambulance and transported him to Holland Hospital. Lacombe was treated for shock and released.

Boeve said a gate is usually put up in the spring by the U.S. Army Corps of Engineers to allow the state park officials to keep persons off the pier when red flag conditions exist. The gate had not been put up yet this summer, Boeve said.

Mel Simpson, technician at the Army Corps of Engineers in Grand Haven said the gate was not up this summer because no formal request had been made by park officials, who would have to control the opening and closing of the gate.

Simpson said today a formal request was forthcoming from the park officials to install the gate. The gate is taken down in the fall because of winter ice conditions.

Boeve said the gate did provide a deterrent, but persons could swim around it and still get on the pier. "People just don't know how dangerous the waves can be out there," he said.

Rail Crossing Work Closes 120th Ave.

Construction by the Chessie System at a railroad crossing has forced the closing this week of 120th Ave. between Lakewood Blvd. and M-21, the Ottawa County Road Commission announced.

A detour route has been established and directs traffic from 120th east to 112th Ave.

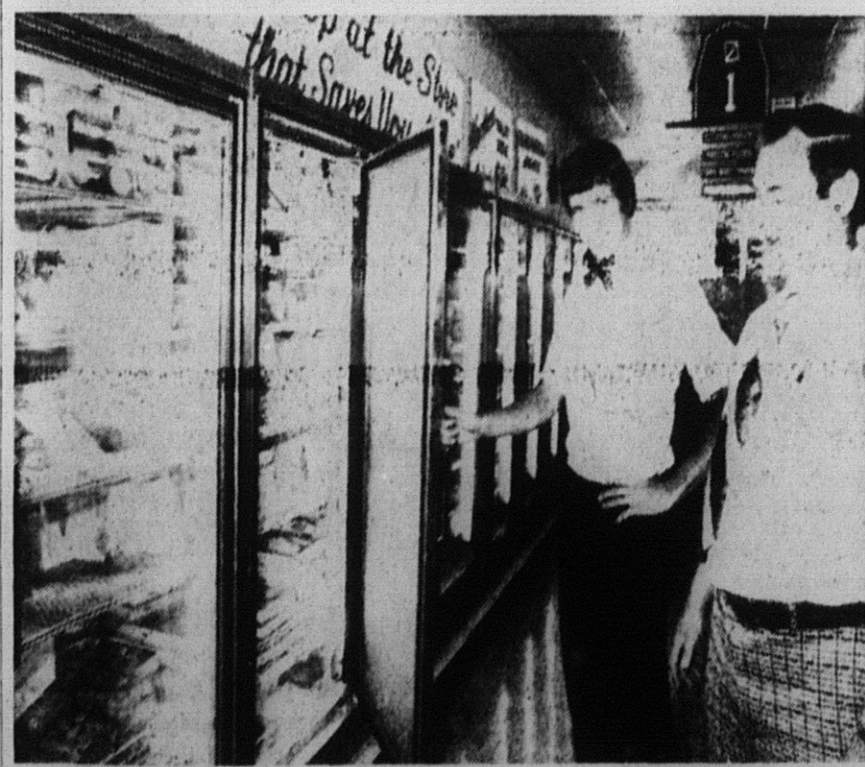

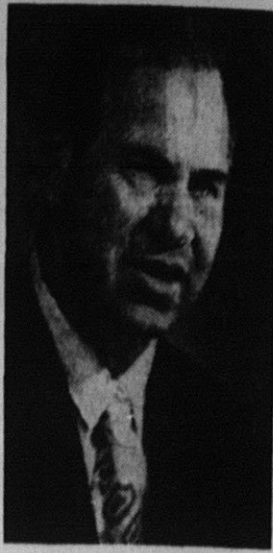
Capt. Vogelzang Is Awarded Army Commendation

Charles Cooper Re-elected As BPW President

The Holland Board of Public Works Monday re-elected its officers for 1976-77 and heard some potentially bad news concerning coal shipments for the power plant.

Charles Cooper was elected to his sixth term as BPW president and Stuart Padnos was returned as vice president.

BPW General Manager Frank C. Whitney said a fire destroyed coal loading facilities at Chicago and it could be 30 to 90 days before coal could be shipped from the port.

Whitney said the BPW would be in no danger unless the delay lasts 90 days or longer. In addition to Chicago, Holland also receives coal shipments from Toledo.

The board gave approval to the final contract for electrical equipment for the electrostatic precipitator at Unit 4 of the power plants subject to approval from the BPW attorney and city council. The contract with General Electric is for \$7.460.

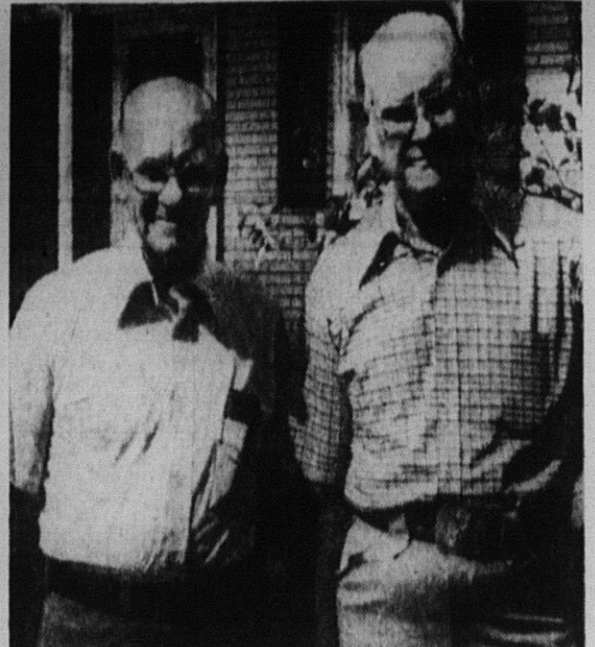

Brothers Reunited After 54 Years of Separation

L. C. Briggance's son and Joe Murphy's daughter have more than their ages in common.

The cousins were married in separate ceremonies on the same day, same month, same year.

"Eerie" is the fathers' description of the coincidence. The fact is particularly startling since neither the cousins nor their uncles knew each other.

L. C., now of 996 College Ave., was adopted by foster parents at the age of two and from that time until six months ago was separated from his older brother.

A ten year search by L. C.'s niece ended last November when she finally tracked down the identity of her uncle and reunited her father and his brother.

Now 56, L. C. and his wife have been entertaining his brother, Joe, and family.

Joe, 62, a resident of Pasadena, Texas, delights in the similarities with his younger brother. Both have worked as truck drivers, have like tastes, like expressions and a haunting resemblance.

The physical appearance after 54 years of separation is so striking one grandchild failed to determine her own grandfather.

Joe's daughter, Velva, explained the difficulties in tracking down her uncle. "We checked social security, the armed forces, and towns up and down the Mississippi before discovering that we were spelling his adopted name wrong. We weren't even sure which name he was using."

One night last November an operator assisted Velva in determining the correct spelling and connected her with Mrs. Briggance. L. C.'s foster mother who gave her the phone number in Holland.

"I couldn't believe it," L. C. says of his midnight call last November. "I asked her leading questions that only she could know. I finally realized it was true."

After returning home from work and hearing the news from his daughter, Joe also called his brother at 1 a.m.

The following day they began making arrangements to meet. L. C. says, "And we have plans to see each other a lot in the future."

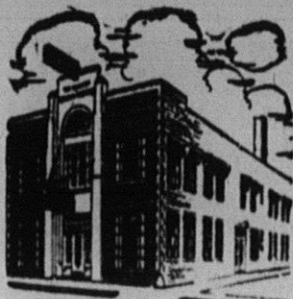

FOOD LABELING

Recently the consumer division of the Food and Drug Administration conducted a survey about food labeling, and although the complete report is not yet out, the preliminary report has some interesting facets. The survey covered 1,664 persons who did at least half of the food shopping for their households. These people were interviewed in their homes.

Over half of these people read and used the nutritional information given in the labeling in selecting certain foods and beverages. Furthermore, although industry has declared that buyers do not want the added expense which labeling entails, consumers said they were willing to pay up to 50 cents on their weekly food bill to get accurate and reliable information on the label. There is no doubt that the housewife wants to know what she is paying her money for. They also want to know about open dating and unit pricing even though this may slightly increase the price of the commodity.

It was evident also that the least educated among us have the least use for labeling because they do not understand what the labels say. They don't, for instance, if they haven't finished high school, generally know what the recommended daily allowances are that are listed on the label. Here is another bit of proof that our educational system has to get to business of simply teaching people to read and thus making them self-directing in matters of practical living.

There is nothing startling in these findings except that we were not prepared to believe that people would pay for such information. It goes to show that people want to know what they're eating, and that we can't take industries word for everything. The survey will likely make complete and legible labeling a matter of greater concern to industry.

Summer Crafts Program Shows Best in 'Kids'

While the shouts and groans of summer playground athletes experiencing the thrill of victory and the agony of defeat waft through the windows of all-purpose rooms is five of Holland's elementary schools, activity of a quieter but no more serious nature is going on inside.

At Longfellow, Holland Heights, and Van Raalte schools, a program of various arts and crafts is taught by regular Holland art teachers, and at Montello Park and Maplewood schools, children glaze and fire ceramic articles they have chosen from the selection available at the centers.

Some of the projects are decorative, like the ceramic figurines and pipe cleaner and cloth flowers, made at some of the centers. Ceramic mugs and vases, and some of the string art and banners, however, have decidedly practical uses. The projects and their uses were described by their creators during a recent Sentinel visit to the craft and ceramics centers.

Marla Van Huis, 9, of 223 Cypress, was making a "string art" project, and gladly explained the technique. For string art, the artist selects a piece of board, covers it with dark-colored felt, and places a dot-to-dot version of the design he will express in string on the felt-covered board. Next he nails the design on at the dotted points, removes the paper, and winds string in colors befitting his design around the nails.

Marla's design was an arrangement in pink of the words "Love Me." When asked about the significance of the words she chose, the artist responded that he planned to put the finished piece on her bedroom wall so her brother, "a 15-year-old creep," would love her.

Sally Vannette, also 9, of 222 Glendale Ave., chose an equally intriguing pair of words. In patriotic colors, she had spelled out "Kiss Me." Leaving further questions unanswered, she explained that the work when completed, would be placed in a prominent spot over her bed. Felt banner making was the order of the day at the Van Raalte craft center, and artists

there were expressing a variety of sentiments through their works.

Karen Jekel, 9, of 156 West 12th St., reflected heritage in her design of bright red tulips on a field of yellow felt. Kelly green mushrooms were sprinkled between the tulips.

Dawn Kiefer, 10, of 227½ Pine St., seemed to have the Great West in her mind as she illustrated on a light blue background a felt scene of a mountain lake surrounded by dark green pines. The banner was to be a present to her older brother.

Deb Husted issued a warning in felt to her rambunctious brothers — "Keep Out!" She intended to post the finished banner on her bedroom door, so that her siblings "won't tear my room apart."

Craftspersons at the Longfellow center were pounding leather initial bands, making moccasins and slouchers.

Another popular project there was "shrink art." Masters in this technique take a piece of special clear plastic, copy, trace or draw a design on it with markers, cut it out and place it on a cookie tin to pop into the oven. With heat, the designs shrink to a fraction of their former size, and can be made into such articles as Christmas tree ornaments and necklaces.

Lisa Nelson, another 9 year old, of 833 West 25th St., a ceramics artist at the Montello Park center, was glazing a ceramic dog. The figurine was intended for her grandfather, a hunting enthusiast. Lisa, however, does not approve of this dangerous sport, and planned to send her grandfather the dog, in order "to keep his mind off hunting."

The crafts program at these schools lasts through July 30. There are two sessions at each center. One meets in the morning from 9 until noon, and the other in the afternoon from 1 till 4 p.m.

Instruction and supplies for these projects are provided by the Holland Recreation Department. Children pay for the materials they use, at cost price, as they need them. Estimated cost of a week's participation in the program is \$1.50.

Each center posts a weekly program of activities, and the children are free to sign up and participate whenever they want to.

Participation in the crafts program is limited to children eight years old and above, because of the nature of some of the projects. Some of the techniques used are complicated and some equipment is sharp or heavy.

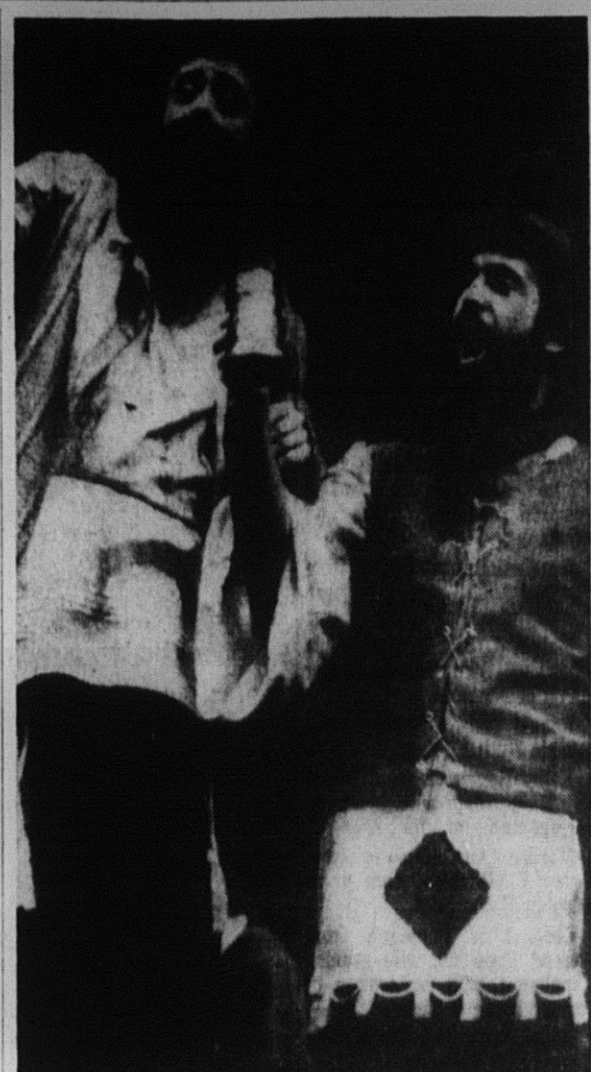

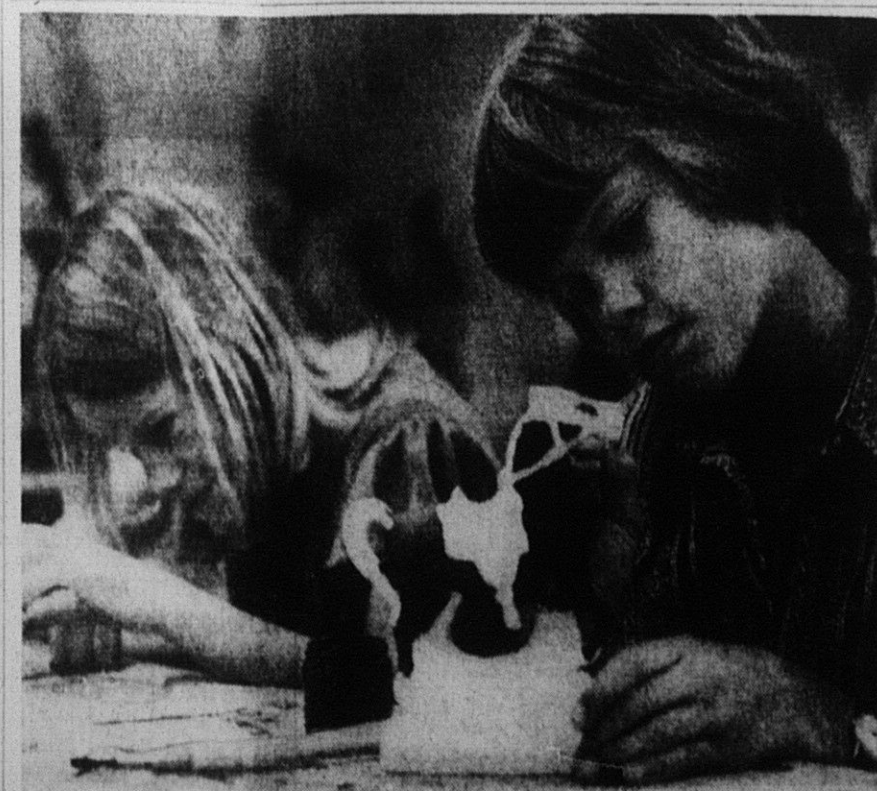
Ottawa County deputies said Bartel apparently fell asleep at the wheel when the accident occurred at 3:43 a.m. Saturday.

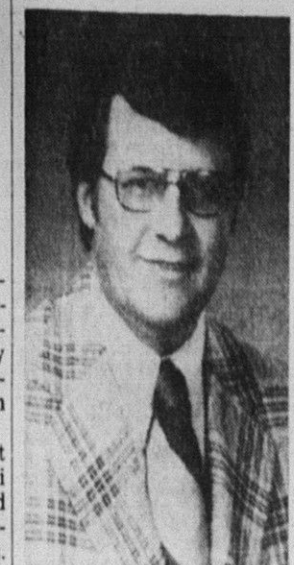

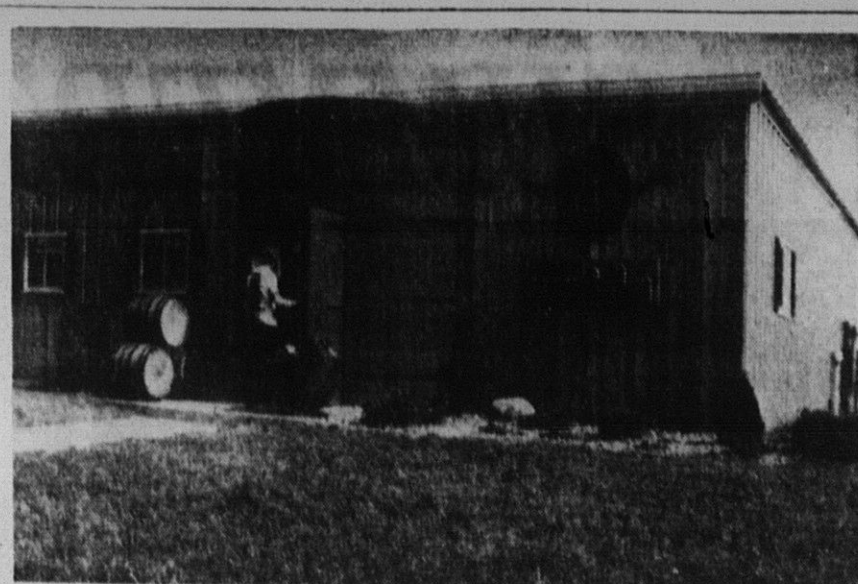

Daily Tours Available At Fennville Winery

Bill Welsh, president of Fenn Valley Vineyards, smiles proudly as he shows visitors around the new family owned winery located off M-89 in Fennville.

Wine making is a growing Michigan industry and the state ranks third in the production of fine table wines.

"It's surprising," Welsh says, "how interested area people are in our self-guided tours. They seem to particularly enjoy our sampling room where they can taste the wines to determine which they enjoy most."

Ground was broken in early 1973 after the family did considerable searching for an ideal wine-grape growing site. They started at the tip of the lower peninsula north of Traverse City and worked down.

The rolling hills around the winery are cooled in summer and warmed in winter by Lake Michigan which is four miles to the west. The area is also ideal for the fruit wines such as cherry, blueberry, pear and plum. All of the fruits are

grown within 20 to 30 miles of Fennville.

The family purchased 230 acres to grow two basic types of grapes. "We grow French hybrids which provide the superior flavor of European type grapes with the hardiness of native American Grapes, and Vinifera, to more fragile and tender grape variety grown in Northern Germany," Welsh explains.

The winery is built in the side of a hill to take advantage of natural cooling in the aging cellars.

"Good wine cannot be hurried," Welsh says. "Even superior wine grapes require proper handling and tending to make a good wine. Though cool fermentation takes longer, it produces a fruitier wine that adds much to its final enjoyment. Then, we monitor the fermenting processes with the most modern laboratory instruments."

Fenn Valley Vineyards and wine cellar is open to visitors daily through November from 10 a.m. to 5 p.m. and Saturday and Sunday from 1 to 5 p.m.

The ceremonial at Leisure Acres will be the first outdoor event of its kind ever held by

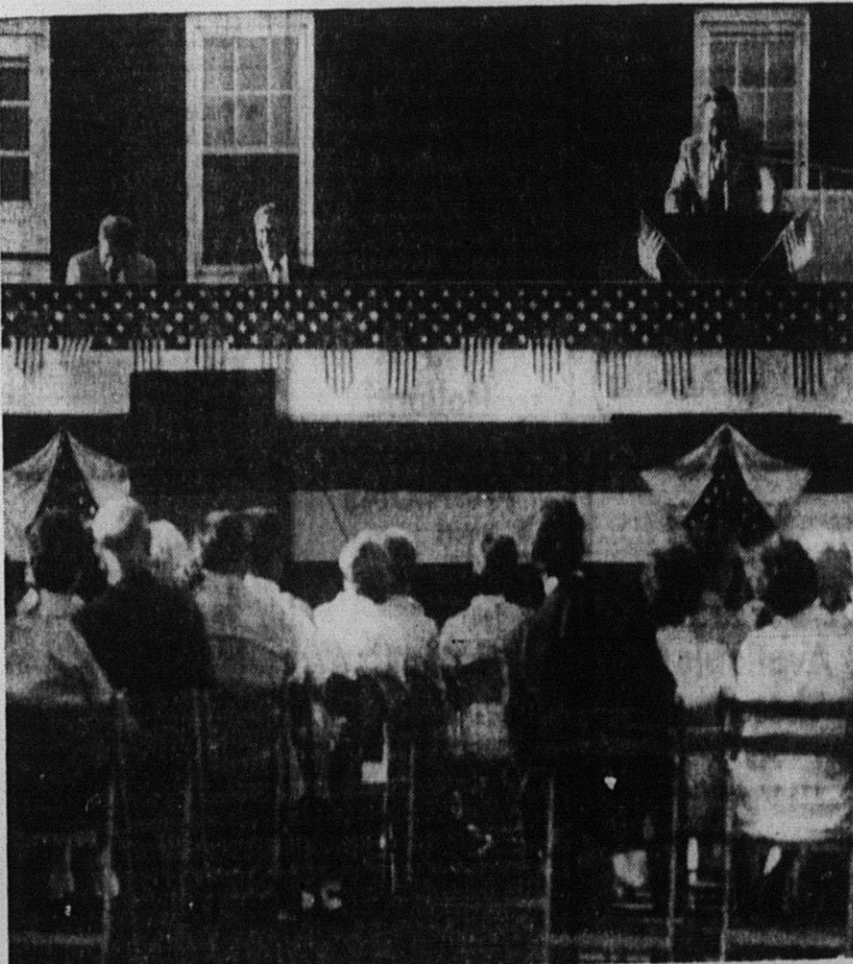
Saladin Temple and is expected to attract more than 300 members and wives for the all-day affair.

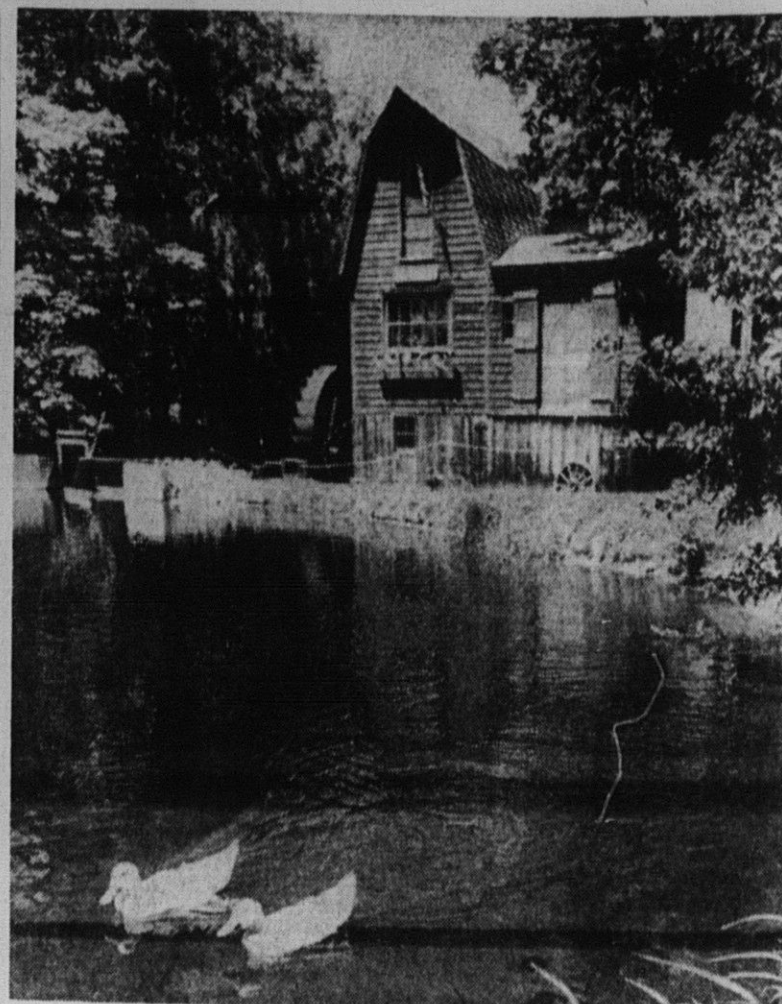
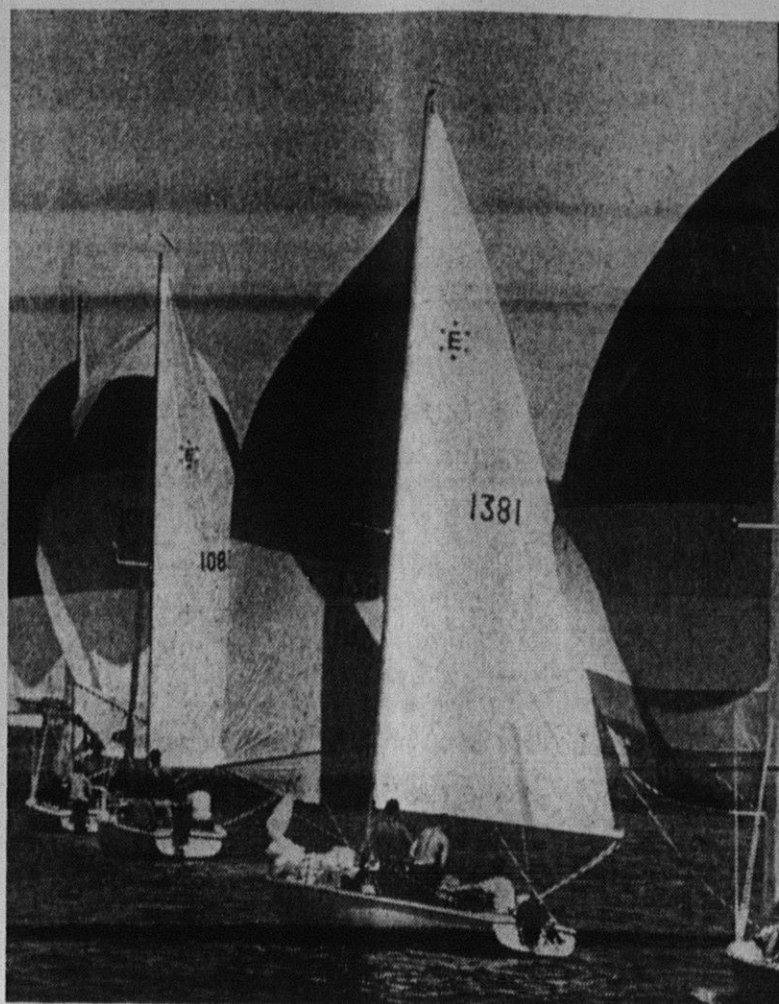
