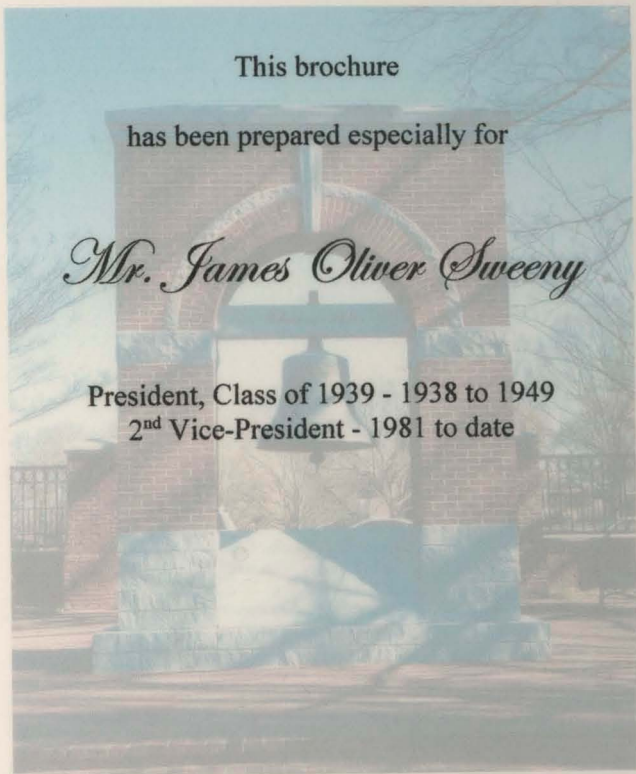

From Tennyson's "Crossing the Bar"

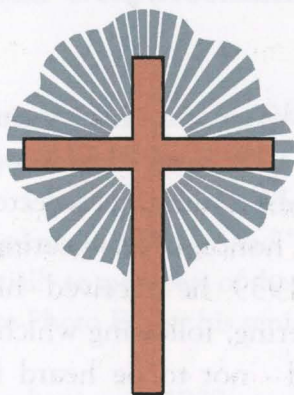
Sunset and evening star,

Loyal Ayres Williamson, Jr.

Died October, 1964

Loyal Williamson, known to his classmates as "Wiley," entered Clemson in 1935 from Ridgewood, New Jersey. His scholastic record enabled him to be selected for membership in Tau Beta Pi, the honorary engineering fraternity, in his Junior year. In 1939 he received his B.S. degree in Mechanical Engineering, following which he went out into the workaday world - not to be heard from again by his classmates. He was listed as an "address unknown" alumnus until a recent internet search of Social Security records disclosed his death in 1964.

So far, we have been unable to find an obituary for Loyal. When we do, it will be distributed to the class.

Robert Morehead Geer

Died April 28, 1992

Robert Geer was raised in Anderson, S.C., graduating from the Anderson Boys High School in 1935. He entered Clemson with the Class of 1939, where he majored in Architecture. He was known as "Gus" and "Free-wheeling" to his classmates, and especially to members of the TAPs Staff, on which he served as Associate Photo Editor his senior year.

His activities after graduation in 1939 are unknown to us, there having been no contact reported between Robert and other class members. It has recently been learned that he died in Chevy Chase, Maryland in 1992, but no other facts of his life after school at Clemson are known. If we are so fortunate as to locate an obituary for Gus, it will be distributed to the class.

Richard Melvin Lynes

Died April 11, 2003

Richard Melvin Lynes, 88, widower of Julia Thomas Lynes, formerly of 607 South E St., Easley, S.C., died at Richard M. Campbell Veterans Nursing Home in Anderson S.C.

Born in Fairfax, S.C., Richard was the son of the late Minnie Jenkins Lynes and Oscar Benjamin Lyrics. He majored in General Science at Clemson College, where he was in the 1939 class. He served with the U.S. Army in Panama during World War II, as a Staff Sergeant in a medical unit.

After the army Mr. Lynes worked for many years as owner and operator of Friendly Loan Company in Easley, S.C. He is remembered by his former business associates for his fairness, honesty, and integrity.

Mr. Lynes was a long time member of the First Baptist Church of Easley. He was predeceased by his wife of 49 years; a daughter, Linda Sue Lynes; his parents and three brothers.

Richard's hobbies were collecting and repairing clocks and watches, and dove and quail hunting with his dog.

He is survived by a daughter and son-in-law, Julianne and Richard Maxwell of 346 Brown Road, Simpsonville, S.C., 29681; grandchildren; Julia Allen and her husband Tim, of Hickory N.C., Richard Crohn, of Simpsonville; and a great-grandson, Stephen Allen.

The immediate family remembered him with a private graveside service Monday, April 14th. The Rev. Charles E. Fritz, pastor of St. Matthias Lutheran Church of Easley, conducted the service.

Died December July 3, 2003

Mr. William Owen Cofer, age 85, of 9617 North Road, North, S.C., died on July 3rd, 2003, at Bamberg Nursing Center.

He was born on February 14, 1918 in Aiken County, the son of the late Owen Randall and Juanita Wofford Cofer. After attending Waegner High School, he entered Clemson College and was in the class of 1939. He majored in vocational agricultural education and agricultural economics, and he worked for the Agricultural Economics Department until March 13, 1940.

Bill was a World War II Veteran, having served for 5 years and 3 months in the 367th Infantry of the 82nd Division and the 63rd Division (Antilles Dept) in Puerto Rica. His highest rank was Captain.

After the war service, Mr. Cofer operated a Mom and Pop grocery store in North, S.C. for 16½ years. Following that he was a zone manager for Investors Diversified Services, later listed as American Express Financial Services for 21½ years.

In 1941 Bill was married to Rachel Jones Patterson who died in 1976. In 1977 he married Ethel Pender White.

Mr. Cofer was Grand Master of the North, S.C. Masonic Lodge; Former Post Commander of Nelson-Bass American Legion Post; a shiner in Orangeburg County. He was a faithful member and Sunday School teacher of the First Baptist Church of North, SC.

He is survived by his wife, Ethel White Cofer; sons, Dr. William A. Cofer of Greer, S.C. and George P. (Pat) Cofer of Jacksonville, Fla.; grandchildren, Jeff Olmert, Travis Olmert and Chris Smith; stepchildren, Whitefied White of Springfield and Loxie White Brown, of Katy, Texas; step grandchildren, Whitney White, Kristie Landy, and Dathne Brown; and 3 great grandchildren.

The family received friends from 1:30 to 2:30 pm Saturday at Cutler-McAlhany Funeral Home. Graveside services with Masonic Rites were held at 3 pm at Riverside Cemetery with the Rev. Dr. Joseph Guess, age 84, of 114 Park Drive, Union S.C. 29379, husband of Julia Mae Easterling Guess died in Johnson City Medical Center in Johnson City, Tennessee.

Dr. Guess was born in Denmark, S.C., September 12, 1918, a son of the late St. Clair P. and Sarah Heriot Guess. After his early schooling in Denmark he attended Clemson College and graduated in 1939. At Clemson he was a member of Tiger Brotherhood, Scabbard and Blade, and a member of the Senior Platoon. In 1942 he was a graduate of the Medical College of South Carolina. He was a veteran of World War II, having served in the U.S. Army Medical Corps from 1944 until 1946. He began his practice of medicine in Union, S.C. in 1946 where he practiced until his death.

Dr. Guess was a member of the S. C. Medical Association, the Union County Medical Association, and was a Diplomate of the American Academy of Family Practice. He was a member and Past President of the Union Lions Club.

Surviving in addition to his wife are three sons, Joseph H. Guess, Jr. of Denmark, Robert E. Guess of Union, and J. Dechard Guess of Summerville, S.C.; a daughter Mae G. Chamberlain of Columbia, S.C.; two sisters, Betty G. Thomas of Denmark and Sarah G. Barton of Greenville, S.C.; six grandchildren; one great-grandchild; two step grandchildren.

Dr. Guess was predeceased by a brother, St. Clair Guess, and two sisters, Carolyn G. Watson and Martha G. Johnson.

Drake Watson, 85, of 2006 Springfield Circle, Newberry, S.C. 29108, died in the Newberry County Memorial Hospital on August 22, 2003.

Mr. Watson was born in Florence, S.C., a son of the late Lawrence Orr and Julia Drake Watson. He was a 1939 graduate of Clemson College in Agronomy and received his Master's Degree from Virginia Technical University in 1941. In World War II, he served in Trinidad at a U.S. Air Base. He became Company Commander of Headquarters and Service Company in charge of air base security. He was also in the Korean War. He retired as a Lieutenant Colonel in 1978 from the U.S. Army Reserve after 26 years of Service.

Drake worked for the Virginia Truck Experiment Station in Norfolk, VA in 1941, the Pee Dee Experiment Station in Florence, S.C. in 1946-1947, and in 1982 he retired after 35 years of service with Pennwalt Corporation in Philadelphia, PA, where he had been an Agricultural Chemical Division General Manager.

Mr. Durban returned to Aiken after World War II and was engaged in real estate and insurance. His office was designated as Insurance, Inc.

In Aiken, the Mass of Christian burial was celebrated at 11:00 a.m. Monday, November 3, 2003, at St. Mary Help of Christians Catholic Church, with Rev. Father James L. Leblanc celebrant. Final prayers and commendations followed in Historic Bethany Cemetery with full military honors. The Shellhouse Funeral Home in Aiken handled the arrangements.

Mr. Durban was preceded in death by his wife, Maria Hertwig Durban in 2001.

Died November 19, 2003

He served six months in the Philippine Islands and Japan. He commanded an infantry battalion, while in Japan, which was responsible for administration and training of occupational troops. He was awarded the Asiatic-Pacific Theatre Service Medal and the World War II Victory Medal.

After release from the Army, Mr. Frazier resumed the timber and forestry products business that became Fairfield Wood Corporation and subsequently J.B. Frazier and Sons. Also, he was a partner in Frazier-Coleman Motors with franchises in North and South Carolina. He was a member of the Board of Directors of the Bank of Fairfield in Winnsboro and the Board of Directors of Key Life Insurance Company in Columbia, S.C.

Indeed, last month the Clemson Faculty Senate hosted a reception in honor of the 385 members of the Class of '39 to recognize their distinctive contributions. This is the first time the Senate has so recognized an alumni class.

Over the years the Class of '39 has regularly led the way in the percentage of members who attend annual reunions and contribute to the university's annual fund. The class has also established three handsome endowments that total over \$1 million. One honors a deserving faculty member with a \$7,000 award. Another provides four full-tuition scholarships to freshmen each year. And the third supports the Heritage Garden within the South Carolina Botanical Garden.

What explains the unusual bonding of this class? I suspect it has something to do with the two major events that these men (Clemson College was then all male — which explains why so many of them are married to Furman and Winthrop grads) experienced: the Great Depression and the Second World War. As class member Pick Gantt from Gainesville, Georgia, explains, "The fact that the Class of '39 came along during the Depression made us closer. We were the poor boys." They were also the "boys" who wore military uniforms to class and soon after graduation went overseas to fight for their country. They endured experiences that further strengthened the bonds among them and helped instill such a fierce loyalty to alma mater.

We have all sorts of loyalties — to our friends and families, to our churches, cities, athletic teams, region and country. But why are we loyal to a college?

In talking with the 80-year-old members of this distinguished class, I was struck by how

many of them viewed their time at Clemson as the turning point in their lives. Although subjected to a lifetime's weathering, their recollections of shared friendships, classes, professors, military drills, parties and football games are remarkably fresh and precise. Clemson remains a continuing presence in their lives.

To be sure, class members wax nostalgic about bygone days, and, like all of us, they remember some things as they wish they had been. But their mooring to alma mater extends beyond mere sentiment and myth. They return to the campus so often because they find there something very important about themselves. Like so many alumni, they find their strength renewed and their faith revitalized when they attend reunions. Their student days gave them a common identity and a lifetime bond. Clemson endowed them with a sense of place and shared history that is embedded in their consciousness as a memory but protrudes into their present outlook like an exposed piece of granite. At Clemson they were given a chance to surmount the economic distress of their time and broaden their provincial outlook.

The root meaning of the word educate means to lead out, and in this sense Clemson led these students out into a wider, more complicated and even tragic world, all the while providing a comforting tether of support. In this regard, the Class of '39 provides living testimony to what the poet Robert Frost once said: "If you have to fall in love with something, you can do a lot worse than a college." Go Tigers!





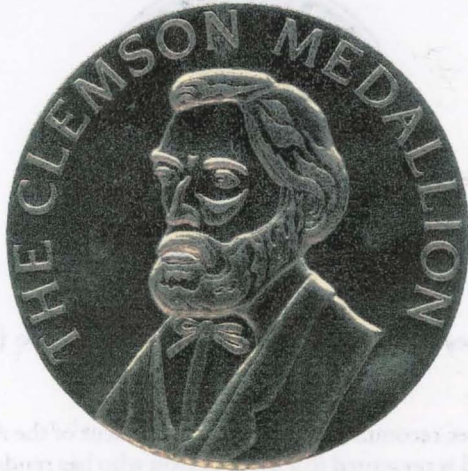

OUR LEGACY TO CLEMSON

The Clemson Heritage Gardens

Approved by the Class at its 1990 reunion, this ambitious project is being developed under the leadership of the Class of 1939 Heritage Gardens Committee (see page 27). The purpose of the Heritage Gardens is to preserve the memory of those people and events that have been key in the evolution of this great university.

The project involves the following elements:

Caboose Garden - sponsored by the Class of 1939; completed 1996.

Grand Entrance - sponsored by the Class of 1939; completed 1997.

Cadet Life Garden - sponsored jointly by the Golden Tigers and the Class of 1942; completed 1999.

Amphitheater - sponsored by a widow of a Class of 1939 member; will be completed in 2004.

First Trellised Walkway - sponsored by '39er Ben McLeod; completed 1998.

Second Trellised Walkway - sponsored by '39er Harry Avinger; completed 1999.

Founders Garden - promised for sponsorship by the Class of 1955; not yet begun.

Presidents Gardens - being considered for sponsorship by the Class of 1964 - but not yet decided.

Picnic Garden - to be sponsored by the Class of 1989; fund raising in progress.

Picnic Pavilion - sponsorship not definite; being considered by a member of the Class of 1942.

Restrooms - to be sponsored jointly by the Classes of 1939 and 1989; available funds at about 70% of need.

OUR LEGACY TO CLEMSON

The Heritage Gardens Maintenance Endowment

This Endowment was originally created in 1989 by the Class of 1939 as part of its fiftieth anniversary gift to the University. As created, it was intended to provide funding for promotion of the Botanical Garden for a ten-year period, after which the income of the fund would be used for maintenance of the Heritage Gardens.

At our reunion in 1997, the Class agreed to renaming the endowment as shown above, in order to encourage other classes to contribute to the fund. However, the purpose of the fund, to provide for maintenance of the Heritage Gardens, remained unchanged.

As of fiscal year 2002-2003, the fund totaled about \$363,000, yielding in 2003 some \$12,000 for maintenance purposes. This includes two companion funds which also provide maintenance monies for named parts of the Heritage Gardens; they are the Harry Avinger fund for his Trellised Walkway, and an endowment for maintenance of the Amphitheater.

The intention of the Class of 1939 Heritage Gardens committee is to bring the level of these funds up to the point where the University will not need to provide any supplementary funding for maintenance. It is a long way from that objective at mid-year 2004.
