#### **Department Highlights**

The department is proud to announce the success of our students in passing the CPA exam on their first attempt. The National Association of State Boards of Accountancy (NASBA) released the 2012 CPA examination passage rates for all universities across the United States, noting that the University of Tennesee, Knoxville's first-time candidates earned the 16th highest passage rate (top 6%) among students attending large universities ("large" defined as a university with 60 or more candidates taking the exam during the year). UT's students landed in the top 5% of all universities, earning the 37th highest passage rate.

To improve the consistency of accounting GPA calculations, the faculty appproved a new policy for students to use in calculating their accounting grade point average.

Under the new policy, undergraduate students will be evaluated based on eight accounting courses. In addition, the Master of Accountancy (MAcc) Admission Committee will use the same eight courses to evaluate candidates for admission to the MAcc program.

the premier accounting journal, Journal of Financial Economics.

### **Dr. Bruce Behn Completes Tenure as Chair of the Pathways Commission**

Dr. Bruce Behn completed his tenure as chair of The Pathways Commission, a joint undertaking of the American Accounting Association (AAA) and the American Institute of Certified Public Accountants (AICPA) to study and recommend improvements in accounting education.

In 2010, the U.S. Treasury Advisory Committee on the Auditing Profession asked the AAA and AICPA to form the commission as a consortium of professionals and academics. After two years of leading the commission. Dr. Behn and his fellow commissioners released short term, as well as in the intermediate and long term.

As part of this transition, Jan Williams, who also is a faculty member in our department, is retiring at the end of February as dean of UT's College of Business Administration. Our faculty recently voted to award him emeritus status in the department upon his retirement.

Jan has served the University of Tennessee since 1977. During this time, he has published many journal articles and books; taught numerous undergraduate and graduate students; was chair of our department; and was an associate dean, acting dean, and dean of the College of Business Administration. He has held significant leadership roles in various national organizations, including president of the American Accounting Association (AAA) and board chair of the Association to Advance Collegiate Schools of Business (AACSB). We congratulate Jan and are grateful for all he has done for this university, the college, our department, and the accounting profession.
