### February 2, 2007 2007 SOCIAL SECURITY CHANGES COST-OF-LIVING ADJUSTMENTS (COLA)

Social Security Income (SSI) beneficiaries will receive a 3.3 percent cost-of-living adjustment for 2007. This increase is based on growth in the Consumer Price Index (CPI-W) from the third quarter of 2005 through the third quarter of 2006.

Additional information below was extracted from the 2006-2007 Social Security Fact Sheet, a press release from the Social Security Administration (SSA).

These tax rates reflect the combined rate for Social Security and Medicare. The 7.65 percent tax rate is composed of the Social Security (OASDI) rate of 6.20 percent and the Medicare rate of 1.45 percent. The Social Security portion is applied on earnings up to the applicable taxable maximum amount listed below. The Medicare portion is applied to all earnings.

There is no limit on earnings beginning the month an individual attains full retirement age (65 and 8 months for retirees born in 1941; 65 and 10 months for those born in 1942).
